MESSAGE FROM THE TRIBUNAL DIRECTOR

This issue reports that our previous Director, Zeynep Onen, left the Tribunal in June 2002 to take on the position of Director of Professional Regulation for the Law Society of Upper Canada. As a colleague of Zeynep's since 1985, I am aware that this is a loss the Tribunal will experience deeply. Since joining the Tribunal, Zeynep has made a number of significant contributions to its processes, jurisprudence, and presence in the administrative justice community through her roles as Senior Legal Counsel, Vice Chair, Alternate Chair, and most recently as Executive Director. In the latter role, she was pivotal in steering the Tribunal through its two-

year inventory reduction project, which concluded successfully in March 2002. During this time, Zeynep worked with Tribunal staff in other significant projects that included the renovation of the Tribunal's premises and the reform of the Tribunal's pre-hearing process. She was also an active contributor to SOAR during this period. My colleagues at the Tribunal join me in thanking Zeynep for her dedication and commitment to public service over the years, and in wishing her good fortune in her new challenge.

NEW TRIBUNAL DIRECTOR APPOINTED

The Tribunal wishes to congratulate **Zeynep Onen**, our former Tribunal Director, on her June 2002 appointment to the position of Director of Professional Regulation with the Law Society of Upper Canada. Ms. Onen joined the Tribunal as senior legal counsel in 1985. She was appointed a Vice-Chair in 1988 and subsequently served as Alternate Chair from 1993-96 and as Executive Director from 1999-2002.

The Tribunal also wishes to announce the appointment of **Marsha Faubert** as Tribunal Director, effective July 1, 2002. Ms. Faubert has been with the Tribunal since its creation in 1985. Working initially as Tribunal counsel, she was appointed a Vice-Chair in 1987. WSIAT Staff and Vice-Chairs Key Participants in Conference

The participation and support of Tribunal staff and Vice-Chairs helped ensure the success of a well-attended workers' compensation conference on April 11, 2002. The conference, entitled "New Developments in the Law and Advocacy Before the WSIAT," was co-sponsored by the Law Society of Upper Canada and the Ontario Bar Association. Tribunal Executive Director Zeynep Onen, General Counsel Dan Revington, and Counsel to the Chair Carole Prest updated the nearly 100 lawyers and laypersons in the audience on developments at WSIAT. In the afternoon, attendees had a unique opportunity to discuss practice, procedure and advocacy in small group workshops led by Tribunal Vice-Chairs Eleanor Smith, Marsha Faubert (now Tribunal Director), Maureen Kenny, John Moore and Linda Gehrke.

There were also lively panel discussions led by experienced worker and employer representatives on the interrelationship of CPP and workers' compensation, Board policies concerning return to work and entitlement following work disruptions, the new stress provisions in the WSIA, and compliance investigations at the Board.

The program was co-chaired by Ann Somerville, Associate Counsel to the Chair at the Tribunal, and Robert Boswell of Hicks Morley Hamilton Stewart Storie. Speakers also provided papers on their topics which can be ordered from the OBA.

New Features Added to WSIAT Web Site

The home page of the Tribunal's web site (www.wsiat.on.ca) now contains two recently added links, which give users access to the following new features:

- 1) **WSIAT Hearing Process and Organizational Chart:** A chart which explains the Tribunal's hearing process and provides details for how to contact staff responsible for the various stages of the appeals and hearing processes.
- 2) **Forms:** A link providing web users with direct access to all WSIAT forms currently available online in both Word and pdf format. These include forms for Notice of Appeal, Confirmation of Appeal, Respondent's Confirmation of Appeal, Request for Reconsideration / Clarification and the 2002 Order Form among others.

Decision Summary Search

Within the Decision Summary Search function, the following new features have been added:

- **Currency of Data:** A note which informs users about the currency of the data contained in the decision summary database has been added.
- **Summarized Decisions Only Filter:** this filter allows users to restrict searches to decisions with summaries in the Summary field.
- **Search Last Results Filter:** This filter allows users to narrow their searches. After a user has completed at least one search, a check box will appear on the Decision Summary Search screen. When this box is checked and additional search criteria have been specified, the search engine will search only within the results of the last search entered instead of searching the whole database. This option can be used for searches on any field.
- **Panel Members:** It is now possible to search for decisions according to the first and/or last name of a panel member. (Previously, the search engine only recognized panel members' surnames).

DAN REVINGTON RECEIVES 2002 RON ELLIS AWARD

Daniel S. Revington, General Counsel at the Workplace Safety and Insurance Appeals Tribunal, is this year's winner of the Ron Ellis Award. The award, which is jointly sponsored by LexisNexis™ Butterworths Publishing and the Ontario Bar Association, recognizes exceptional contributions to the field of workers' compensation. Mr. Revington joins previous distinguished winners Dr. Robert Elgie, Gary Newhouse, Alec Farquhar and David Brady.

After graduating from the University of Western Ontario Law School, Mr. Revington worked in private practice where he received his first exposure to workers' compensation. He was manager at the Office of the Employer Adviser, representing employers in many of the leading cases at the Tribunal, including *Decision No. 72*. He became Senior Counsel in the WSIAT Tribunal Counsel Office in 1991, and was appointed General Counsel to the Tribunal in 2000. Dan is a founder and past president of the Ontario Bar Association's Workers' Compensation Section. He played a leading role in persuading the CBAO to admit non-lawyers as section members. He was a charter member of the LSUC workers' compensation specialty committee, and has been heavily involved with CLE at the LSUC.
