WSIAT Recognized with 2003 Public Sector Quality Fair Award

The Workplace Safety and Insurance Appeals Tribunal is the recipient of a 2003 Public Sector Quality Fair (PSQF) award for its use of quality management principles and practices. The Tribunal has received a bronze award for its quality initiative, "A New WSIAT Appeal Application Process," a two-staged appeal application process, first introduced in 2001, that improved customer service by increasing appeal process efficiency and significantly reducing the wait time to hearings.

The Tribunal's quality initiative was evaluated against the National Quality Institute's "Canadian Quality Criteria for Public Sector Excellence," earning it the opportunity to be an exhibitor at this year's fair, held in Toronto on October 30, 2003.

WSIAT STAFF ACTIVITIES

Tribunal staff and OICs regularly participate in conferences and training sessions. The information that follows summarizes the participation which occurred over the past few months.

Daniel Revington, General Counsel, participated in a Panel discussion at the Lancaster House Workers' Compensation Conference in early October. The Panel topic was Adjudicating Occupational Disease Claims.

The Vice-Chair Registrar, Martha Keil, continued her work with the SOAR adjudicator training program by presenting a seminar on decision writing. The Vice-Chair Registrar also spoke to the London Regional Advocates Group at the request of the Office of the Worker Adviser. The topics of discussion included written cases and advice about representing clients before the Tribunal.

At the COBA Conference, 2003, the late Nick McCombie (1949-2003) was honoured with a SOAR Medal for his contributions to workplace safety and insurance. Nick was a Tribunal member

Medical Discussion Papers

DECISION SUMMARY SEARCH TIP

Searching by Act

Cases regarding accidents occurring before January 1, 1998, are decided under provisions of the *Workers' Compensation Act* (WCA). Cases regarding accidents occurring after January 1, 1998, are decided under provisions of the *Workplace Safety and Insurance Act* (WSIA).

When searching the Decision Summary database, you may want to limit your results to cases decided under the *Workers' Compensation Act* or the *Workplace Safety and Insurance Act*. To limit your search in this manner:

- click on the drop-down box (in which "References" is listed as the default)
- select "Section of the Act"
- enter WCA or WSIA in the accompanying search field.

This should be done in conjunction with a search of another field, such as the Keyword field or the Summary field.

- The Selection of Appeals for a Written Process

This item discusses in greater detail the type of appeals eligible for a written hearing process. It also provides a link to the introductory section of the NEL Quantum Appeals casebook, a document prepared by the Tribunal's Office of the Vice-Chair Registrar to assist parties in preparing submissions. This document can also be found in the Resource Materials section of the web site.

DECISION NUMBER CITATION AND SEARCH

Since the Tribunal Web Site's Decision Summary Search Service was launched, there has been some confusion about how to cite tribunal decisions and how to search for these decisions using the web site search service. This article aims to clarify the difference between citing a decision and searching for a decision on the web site in order to dispel this confusion.

The name of a Tribunal case is the Decision Number. A Decision Number is composed of three elements: the Root Number, the Year Mark and, if appropriate, a Suffix.

The actual Decision Number has a slash between the Root Number and the Year Mark, and no spaces between the elements. **When citing Tribunal decisions, please use the actual Decision Number.** An example of an actual decision number is *Decision No. 123/03R*.

For technical reasons, the Decision Summary Search service displays the Decision Number with spaces between the various elements. Due to this, it becomes necessary, **when searching for a Tribunal decision in the Decision Number field, to enter the Decision Number with spaces between the root number, year mark and the suffix, if any.** For example, although the actual Decision Number is 123/03R, when searching, enter 123 03 R. **When searching for a Tribunal decision in the References field, use the actual number (slash and no spaces).**
