Agreements Settled in December

In December, 27 collective agreements were ratified, each covering 150 or more employees. These agreements covered 26,390 employees, 63% of whom were in the private sector (16,742).

The overall average annual increase in base wage rates in December was 1.8%, compared to 1.9% reported in the previous month. In the public sector, 20 agreements were settled for an average annual wage increase of 1.8%, an increase from 1.7% in November. In the private sector, seven agreements were settled for an average annual wage increase of 1.8%, a decrease from 2.1% reported in the previous month.

For settlements in the month of December, the industry with the highest average annual increase was in transportation, communications and utilities. The lowest average annual wage increase was in trade and finance. The average annual wage increase in transportation, communications and utilities for one settlement was 3.2%, while in public administration (six settlements), and other services (two settlements), the average annual wage increases were 2.2%. Health and social services reported an average annual wage increase of 1.5% for 13 settlements. Trade and finance reported an average annual wage increase of 1.3% for two settlements.

Selected Settlement Summaries

(Key monetary items based on available information)

Municipal Property Assessment Corporation and Ontario Public Service Employees Union (1,255 employees)

a four-year renewal agreement, effective January 1, 2012, expiring December 31, 2015

- wage increases of 2% in the first two years and 2.2% in each of the third and fourth years
- improvements to life insurance coverage, vision and hearing care plans

Windsor Regional Hospital and National Automobile, Aerospace, Transportation and General Workers' Union of Canada (CAW-Canada), Local 2458 (455 employees)

a two-year arbitrated renewal agreement, effective April 1, 2010 to March 31, 2012

- general wage increase of 2% in each year
- improvements to vision care, dental plan, and orthodontic coverage as well as shift premiums

No Frills Franchise Stores and United Food and Commercial Workers, Local 1000A (10,990 employees)

a five-year renewal agreement, effective July 1, 2011, expiring June 30, 2016

- wage increases of \$0.35 for full-time employees and \$0.30 for part-time employees applicable to end rates on ratification date, and in each of the third and fifth years; lump sum payment in the second and fourth years
- annual orthotic coverage of \$350 for full-time employees
- increased night shift premium

Champlain Community Care Access Centre and Ontario Public Service Employees Union (400 employees)

Part of a jointly bargained Memorandum of Settlement for four Community Care Access Centres, covering four 36-month renewal agreements for 892 employees, effective on various dates in 2011 (for Champlain, effective date is on January 1, 2012), expiring on various dates in 2014

- lump sum payment in the first two years, and general wage increase of 2.75% in the third year for all classifications in Hamilton Niagara Haldimand Brant, Central East and Champlain, and 4% for North East
- increased shift and weekend premiums

Fourth Quarter 2011 Summary

During the fourth quarter of 2011, 107 collective agreements were ratified, each covering 150 or more Ontario-based employees. These agreements covered 79,113 employees, 54% of whom were in the public sector. By industry, the majority of employees were in health and social services (18,728), management services (15,500), and education and related services (13,262) (Table 10).

Wage Adjustments

Fourth quarter settlements (Table 7) provided an overall average annual wage increase of 1.8%, an increase from 1.6% reported in the previous quarter. In the public sector, the average annual wage increase was 1.7%, up from 1.6% in the previous quarter. The private sector reported an average annual wage increase of 2% compared to 1.6% in the third quarter. During the fourth quarter of 2011, average annual wage increases (Table 10) were affected by settlements in management services (2.7%), education and related services (1.7%), health and social services (1.3%), and retail trade (1.3%).

In the fourth quarter of 2011, approximately 48% (37,945) of all employees received average annual wage increases ranging from 1% to 1.9%, compared to 33% (26,033) who received average annual wage increases ranging from 2% to 2.9%. In the public sector, 60% (25,403) of employees were covered by agreements with average annual wage increases ranging from 1% to 1.9%, compared to 34% (12,542) of private sector employees. In the private sector, 49% (17,971) of employees received average annual wage increases ranging from 2% to 2.9%.

Of the total number of employees for whom agreements were reached during the fourth quarter of 2011, 48% (37,596) were covered by three-year agreements. Approximately 55% (23,399) of public sector employees and 39% (14,197) of private sector employees were covered by three-year agreements. In the manufacturing sector, approximately 72% (2,016) of employees were covered by three-year agreements, compared to 47% (35,580) of non-manufacturing employees (Table 13 and 14).

Negotiations

On average, private sector agreements were ratified within 5.8 months from the start of negotiations, compared to 8.3 months in the public sector (Table 16).

Of all settlements reached during the fourth quarter of 2011, 16 agreements covering 11% (8,982) of employees were negotiated directly by the parties, compared to 65 agreements, covering 64% (50,686) of employees, reached with the assistance of conciliation or mediation. Twenty-three (23) agreements, covering 9% (6,986) of employees were settled by arbitration, and three (3) agreements were reached following work stoppages (Table 17).

In the public sector, approximately 46% (19,524) of employees reached settlements with the assistance of conciliation or mediation, while 19% (7,918) were settled by direct bargaining. In the private sector, 85% (31,162) of employees reached agreements with the assistance of conciliation or mediation, compared to 3% (1,064) who settled by direct bargaining.

Upcoming Bargaining

Major negotiations continuing into the first quarter of 2012 include the federal government, municipalities, police services boards, hospitals, nursing homes and homes for the aged, universities, Air Canada, Canada Post, Metro Ontario, and Toronto Transit Commission.

Major agreements scheduled to expire during the first quarter of 2012 include hospitals, nursing homes and homes for the aged, Ontario Power Generation, Metro Ontario (Food Basics), No Frills Franchise Stores, City of Ottawa (transit), and Ontario Government (AMPCEO).

Work Stoppages

During 2011, 40 work stoppages under Ontario jurisdiction were reported, compared to 56 reported in 2010. Work stoppages in 2011 involved 11,502 employees and resulted in 352,160 person-days lost, compared to 10,711 employees and 704,630 person-days lost reported in 2010 (Table 18 and 19).

In 2011, 21 work stoppages were reported in the manufacturing sector, a decrease from 23 reported in 2010. The non-manufacturing sector reported 19 work stoppages compared to 32 reported during 2010. During 2011, 0.02% of the estimated working time in Ontario was lost due to work stoppages (Table 19-20).
