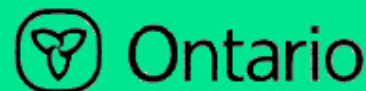

Physicians are reminded of the due date to forward their application for Reimbursement of Malpractice Fees to the Ministry of Health and Long-Term Care no later than June 30, 2000.

You must return the completed application and your 1999 Canadian Medical Protective Association (CMPA) Acknowledgement to the Ministry of Health and Long-Term Care. If covered by an insurer other than the CMPA, a receipt demonstrating proof of payment for the year 1999 must be enclosed. Please send your application to:
