Subject **Malpractice Premium Reimbursement Business Resumption**

The ministry has now resumed the processing of malpractice reimbursement payments. Following is information regarding the processing and payment of the three (3) reimbursement options available.

Option A – Early Annual Reimbursement for the 2002 Coverage Year

- The CMPA has agreed to delay cashing the May 1, 2002 post-dated cheques until the ministry confirms payment into the physician's account has been made.
- The malpractice reimbursement payment for physicians in Option A will be made on June 18, 2002.

Option B – Quarterly Reimbursement for 2002 Coverage Year

- The first 2002 quarterly reimbursement payment for physicians in Option B will be made in June 2002.
 - The second quarterly reimbursement will be processed and paid on schedule in July 2002.

Option C – Regular Annual Reimbursement for 2001 Coverage Year

- Every effort will be made to process all applications within the normal processing timeframe of 6 to 8 weeks.
- The deadline for receipt of applications for the 2001 premium year has been extended to August 30, 2002.
