Subject: Changes to Payment Thresholds for Ontario Physicians

Based on recommendations made by the Physician Services Committee, the following items are being implemented to the physician payment threshold system for services effective fiscal year 2002/03:

New Threshold Payment System

The introduction of a new threshold payment system that eliminates the first and third threshold levels of the current three level system, combines separate GP and Specialist threshold classifications into one threshold classification level for all physicians, and provides additional exemptions from threshold reductions for hospital-based services and critical care services.

The new singular threshold payment reduction amount is 66.7% and occurs for all professional fee-for-service billings over \$455,000.

Additional Exclusions to Thresholds

Acute care "C" prefix hospital in-patient services including the listings for consultations, assessments and visits rendered to registered bed patients for services billed with a "C" prefix are excluded from the threshold.

The following critical care codes are also exempted from the threshold:

Effective Date

These changes are effective for fiscal year 2002/03. The new threshold payment system will be applied automatically to all claims submissions for services provided between April 1, 2002 to March 31, 2003 as early as April Remittance Advice.

SRI Program

The ministry is in the process of reviewing SRI Program applications and will communicate with all applicants regarding the impact of these changes.
