WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 49. Falls prevention and management

Specifically failed to comply with the following subsections:

s. 49. (2) Every licensee of a long-term care home shall ensure that when a resident has fallen, the resident is assessed and that where the condition or circumstances of the resident require, a post-fall assessment is conducted using a clinically appropriate assessment instrument that is specifically designed for falls. O. Reg. 79/10, s. 49 (2).

Findings/Faits saillants :

1. On July 29, 2011 the MOHLTC received notification through the critical incident reporting system that a resident had fallen and sustained an injury which required transfer to hospital.

On October 19, 2011, the Inspector reviewed the resident's health care record and noted that the resident was assessed in hospital and returned to the home with a tentative diagnosis of a fractured humerus. The Inspector was unable to locate a post falls assessment on the resident's health care record.

On October 19, 2011, the Inspector requested the assistance of the DOC and the Administrator in locating the resident's post falls assessment. After consulting with the Education Coordinator, the Administrator reported that a post falls assessment utilizing a clinically appropriate assessment tool specifically designed for falls had not been completed for the resident because the assessment tool had not yet been implemented at the time of the resident's fall on July 28, 2011.

The licensee failed to ensure that when a resident has fallen, the resident is assessed and that where the condition or circumstances of the resident require, a post-fall assessment is conducted using a clinically appropriate assessment instrument that is specifically designed for falls.
