The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): February 07, 2013.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care; the Environmental Services Supervisor; several registered and non registered nursing staff; several residents and visitors.

During the course of the inspection, the inspector(s) toured the A, B, and C wings. Checked the operation of the mechanical air make up and exhaust ventilation system; checked the availability of hand hygiene product at point of care locations; checked an audio visual enunciator panel for the door alarms in the A wing; followed up on a compliance order which was determined to have been complied with; reviewed posted minutes for a recent Residents' Council meeting.
