Inspection Summary/Résumé de l'inspection



The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): January 10, 2013

This visit was conducted to determine compliance with Orders #001 and #003, served on October 10, 2012 related to bed safety and infection prevention and control. Order #001 has been cleared and Order #003 remains outstanding and non-compliant for staff tuberculosis screening requirements. The details are listed below.

During the course of the inspection, the inspector(s) spoke with the Administrator and Assistant Director of Care.

During the course of the inspection, the inspector(s) toured the home and specifically selected resident rooms to observe the condition of the beds, reviewed resident plan of care records, bed safety audit reports, resident and staff tuberculosis screening records and management staff attendance records for participation in a course related to infection prevention and control.

At the time of the inspection, documentation was not available that identified the tuberculosis status for all staff in the home. The administrator provided documentation that tuberculosis testing clinics were set up for initial screening on January 14 and 21, 2013 and that all staff would receive their step 2 screening by February 4, 2013. However, by February 5, 2013, 30 staff had not yet been screened. The home was originally ordered to submit a compliance plan by October 31, 2012 to identify their staff tuberculosis testing strategy. The plan was accepted by a Long Term Care Homes Inspector and it described that all staff would be screened by December 31, 2012. [s. 229. (10) 4.]

1. Each resident admitted to the home must be screened for tuberculosis within 14 days of admission unless the resident has already been screened at some time in the 90 days prior to admission and the documented results of this screening are available to the licensee.
 2. Residents must be offered immunization against influenza at the appropriate time each year.
 3. Residents must be offered immunizations against pneumococcus, tetanus and diphtheria in accordance with the publicly funded immunization schedules posted on the Ministry website.
 4. Staff is screened for tuberculosis and other infectious diseases in accordance with evidence-based practices and, if there are none, in accordance with prevailing practices.
 5. There must be a staff immunization program in accordance with evidence-based practices and, if there are none, in accordance with prevailing practices.
