Findings/Faits saillants :

1. Log# O-002245-12

The licensee failed to ensure that the care set out in the plan of care was provided to the resident as specified in the plan.

Clinical documentation in resident #1 plan of care directs that the resident was designated a 2 person transfer. The resident was transferred with the assistance of one person. The resident expressed severe pain and was subsequently was transferred to the hospital for further assessment. [s. 6. (7)]
