Every licensee of a long-term care home shall ensure that the following persons may not be members of the Family Council: an officer, director of the licensee or of a corporation that manages the home on behalf of the licensee or, in the case of a home approved under Part VIII, a member of the committee of management for the home under section 132 or of the board of management for the home under section 125 or 129, as the case may be.

Findings:

1. The Executive Director of the home confirmed that a member of the Board of Directors is a member of Family Council.
2. Upon notification of the conflict, the member of Family Council resigned from the Board of Directors.
