Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Le non-respect des exigences de la Loi de 2007 sur les foyers de soins de longue durée (LFSLD) a été constaté. (Une exigence de la loi comprend les exigences qui font partie des éléments énumérés dans la définition de « exigence prévue par la présente loi », au paragraphe 2(1) de la LFSLD.

Ce qui suit constitue un avis écrit de non-respect aux termes du paragraphe 1 de l'article 152 de la LFSLD.

**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care
Specifically failed to comply with the following subsections:**

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

1. An identified resident's current plan of care indicates that the resident requires two person/total dependence and mechanical lift for transfer.

The Personal Support Workers daily flow sheets indicates that the resident requires 2 staff assist.

A personal support worker did not ensure that the care set out for the resident was provided as specified in the plan of care, when the staff did not obtain two staff assist for transferring resident on a mechanical lift, which resulted in an injury

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 36. Every licensee of a long-term care home shall ensure that staff use safe transferring and positioning devices or techniques when assisting residents. O. Reg. 79/10, s. 36.

Findings/Faits saillants :

1. The current care plan and the personal support worker daily flow sheets, indicate that an identified resident requires mechanical lift for all transfers with two staff assist.

It was determined during the home's internal investigation of the incident that, the identified resident was transferred by staff, on a mechanical lift without two staff assistance.

As a result of the improper transfer the resident sustained an injury.
