Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Follow up inspection.

During the course of the inspection, the inspector(s) spoke with the Director of Care and the Environmental Services Supervisor regarding the resident-staff communication and response system (H-000542-12).

Evidence of non-compliance regarding the resident-staff communication and response system was identified by inspectors between July 8 and August 5, 2011 and Order #008 was issued on inspection report #2011-071159-0012. On December 20, 2011, a follow-up inspection was conducted to determine compliance with the Order. Evidence of non-compliance remained and 2 new Orders #001 and #002 were issued on inspection report #2011-072120-0051. This follow-up inspection revealed that the Orders are now in compliance(see page 2 for corrected non-compliance).

During the course of the inspection, the inspector(s) toured each resident room on all floors and tested the resident-staff communication and response system.
