(i) receives a skin assessment by a member of the registered nursing staff, using a clinically appropriate assessment instrument that is specifically designed for skin and wound assessment,

Findings:

1. A resident did not receive a skin assessment using a clinically appropriate assessment instrument that is specifically designed for skin and wound assessment.

WN #2: The Licensee has failed to comply with O.Reg 79/10 s. 50(2)(b)(iii)

Every licensee of a long-term care home shall ensure that,

(b) a resident exhibiting altered skin integrity, including skin breakdown, pressure ulcers, skin tears or wounds,

(iii) is assessed by a registered dietitian who is a member of the staff of the home, and any changes made to the resident's plan of care relating to nutrition and hydration are implemented, and

Findings:

1. A resident who exhibited infected skin tears to the right arm was not assessed by the registered dietitian.

The licensee shall ensure that the staff and others involved in the different aspects of care of the resident collaborate with each other,
