Findings:

1) On September 28, 2010, the home's Administrator confirmed to Inspectors the name of Labdara's Medical Director. The Administrator confirmed that the same individual also serves on Labdara Foundation's Board of Directors.

2) During an interview on the morning of Sept. 29, 2010, the Administrator informed inspectors that the Medical Director had resigned from the Board of Directors on Sept. 29, 2010.
