The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): November 22, 23, 26 & 27, 2012

Five Critical Incident inspections were completed during this inspection: Log #002630-11, #002846-11, #002911-11, #000068-12 and #000798-12

During the course of the inspection, the inspector(s) spoke with Administrator, Director of Care(DOC), Registered Nurse(RN), Registered Practical Nurse (RPN), Physician, RAI Co ordinator, Resident Care Co ordinators (RCC) and four residents.

During the course of the inspection, the inspector(s) Reviewed identified resident's clinical health records, licensee's investigation reports, relevant policies, Quality Improvement documentation related to falls and abuse, educational records, and five Critical Incident reports.

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 53. Responsive behaviours

Specifically failed to comply with the following:

s. 53. (4) The licensee shall ensure that, for each resident demonstrating responsive behaviours,

(a) the behavioural triggers for the resident are identified, where possible; O. Reg. 79/10, s. 53 (4).

(b) strategies are developed and implemented to respond to these behaviours, where possible; and O. Reg. 79/10, s. 53 (4).

(c) actions are taken to respond to the needs of the resident, including assessments, reassessments and interventions and that the resident's responses to interventions are documented. O. Reg. 79/10, s. 53 (4).

1. The licensee failed to comply with O.Reg. 79/10 s.53(4)(a) when triggers for resident #005 were not identified on the written plan of care for responsive behaviour.

A mental health assessment was completed for resident #005 outlining behaviours and possible triggers.

Documentation in the Critical Incident and the resident's progress notes confirm that an incident occurred between resident #004 and resident #005, resulting in an injury to resident #004.

The plan of care for resident #005 does not identify triggers or interventions to manage the aggressive behaviour.[s. 53. (4) (a)]
