The purpose of this inspection was to conduct a Complaint inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), one Registered Practical Nurse (RPN), and three Personal Support Workers (PSW) and four residents.

During the course of the inspection, the inspector(s) observation of dining service, observation of several rooms on four different floors, reviewed the health record of a deceased resident and reviewed the homes policies.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care
Specifically failed to comply with the following subsections:

s. 6. (10) The licensee shall ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time when,
(a) a goal in the plan is met;
(b) the resident's care needs change or care set out in the plan is no longer necessary; or
(c) care set out in the plan has not been effective. 2007, c. 8, s. 6 (10).

Findings/Faits saillants :

1. An identified deceased resident who was at risk for falls and alteration in tissue perfusion did not have their plan of care revised when their care needs changed.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that when all residents are reassessed, the plan of care is revised as the residents care needs change, to be implemented voluntarily.
