WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care
Specifically failed to comply with the following subsections:

s. 6. (10) The licensee shall ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time when,
(a) a goal in the plan is met;
(b) the resident's care needs change or care set out in the plan is no longer necessary; or
(c) care set out in the plan has not been effective. 2007, c. 8, s. 6 (10).

Findings/Faits saillants :

1. The plan of care for continence and toileting has not been revised to reflect the change in care needs for a resident. According to the Personal Support Worker, an identified requires total assistance by staff for all aspects of toileting. The resident is also incontinent of bladder functions and wears an incontinent product at all times. The plan of care states that the resident is continent and has complete control of his/her bladder and staff are to remind him/her to clean them self and to wash his/her hands after toileting. The plan of care was reviewed and signed on March 13, 2012 by a registered nursing staff member.
