The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): August 29, September 5, 10, 11, 12, 2013

This follow-up inspection was conducted concurrently with 2 Critical Incident inspections H-000189-13, H-000547-13 and 3 complaint inspections H-000442-13, H000216-13 and H-000323-13.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Associate Director of Care (ADOC), registered staff, Personal Support Workers (PSW's), physiotherapy staff, hairdressers, dietary staff, residents and family members.

During the course of the inspection, the inspector(s) reviewed the home's audits of transfer assessments and plans of care, residents' health records, policy and procedures related to prevention of abuse and sign-up sheets for prevention of abuse training.

The licensee, who had reasonable grounds to suspect that the following occurred, did not report the incident and the information upon which it was based to the Director: Improper or incompetent treatment or care of a resident that resulted in harm or risk of harm; and, abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or a risk of harm to the resident.

(a) Resident #002 sustained injury in August 2013 during a transfer procedure. The home's internal investigation identified that the workers failed to give proper care. The home did not report the improper care to the Director until advised to do so several weeks later during a complaint inspection.

(b) In August 2013, staff witnessed another staff verbally and/or emotionally abusing a resident. The report was not immediately sent to the Director. The report was sent 6 days later. This information was confirmed by the DOC and ADOC. [s. 24. (1)]

The licensee did not ensure that all staff who provide direct care to residents receive the training provided for in subsection 76(7) of the Act based on the following: 1. Subject to paragraph 2, the staff must receive annual training in all the areas required under subsection 76(7) of the Act.

Abuse recognition and prevention training has not been provided to all employees who provide direct care to residents annually:

2 out of 2 hairdressing staff interviewed stated they have not ever had abuse recognition and prevention training;

3 nursing staff and 1 dietary staff on duty on a date in August 2013 stated they had not had the training within the past year or two.

This information was confirmed by the administrator who stated that between 60 and 70 employees had not had the training in the past year. [s. 221. (2) 1.]
