WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 134. Residents' drug regimes

Every licensee of a long-term care home shall ensure that,

- (a) when a resident is taking any drug or combination of drugs, including psychotropic drugs, there is monitoring and documentation of the resident's response and the effectiveness of the drugs appropriate to the risk level of the drugs;
- (b) appropriate actions are taken in response to any medication incident involving a resident and any adverse drug reaction to a drug or combination of drugs, including psychotropic drugs; and
- (c) there is, at least quarterly, a documented reassessment of each resident's drug regime. O. Reg. 79/10, s. 134.

Findings/Faits saillants :

1. A specified resident was demonstrating an exacerbation in responsive behaviours and was assessed by the community Pieces Resource Consultant (PRC). Recommendations were made related to the use of analgesic to manage pain that may have been a contributing factor in the resident's behaviours. The analgesic was ordered by the physician and a referral for pain control assessment by the Palliative Coordinator was order. No pain assessment was completed by the home and the effectiveness of the analgesic has not been assessed as of September 8, 2011. Interview with the Assistant Director Of Care (ADOC) confirms that any pain assessment completed would have been done in Point Click Care. There is no evidence of a Pain Assessment in Point Click Care as of September 8, 2011.

A specified resident has had frequent changes in medication related to exacerbation in responsive behaviours including changes from consulting specialists. The documentation in the medical record relates to the specific behaviours exhibited but does not include an evaluation of the effectiveness of any of the changes in medication ordered. Interview with the Assistant Director of Care indicated that evaluation of medications ordered would be found in the progress notes.

WN #2: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 3. Residents' Bill of Rights

Specifically failed to comply with the following subsections:

s. 3. (1) Every licensee of a long-term care home shall ensure that the following rights of residents are fully respected and promoted:

1. Every resident has the right to be treated with courtesy and respect and in a way that fully recognizes the resident's individuality and respects the resident's dignity.

2. Every resident has the right to be protected from abuse.

3. Every resident has the right not to be neglected by the licensee or staff.

4. Every resident has the right to be properly sheltered, fed, clothed, groomed and cared for in a manner consistent with his or her needs.

5. Every resident has the right to live in a safe and clean environment.

6. Every resident has the right to exercise the rights of a citizen.

7. Every resident has the right to be told who is responsible for and who is providing the resident's direct care.

8. Every resident has the right to be afforded privacy in treatment and in caring for his or her personal needs.

9. Every resident has the right to have his or her participation in decision-making respected.

10. Every resident has the right to keep and display personal possessions, pictures and furnishings in his or her room subject to safety requirements and the rights of other residents.

11. Every resident has the right to,

i. participate fully in the development, implementation, review and revision of his or her plan of care,

ii. give or refuse consent to any treatment, care or services for which his or her consent is required by law and to be informed of the consequences of giving or refusing consent,

iii. participate fully in making any decision concerning any aspect of his or her care, including any decision concerning his or her admission, discharge or transfer to or from a long-term care home or a secure unit and to obtain an independent opinion with regard to any of those matters, and

iv. have his or her personal health information within the meaning of the Personal Health Information Protection Act, 2004 kept confidential in accordance with that Act, and to have access to his or her records of personal health information, including his or her plan of care, in accordance with that Act.

12. Every resident has the right to receive care and assistance towards independence based on a restorative care philosophy to maximize independence to the greatest extent possible.

13. Every resident has the right not to be restrained, except in the limited circumstances provided for under this Act and subject to the requirements provided for under this Act.

14. Every resident has the right to communicate in confidence, receive visitors of his or her choice and consult in private with any person without interference.

15. Every resident who is dying or who is very ill has the right to have family and friends present 24 hours per day.

16. Every resident has the right to designate a person to receive information concerning any transfer or any hospitalization of the resident and to have that person receive that information immediately.

17. Every resident has the right to raise concerns or recommend changes in policies and services on behalf of himself or herself or others to the following persons and organizations without interference and without fear of coercion, discrimination or reprisal, whether directed at the resident or anyone else,

i. the Residents' Council,

ii. the Family Council,

iii. the licensee, and, if the licensee is a corporation, the directors and officers of the corporation, and, in the case of a home approved under Part VIII, a member of the committee of management for the home under section 132 or of the board of management for the home under section 125 or 129,

iv. staff members,

v. government officials,

vi. any other person inside or outside the long-term care home.

18. Every resident has the right to form friendships and relationships and to participate in the life of the long-term care home.

19. Every resident has the right to have his or her lifestyle and choices respected.

20. Every resident has the right to participate in the Residents' Council.

21. Every resident has the right to meet privately with his or her spouse or another person in a room that assures privacy.

22. Every resident has the right to share a room with another resident according to their mutual wishes, if appropriate accommodation is available.

23. Every resident has the right to pursue social, cultural, religious, spiritual and other interests, to develop his or her potential and to be given reasonable assistance by the licensee to pursue these interests and to develop his or her potential.

24. Every resident has the right to be informed in writing of any law, rule or policy affecting services provided to the resident and of the procedures for initiating complaints.

25. Every resident has the right to manage his or her own financial affairs unless the resident lacks the legal capacity to do so.

26. Every resident has the right to be given access to protected outdoor areas in order to enjoy outdoor activity unless the physical setting makes this impossible.

27. Every resident has the right to have any friend, family member, or other person of importance to the resident attend any meeting with the licensee or the staff of the home. 2007, c. 8, s. 3 (1).

Findings/Faits saillants :

1. The home did not protect residents from abuse. A specified resident frequently approached female residents in a sexual manner. Documentation indicates that there are verbal, physical and sexually abusive behaviours on a daily basis. Over three months in 2011 there were 17 documented episodes of sexual behaviour directed at female staff and residents. The resident was found in bed with a female resident who was visibly upset and crying. The home failed to protect residents from abuse.

Additional Required Actions:

CO # - 002 will be served on the licensee. Refer to the "Order(s) of the Inspector".

WN #3: The Licensee has failed to comply with O.Reg 79/10, s. 8. Policies, etc., to be followed, and records
Specifically failed to comply with the following subsections:

s. 8. (1) Where the Act or this Regulation requires the licensee of a long-term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the licensee is required to ensure that the plan, policy, protocol, procedure, strategy or system,

(a) is in compliance with and is implemented in accordance with applicable requirements under the Act; and
(b) is complied with. O. Reg. 79/10, s. 8 (1).

Findings/Faits saillants :

1. The Risk Management Policy/Resident Non-Abuse (LP-B-20) indicates that disclosure of alleged abuse will be made to the Resident/client's family member or Substitute Decision Maker (SDM) as soon as possible after the incident. A specified resident demonstrated inappropriate behaviours toward another specified resident. There is no record of the specified resident's family being notified of these incidents. Interview with the evening Registered Practical Nurse indicated that there was a brief interaction with the family of the specified resident related to incidents involving another specified resident. The discussion was not documented. There is no record of the resident's family being notified of the specific incident.

2. The homes policy Pain Assessment and Symptom Management - Implementation (LTC-N-50) dated August 2010 indicates that each resident will be assessed by the registered staff upon admission, quarterly, annually and with any identified alteration of the resident's pain processes. A specified resident was identified during assessment by the Pieces Resource Consultant (PRC) to be experiencing pain that may be contributing to responsive behaviours exhibited. The regular use of analgesic was recommended by the PRC and the physician ordered analgesic to be given. No pain assessment was completed for the resident.

The Pain Assessment and Symptom Management - Implementation policy indicates that the effectiveness of interventions will be evaluated using the Pain Monitoring Sheet. Analgesic for the specified resident was ordered, the Pain Monitoring Sheet was initiated but was not consistently completed by staff administering analgesic between August and September 2011.

The Pain Assessment and Symptom Management - Implementation policy indicates that residents who are currently experiencing chronic pain will have the type of pain and contributing factors identified so that appropriate interventions and treatment may be considered and implemented. A specified resident was admitted with diagnosis that may result in chronic pain. No pain assessments were completed for the resident.

The Pain Assessment and Symptom Management - Implementation policy indicates that a Pain Flow Sheet will be initiated when new regular pain medication is ordered. Regular analgesic was ordered for the specified resident. The Pain Monitoring Flow Sheet was not initiated until September 2011 and was not consistently completed by staff administering a new regular analgesic.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance by ensuring that where the Act or Regulation requires the licensee of a long-term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the licensee is required to ensure that the plan, policy, protocol, procedure strategy or system is complied with, to be implemented voluntarily.

WN #4: The Licensee has failed to comply with O.Reg 79/10, s. 26. Plan of care

Specifically failed to comply with the following subsections:

s. 26. (3) A plan of care must be based on, at a minimum, interdisciplinary assessment of the following with respect to the resident:

1. Customary routines.
2. Cognition ability.
3. Communication abilities, including hearing and language.
4. Vision.
5. Mood and behaviour patterns, including wandering, any identified responsive behaviours, any potential behavioural triggers and variations in resident functioning at different times of the day.
6. Psychological well-being.
7. Physical functioning, and the type and level of assistance that is required relating to activities of daily living, including hygiene and grooming.
8. Continence, including bladder and bowel elimination.
9. Disease diagnosis.
10. Health conditions, including allergies, pain, risk of falls and other special needs.
11. Seasonal risk relating to hot weather.
12. Dental and oral status, including oral hygiene.
13. Nutritional status, including height, weight and any risks relating to nutrition care.
14. Hydration status and any risks relating to hydration.
15. Skin condition, including altered skin integrity and foot conditions.
16. Activity patterns and pursuits.
17. Drugs and treatments.
18. Special treatments and interventions.
19. Safety risks.
20. Nausea and vomiting.
21. Sleep patterns and preferences.
22. Cultural, spiritual and religious preferences and age-related needs and preferences.
23. Potential for discharge. O. Reg. 79/10, s. 26 (3).

Findings/Faits saillants :

1. A specified resident has diagnosis that could contribute to her pain. Her substitute decision maker identified that the resident was experiencing pain. The specified resident was seen by the physician and analgesic was ordered for complaints of pain. No pain assessment was completed since admission in 2011, at which time the resident was identified to be pain free. The plan of care does not include interventions to manage the resident's pain.
2. A specified resident was not assessed with respect to specified health conditions that may cause pain for the resident. There is no pain assessment available in the medical record. Interview with the ADOC indicates that the resident was recently started on analgesic at the suggestion of the Pieces Resources Consultant and that staff did not feel the resident was experiencing pain. Pain assessments are to be included in electronic documentation on Point Click Care. The plan of care indicates under transferring, mobility and dressing that the specified resident may have pain and complaints of pain should be documented. Also in the plan of care under Mood State a referral to a pain specialist is recorded. No pain assessment is available within the medical record for this resident.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance ensuring that the plan of care is based on, at a minimum, interdisciplinary assessment of the health conditions, including pain, to be implemented voluntarily.

WN #5: The Licensee has failed to comply with O.Reg 79/10, s. 54. Altercations and other interactions between residents

Every licensee of a long-term care home shall ensure that steps are taken to minimize the risk of altercations and potentially harmful interactions between and among residents, including,

- (a) identifying factors, based on an interdisciplinary assessment and on information provided to the licensee or staff or through observation, that could potentially trigger such altercations; and
- (b) identifying and implementing interventions. O. Reg. 79/10, s. 54.

Findings/Faits saillants :

1. The home did not take steps to minimize the risk of altercations and potentially harmful interactions between residents by implementing interventions that would protect female residents from the advances of a specified resident. The specified resident frequently approached staff and other female residents in a sexual manner. Documentation indicates that there were verbal, physical and sexually abusive behaviours on a daily basis. Over three months there were 17 documented episodes of sexual behaviour directed at female staff and residents. The home failed to take steps to minimize the risk of potentially harmful interactions in not initiating interventions to protect female residents from the specified resident.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance ensuring that steps are taken to minimize the risk of altercations and potentially harmful interactions between and among residents including identifying and implementing interventions, to be implemented voluntarily.

WN #6: The Licensee has failed to comply with O.Reg 79/10, s. 97. Notification re incidents

Specifically failed to comply with the following subsections:

s. 97. (1) Every licensee of a long-term care home shall ensure that the resident's substitute decision-maker, if any, and any other person specified by the resident,

(a) are notified immediately upon the licensee becoming aware of an alleged, suspected or witnessed incident of abuse or neglect of the resident that has resulted in a physical injury or pain to the resident or that causes distress to the resident that could potentially be detrimental to the resident's health or well-being; and

(b) are notified within 12 hours upon the licensee becoming aware of any other alleged, suspected or witnessed incident of abuse or neglect of the resident. O. Reg. 79/10, s. 97 (1).

Findings/Faits saillants :

1. A specified resident demonstrated inappropriate behaviours toward another specified resident. There is no record of the specified resident's family being notified of these incidents. Interview with the evening Registered Practical Nurse indicated that there was a brief interaction with the family of the specified resident related to incidents involving another specified resident. The discussion was not documented. There is no record of the resident's family being notified of the specific incident.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance ensuring that the resident's substitute decision-maker, if any, and any other person specified by the resident, are notified immediately upon the licensee becoming aware of an alleged, suspected or witnessed incident of abuse or neglect of the resident that has resulted in a physical injury or pain to the resident or that causes distress to the resident that could potentially be detrimental to the resident's health or well being, to be implemented voluntarily.

16. Every resident has the right to designate a person to receive information concerning any transfer or any hospitalization of the resident and to have that person receive that information immediately.
17. Every resident has the right to raise concerns or recommend changes in policies and services on behalf of himself or herself or others to the following persons and organizations without interference and without fear of coercion, discrimination or reprisal, whether directed at the resident or anyone else,
 - i. the Residents' Council,
 - ii. the Family Council,
 - iii. the licensee, and, if the licensee is a corporation, the directors and officers of the corporation, and, in the case of a home approved under Part VIII, a member of the committee of management for the home under section 132 or of the board of management for the home under section 125 or 129,
 - iv. staff members,
 - v. government officials,
 - vi. any other person inside or outside the long-term care home.
18. Every resident has the right to form friendships and relationships and to participate in the life of the long-term

19. Every resident has the right to have his or her lifestyle and choices respected.

20. Every resident has the right to participate in the Residents' Council.

21. Every resident has the right to meet privately with his or her spouse or another person in a room that assures privacy.

22. Every resident has the right to share a room with another resident according to their mutual wishes, if appropriate accommodation is available.

23. Every resident has the right to pursue social, cultural, religious, spiritual and other interests, to develop his or her potential and to be given reasonable assistance by the licensee to pursue these interests and to develop his or her potential.

24. Every resident has the right to be informed in writing of any law, rule or policy affecting services provided to the resident and of the procedures for initiating complaints.

25. Every resident has the right to manage his or her own financial affairs unless the resident lacks the legal capacity to do so.

26. Every resident has the right to be given access to protected outdoor areas in order to enjoy outdoor activity unless the physical setting makes this impossible.

27. Every resident has the right to have any friend, family member, or other person of importance to the resident attend any meeting with the licensee or the staff of the home. 2007, c. 8, s. 3 (1).

Order / Ordre :

The licensee shall prepare and submit a plan by November 2, 2011 to ensure that the rights of residents residing in the home and specifically a specified resident are fully respected and promoted; ensuring that they are protected from abuse by other residents, including a specified resident. This plan shall be implemented by November 7, 2011.

This plan shall be submitted electronically to Debora Saville Nursing Inspector, Ministry of Health and Long Term Care, Performance Improvement and Compliance Branch, Hamilton Service Area Office at debora.saville@ontario.ca by November 2, 2011.

Grounds / Motifs :

1. The home did not protect residents from abuse. A specified resident frequently approached female residents in a sexual manner, focusing attention on a specified resident. Documentation indicates that there are verbal, physical and sexually abusive behaviours on a daily basis. Over three months in 2011 there were 17 documented episodes of sexual behaviour directed at female staff and residents. On a specified date the resident was found inappropriately touching another resident. The home failed to protect residents from abuse. (192)
