Inspection Summary/Sommaire d'inspection

The purpose of this inspection was to conduct a Dietary Post Occupancy inspection in follow-up to the Pre-occupancy Review conducted April 2010.

During the course of the inspection, the inspector spoke with the Administrator, Nutrition Manager, Registered Dietitian, 2 cooks, and 2 dietary aides.

During the course of the inspection, the inspector conducted an inspection of storage areas in all the serveries, as well as the food produced for the lunch meal in the third floor serveries. Standardized recipes and production sheets along with the menus were reviewed with the Nutrition Manager.

Findings:

The home does not have a menu cycle for meals and snacks for residents on vegan vegetarian diets.

WN #2: The Licensee has failed to comply with O. Reg. 79/10, s. 72(2)(c)
 The food production system must, at a minimum, provide for,
 (c) standardized recipes and production sheets for all menus.

Findings:

The home does not have standardized recipes and production sheets for vegetarian diets.

Additional Required Actions:

VPC - pursuant to the *Long-Term Care Homes Act, 2007*, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that standardized recipes and production sheets are available for vegetarian diets, to be implemented voluntarily.
