The purpose of this inspection was to conduct a Complaint inspection.

During the course of the inspection, the inspector(s) spoke with Administrator, Assistant Director of Care (ADOC), Registered Nurses (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSW), and Residents.

During the course of the inspection, the inspector(s) conducted a walk-through of resident home areas and various common areas, observed care provided to residents in the home, and reviewed resident health care records.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 32. Every licensee of a long-term care home shall ensure that each resident of the home receives individualized personal care, including hygiene care and grooming, on a daily basis. O. Reg. 79/10, s. 32.

Findings/Faits saillants :

1. A resident's plan of care indicates that they are to be shaved daily. On January 19 and 20, 2012 inspector 106 observed long stubble under the resident's chin. On January 20, 2012, a PWS, applied the residents dentures and hearing aids at approximately 1030 hours, after they were interviewed regarding the care of of the resident. The licensee failed to ensure that the resident receives individualized personal care, including hygiene care and grooming on a daily basis. [O. Reg. 79/10, s. 32] (106)
