Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator and the Assistant Director of Care.

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care

Specifically failed to comply with the following subsections:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

1. Review of the resident's plan of care, and the resident's clinical health records, identified the resident as a high risk for falls. The resident's plan of care outlined interventions to prevent falls and injuries, which included:

1. Bed chair alarm to be used while resident is in bed.
2. Bed is to be kept at lowest level and locked in position.
3. "Crash mat" at all times.

Interview with Assistant Director of Care, and review of the resident's clinical records confirm that the Personal Support Workers caring for the resident were not familiar with resident's plan of care and had not reviewed the plan of care prior to providing care.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the care set out in the plan of care is provided to the resident as specified in the plan., to be implemented voluntarily.
