Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 8. Policies, etc., to be followed, and records
Specifically failed to comply with the following subsections:

s. 8. (1) Where the Act or this Regulation requires the licensee of a long-term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the licensee is required to ensure that the plan, policy, protocol, procedure, strategy or system,
(a) is in compliance with and is implemented in accordance with applicable requirements under the Act; and
(b) is complied with. O. Reg. 79/10, s. 8 (1).

Findings/Faits saillants :

The licensee's policy for drug destruction from the Pharmacy Policy and Procedure Manual for LTC Homes ,Section 5, policy 5-4 states: "The nurse who processes an order to discontinue a narcotic or controlled medication requiring disposal is responsible for removing the medication(s) along with the count sheet sheet(s) and extra reorder labels from the medication and the narcotic bin".

The licensee's investigation and the Administrator confirmed, that medication was removed from the medication /narcotic cupboard prior to receiving a discontinue order from the physician as per the licensee's policy. [r.8(1)(b)].
