Inspection Summary/Sommaire d'inspection		

The purpose of this inspection was to conduct a Dietary Follow-up inspection in respect to the Long Term Care Homes Program Manual Standards and Criteria previously identified as B2.4, B3.23, B3.33, and P1.22 issued April 2009.

During the course of the inspection, the inspector spoke with: the director of care, the foodservices supervisor, cooks, dietary staff, nursing staff and residents.

The inspector observed breakfast, lunch and pm snack service. The Home's policy on feeding dependent clients was requested and reviewed. Plans of care were reviewed in the resident's chart. The menu, production sheets and recipes were reviewed for the two days of this inspection.

WN #1: The Licensee has failed to comply with LTCHA, 2007, S.O. 2007, c. 8, s. 6 (1) (c). Every licensee of a long-term care home shall ensure that there is a written plan of care for each resident that sets out, clear directions to staff and others who provide direct care to the resident.

Findings:

1. Resident #1; the resident diet binder indicates a regular texture diet; however the plan of care indicates a minced texture.
2. Resident #2; the resident diet binder indicates a regular texture diet; however the plan of care indicates a minced meat texture.
3. Resident #3; the resident diet binder indicates a regular diet; however the plan of care indicates a modified diabetic diet.
4. Resident #4; the resident diet binder indicates a regular texture diet; however the plan of care indicates a minced meat texture.
5. Resident #5; the resident diet binder indicates a minced meat texture diet; however the plan of care indicates a full minced texture.

Additional Required Actions:

VPC - pursuant to the *Long-Term Care Homes Act, 2007*, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance with providing clear direction to staff regarding resident dietary needs, to be implemented voluntarily.
