Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 8.

(3) Every licensee of a long-term care home shall ensure that at least one registered nurse who is both an employee of the licensee and a member of the regular nursing staff of the home is on duty and present in the home at all times, except as provided for in the regulations. 2007, c. 8, s. 8 (3).

1. The licensee failed to comply with LTCHA s. 8(3) when there was no Registered Nurse(RN)on duty for 31 night shifts for the period of March 2013 to August 21, 2013.

The Executive Director has confirmed that between the period of March 01, 2013 and August 21, 2013 there were 31 night shifts where there was no RN on duty. The home attempted to fill the position with regular RN staff as well as Agency RN staff but was unable to provide full RN coverage. The staffing compliment consisted of two Registered Practical Nurses (RPN) on duty during the nights in question.

The home was actively recruiting for the Registered Nursing position and interviews were conducted but no successful candidate was found. The home also uses an Nursing Agency for staffing needs. The Registered Nurse position was filled in July 2013. [s. 8. (3)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance ensuring that a least one Registered Nurse who is both an employee of the licensee and a member of the regular nursing staff of the home is on duty and present in the home at all times., to be implemented voluntarily.

WN #2: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care

Specifically failed to comply with the following:

s. 6. (9) The licensee shall ensure that the following are documented:

- 1. The provision of the care set out in the plan of care. 2007, c. 8, s. 6 (9).**
 - 2. The outcomes of the care set out in the plan of care. 2007, c. 8, s. 6 (9).**

1. The licensee failed to comply with LTCHA, 2007 s. 6(9)2 when the outcomes of the care set out in the plan of care was not documented.

Review of the plans of care for both resident #18 and #15 indicate that the residents are to be given a bath twice a week. Review of the bathing list for resident #18 and #15 indicated that the residents were to be provided with a bath on an identified date. Review of the bathing records for the identified date on Point of Care (POC) for both residents did not indicate that a bath was provided.

Interview with PSW #2 and PSW #4 verified that the baths were completed for both residents but that the PSW's had not documented the baths on the identified date. [s. 6. (9) 2.]
