WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 19. Duty to protect
Specifically failed to comply with the following subsections:

s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits saillants :

1. An identified resident was not protected by the licensee from emotional abuse by staff of the home. The home was informed of the allegation of emotional abuse towards a resident. The home's investigation confirmed the incident of emotional abuse occurred. The home's policy and procedure for "Resident Abuse" states emotional abuse is the evoking of fear, verbal assault including threatening and humiliation.

During the inspection the resident stated that the verbal assault caused them to be upset and thought the staff person was purposely trying to make them feel low. s.19.(1)
