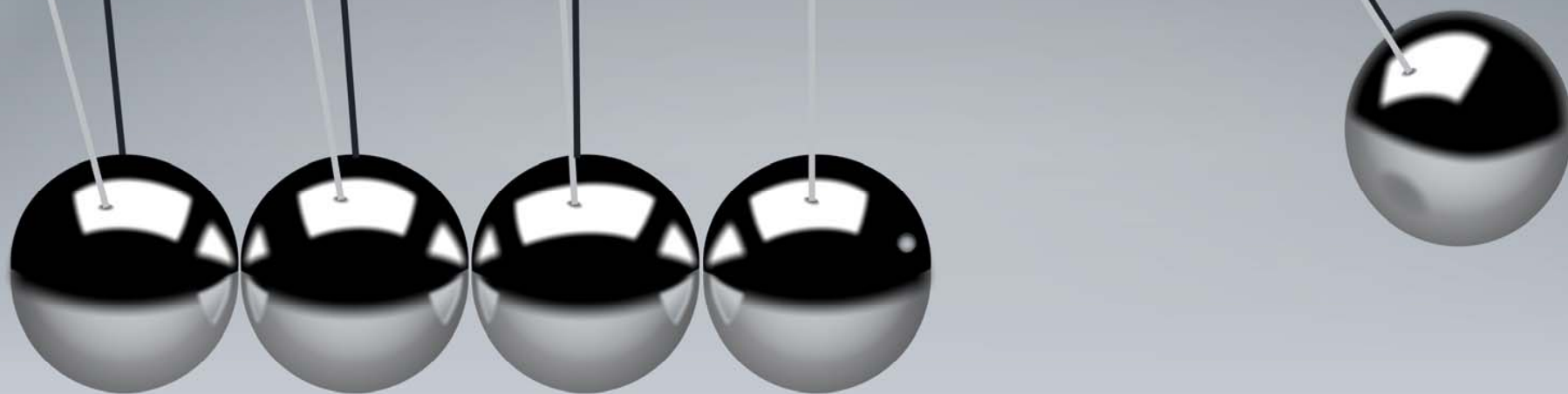

THE POSTSECONDARY EDUCATION QUALITY ASSESSMENT BOARD

OUR MANDATE

The Postsecondary Education Quality Assessment Board (PEQAB or the “Board”) was created by the *Post-secondary Education Choice and Excellence Act, 2000*. Under sections 5 and 7 of the Act, the Board is empowered to

- review all applications referred by the Minister for consent under the Act
- establish the criteria and procedures to determine the quality of postsecondary programs
- undertake reviews of program quality and organizational capacity
- create subject matter expert review panels, organizational review panels and advisory committees
- undertake research as appropriate
- provide recommendations to the Minister on applications
- address any other matter referred to the Board by the Minister.

To implement this mandate, the Board has established its own standards, benchmarks and procedures for quality reviews with the provision, identified in the Act, that PEQAB’s standards must be those “recognized in Ontario and other jurisdictions.” The Board assesses programs against standards originally developed by PEQAB itself and later incorporated into what are now the degree standards in the Ontario Qualifications Framework and the Canadian Degree Qualifications Framework. PEQAB’s criteria also correspond to other procedures and standards enunciated in the Canadian “Ministerial Statement on Quality Assurance of Degree Education in Canada, 2007,” including provisions for fairness, transparency, the use of expert panels of reviewers, and the opportunity for institutions to respond to reviews prior to Board decisions.

CHAIR'S MESSAGE



On behalf of the Postsecondary Education Quality Assessment Board, I am pleased to introduce the 2017/18 Annual Report. This report details the Board's activities from the beginning of April, 2017 to the end of March, 2018. Over nine meetings, the Board made thirty-nine recommendations to the Minister on applications for consent. Of these recommendations, thirty-two were in respect of Ontario colleges, two were in respect of public institutions, and five were in respect of private institutions.

The Board continues to work with stakeholders to develop Ontario's quality assurance system. One highlight during the current reporting year includes implementing an expedited renewal process for Colleges of Applied Arts and Technology and Institutes of Technology and Advanced Learning. This process recognizes the internal quality assurance practices of these institutions. Another highlight in the reporting year concerns the expansion of the Board's collaborative initiatives with stakeholders. Applicants may now nominate several persons from whom the Board may choose one to serve on External Expert Review Panels.

In addition to information on applications referred to the Board, the 2017/18 Annual Report identifies progress against goals identified in the 2016/17 Annual Report. As detailed on pages three and four, the Board has fully met many of its annual goals and is in process on the others. The Board's annual goals for 2017/18 are presented on page six.

The Board is supported by a Secretariat based in the Ministry of Training, Colleges and Universities. Secretariat staff continue to strengthen Ontario's relationship with the broader quality assurance community by regularly participating in national and international postsecondary education quality assurance conferences and by engaging in relevant substantial research projects. Participation in national and international forums presents a valuable opportunity for staff to discuss strategic and operational matters related to degree granting, quality assurance and student protection. The Secretariat's research contributes to the ongoing development of its standards, ensuring that Ontario's quality assurance system is contemporary and based on research, evidence and best practice. I am also pleased to note that the Secretariat has worked with the Ministry, the Aboriginal Institutes Consortium and Indigenous Institutes to establish a quality assurance framework to support the new postsecondary Indigenous Institute sector in Ontario.

I would like to thank Board members Richard Barham, Rob Devitt, Robert Gordon, Dianne Kieren, Alexandre Laurin, Catherine Chandler-Crichlow and Patricia Lang for their outstanding service to the Board.

REPORT ON THE BOARD'S ANNUAL GOALS

The information below presents the goals identified in PEQAB's 2016/17 Annual Report and reports on how the Board has met those goals over the reporting year.

- 1. Develop an Audit-Only Review Process:** Work with Ontario Colleges through the College Degree Operating Group (CDOG) and the Ministry through the Postsecondary Education Division and the Strategic Policy and Programs Division to formalize a process which recognizes an institution's maturity in degree granting.

2017/18 Progress: Working closely with Ontario Colleges through CDOG and the Ministry, the Board implemented a new process of expedited renewals. The expedited renewal process recognizes an institution's maturity in granting degrees, simplifying the process of renewing applications for ministerial consent by relying on the institution's self-study and the evaluation of the Program Evaluation Committee selected by the college.

- 2. Incorporation of Student Input into the Quality Assurance Process:** Work with Ontario Colleges, public-in-province, public-out-of-province and private applicants to incorporate student input into quality assessment reviews.

2017/18 Progress: A study has been conducted on national and international trends in student engagement in quality assurance and options are being developed to incorporate increased student feedback into the PEQAB quality assurance process.

- 3. Increase Transparency:** Establish a process in consultation with consent holders to increase the transparency of External Expert Panel Reports and formal institutional replies.

2017/18 Progress: The Board approved the creation and distribution of "PEQAB Final Reports". PEQAB Final Reports are documents which summarize External Expert Review Panel conclusions and applicant responses on applications for Ministerial consent. These reports are now shared with institutions and reviewers.

- 4. Expand Program Advisory Committee Membership:** Broadened PEQAB's requirement for Program Advisory Committees to ensure they include expertise in the field of study.

2017/18 Progress: The Board approved revisions to the Program Advisory Committee requirement to include expertise in the field of study.

- 5. Modify Work-Integrated Learning Experience:** Expand the Board's requirement that Ontario College students earn 420 hours through a work-integrated learning experience to include hours earned on a part-time basis concurrent with their studies.

2017/18 Progress: The Board expanded and implemented its work-integrated learning experience requirement to include hours earned on a part-time basis.

- 6. Update the Ontario Qualifications Framework:** Engage with the Ministry to consider revisions to degree level competencies/learning outcomes identified in Ontario's Qualifications Framework (OQF).

2017/18 Progress: In addition to a modification identifying Indigenous Institutes as credential granting organizations, the Secretariat remains engaged with the Ministry as it considers revisions to degree level competencies/learning outcomes identified in the OQF.

REPORT ON THE BOARD'S ANNUAL GOALS

7. **Reduce PEQAB's Benchmarks:** Reduce the number of benchmarks currently used to quality assess applicant institutions.

2017/18 Progress: The Board has reviewed all its standards and benchmarks and has achieved a notable reduction in the number of benchmarks used to quality assure applicant institutions. Revised quality assurance materials will be updated to the Board's website for 2018/19.

8. **Develop an Appeals Process:** Work with the Ministry on developing a process to allow reconsiderations of Board recommendations.

2017/18 Progress: Working with the Ministry, the Board has developed and implemented a process for reconsideration of a Board recommendation at the request of the applicant institution, prior to the Minister's final decision.

9. **Credential Recognition and Quality Assurance for Indigenous**

Institutes: Work with the Ministry, the Aboriginal Institutes Consortium and Indigenous Institutes to develop a process for credential recognition and quality assurance for Indigenous Institutes in Ontario.

2017/18 Progress: The Secretariat supported the development of a quality assurance framework, including quality assurance Handbooks and Submission Guidelines, for each credential to be offered in Ontario's Indigenous Institutes sector.

OTHER ACCOMPLISHMENTS: 2017/18

During the reporting year, the Board and its Secretariat completed the following initiatives and enhancements.

1. **Aligned** PEQAB review processes with accreditation processes to reduce institutional burden.
2. **Enabled** paperless submissions from applicants for Ministerial consent.
3. **Contributed** to conversations on contemporary topics in quality assurance through research projects and publications, including
 - the role of students in quality assurance
 - the impact of learning outcomes policies
 - the use of learning outcomes for transfer in Ontario
 - the ability of college degree graduates to access graduate school.
4. **Raised** PEQAB's international profile by presenting and participating in local, national and international conferences, including
 - the European Union's Bologna Process Rectors Conference
 - the European Quality Assurance Forum
 - the Canadian Society for Teaching and Learning in Higher Education
 - the Ontario Council on Articulation and Transfer Annual Student Pathways Conference
 - the Council for Higher Education Accreditation International Quality Group Conference
 - the United Nations Educational, Scientific and Cultural Organization/ International Network of Quality Assurance Agencies in Higher Education Conference.
5. **Continued** collaboration and consultation with College Degree Operating Group the Coordinating Committee of Vice-Presidents Academic, and the Private and Out-of-Province Degree Operation Group.
6. **Hosted** an international delegation from Croatia's quality assurance agency, the Croatian Agency for Science and Higher Education and participated in a staff exchange.
7. **Collaborated** with sister quality assurance agencies in Canada and published a list of degree mills on PEQAB's website to better inform the public.
8. **Implemented** a Concerns and Complaints procedure related to programs approved by PEQAB, PEQAB operations and the *Post-secondary Education and Choice Act, 2000*.
9. **Developed** a process of allowing applicants to nominate reviewers for consideration by the Board, and allowing applicants to identify any conflicts of interest with reviewer candidates identified by the Board's Secretariat.
10. **Revised PEQAB Benchmarks**
 - Amended the Board's Work-Integrated Learning requirement to include hours earned on a part-time basis
 - Implemented a process to validate faculty member credentials by requiring due diligence with respect to the academic credibility of the credential granting institution for all qualifications claimed by faculty members at Ontario Colleges, and
 - Revised the Board's Program Evaluation Standard.
11. **Supported** the Minister's Advisory Council of Students.
12. **Published** *PEQAB External Expert Review Panel Reports: An Analysis of Recommendations* to the Board's website. The report presents the patterns of common strengths and weaknesses in applications reviewed between 2011 and 2016.

ANNUAL GOALS

Articulating goals for the Board provides a basis to continually monitor and improve practical aspects of quality assurance and serves as a reference point for accountability and progress. The goals for the Board in 2018/2019 include:

- 1. Quality Assuring Ontario's New French Language University**
Work with the French Language University to quality assure their inaugural applications for Ministerial consent under the *Post-secondary Choice and Excellence Act, 2000*.
- 2. Completing *College Degree Graduates: Hopes and Hurdles***
College Degree Graduates: Hopes and Hurdles is a study of further educational opportunities for graduates of Ontario college degree programs. The research project is a collaboration between PEQAB and Algonquin College, Centennial College, Conestoga College, Fanshawe College, George Brown College, La Cité collégiale, Seneca College and Sheridan College.
- 3. Completing *Students in Quality Assurance* Research Project**
The *Students in Quality Assurance* research project examines national and international activities in student engagement in quality assurance. The research project is a collaboration between PEQAB and Seneca College.
- 4. Increasing Student Participation in Quality Assurance**
Implement measures to increase student participation in quality assurance processes and procedures.
- 5. Developing and Sharing Institutional Specific Reports**
Develop and share institution specific analysis of trends based on historical *External Expert Review Panel Reports*.
- 6. Publishing Updated Quality Assurance Review Materials**
Publish quality assurance materials which identify the reduction of benchmarks used for applications for Ministerial consent.
- 7. Creating More User-Friendly Documents**
Combine PEQAB's Handbooks and Submission Guidelines to create a single document which increases clarity and directness.
- 8. Increasing the Participation Rate for PEQAB's Client Satisfaction Surveys**
Increase the applicant response rates for PEQAB's Client Satisfaction Surveys administered after a PEQAB site-visit and once a quality assurance review has been completed.
- 9. Quality Assuring "2+2" Diploma-to-Degree Pathways**
Develop a process to quality assure transfer pathways between diplomas and degrees at Ontario Colleges.

PERENNIAL GOALS

In addition to the annual goals – goals developed on an annual basis and unique to each reporting year – the Board has also identified ongoing, year-over-year goals which will be incorporated into standard operating practice. These goals include:

1. Maintain Client Satisfaction Levels

Maintain exceptional levels of client satisfaction, as determined by the Board's multiple ongoing Client Satisfaction Surveys. Specifically,

- a) Maintain an average of 80% or above for the combined answers 'satisfied' and 'very satisfied' for all questions in PEQAB's post-site visit survey.

2017/18 Progress: As detailed on pages 26-7, the Board maintained an average above 80% for the combined answers 'satisfied' and 'very satisfied' for all questions in PEQAB's post-site-visit survey.

- b) Maintain an average of 90% or above for the combined answers 'satisfied' and 'very satisfied' for all questions in PEQAB's post-review survey.

2017/18 Progress: As detailed on pages 28-9, the Board maintained an average above 90% for the combined answers 'satisfied' and 'very satisfied' for all questions in PEQAB's post-review survey.

- c) Maintain an average of 90% or above for the combined answers 'satisfied' and 'very satisfied' for all questions in PEQAB's External Expert Panel survey.

2017/18 Progress: As detailed on pages 30-1, the Board maintained an average above 90% or above for the combined answers 'satisfied' and 'very satisfied' for all questions in PEQAB's External Expert Panel survey.

2. Maintain Publication Schedule

- a) Publish revisions to the Board's *Handbooks, Submission Guidelines* and accompanying *Record of Change* to PEQAB's website in August of each reporting year.
- b) Publish the Board's Annual Report in August of each reporting year.

2017/18 Progress: The Board maintained its publication schedule.

3. Engage with the Quality Assurance Community of Practice

- a) Continuously monitor best practices from national and international quality assurance bodies.
- b) Participate in provincial, national and international discussions, meetings and conferences related to quality assurance.

2017/18 Progress: As detailed on pages 32-4, PEQAB is actively engaged in national and international quality assurance conferences and the CEO chair's national quality assurance teleconferences.

PERFORMANCE MEASURES

The following performance measures will assist the Board in tracking its progress regarding stakeholder satisfaction and against annually established goals:

1. Satisfaction Levels

Establish performance goals against baseline results of PEQAB's 2017/18 Client Satisfaction Surveys, and track the results year-over-year.



2. Application Timelines

Report on results achieved against the Board's target goals of eight months for a review of new programs/renewals and six months for amendments/conditions of consent.



3. Results Achieved against Annual Goals

Report on results achieved against the Board's previous annual goals, on a year-over-year basis.

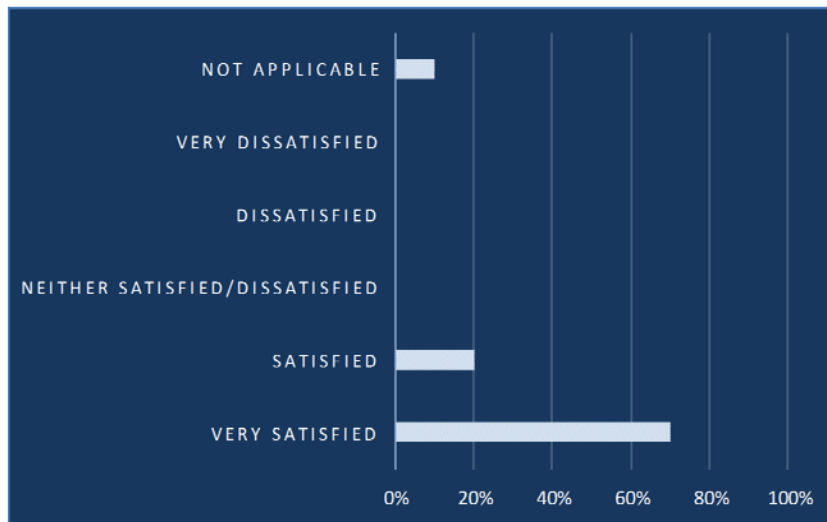

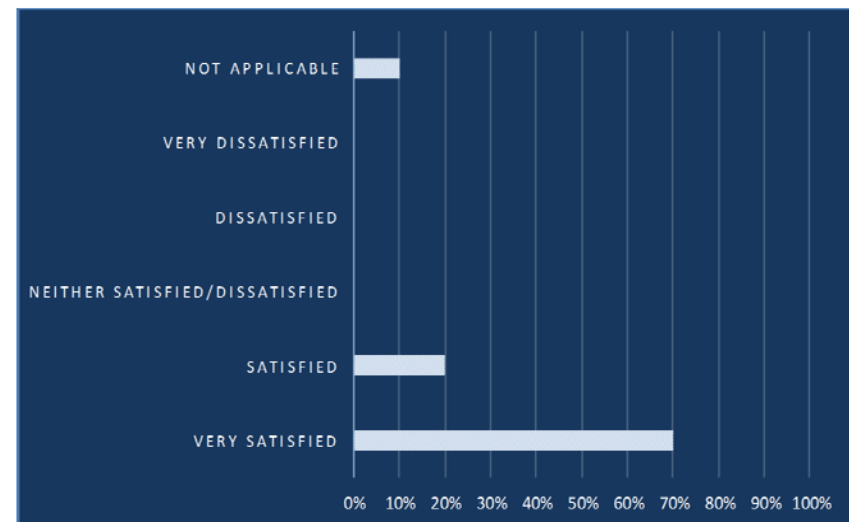
POST SITE-VISIT SURVEY

Q2: How satisfied have you been with the **timeliness** of the response you received from PEQAB Secretariat staff?

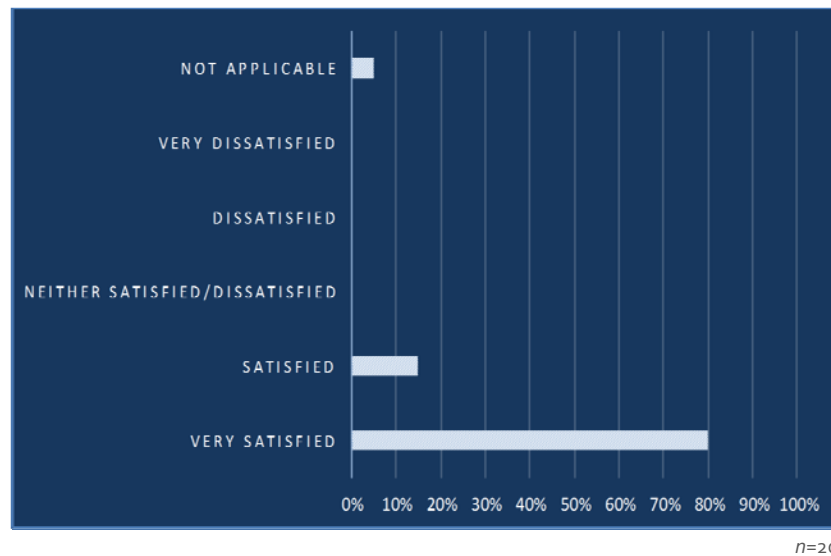

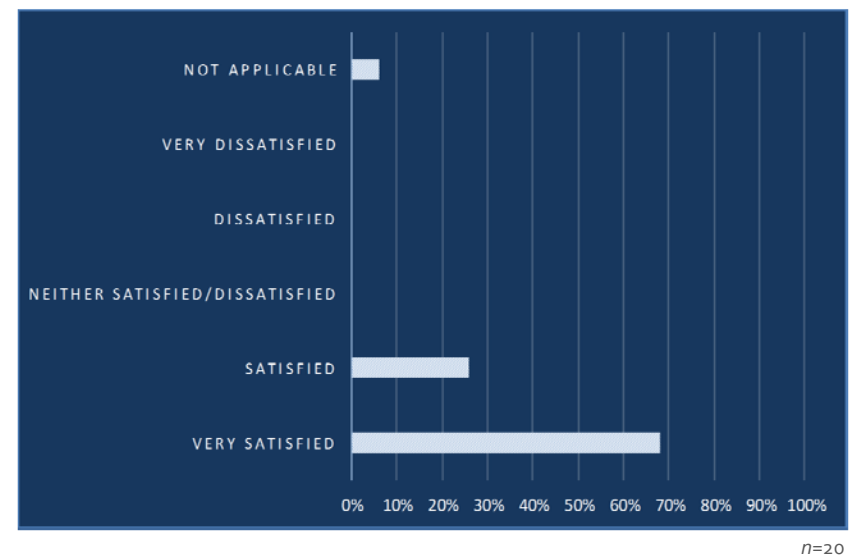

Q3: How satisfied have you been that the **attitude of PEQAB Secretariat staff** has been helpful/collegial?



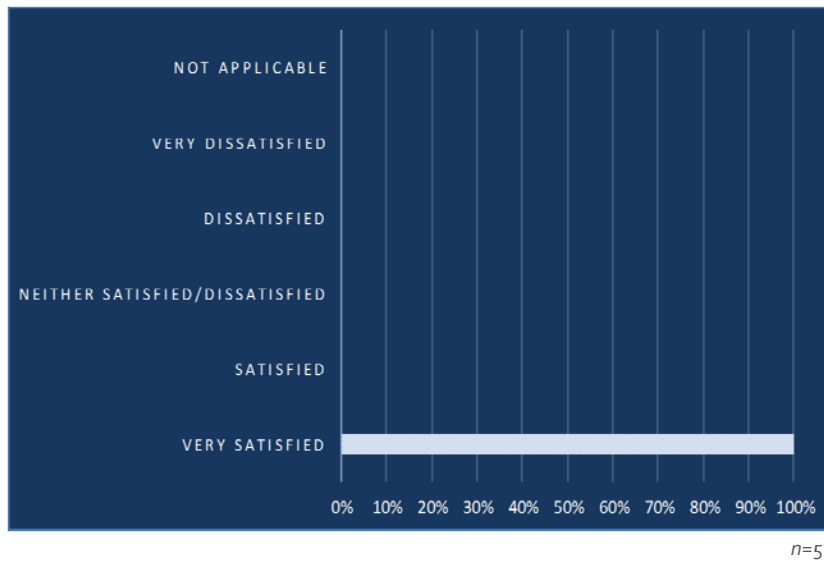

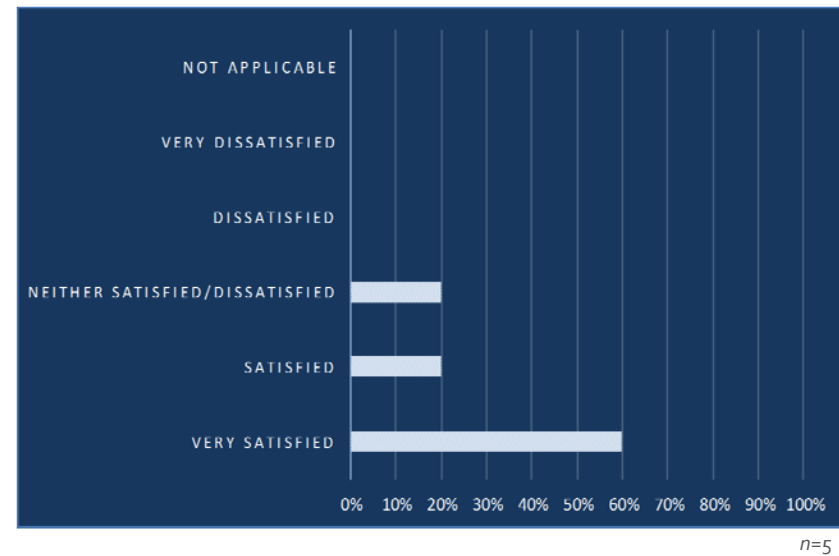

Q1: How satisfied have you been with the **quality/usefulness** of the responses you received from PEQAB Secretariat staff?



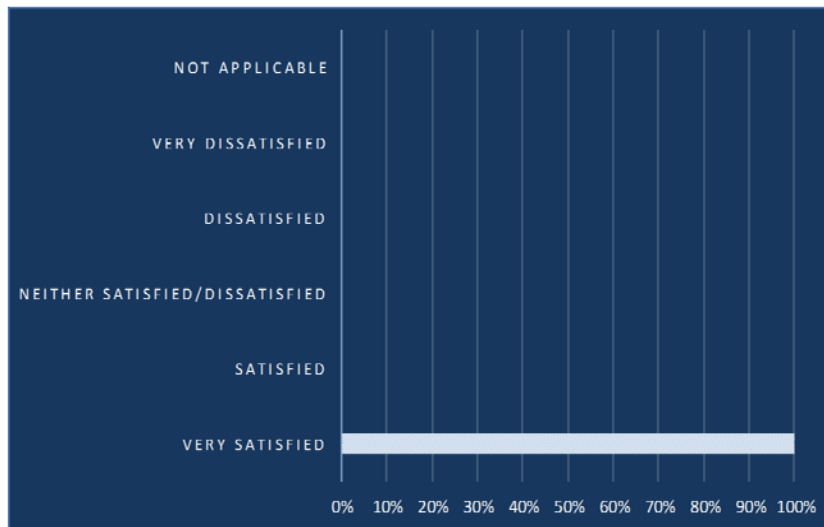
Q2: How satisfied have you been with the **timeliness** of the response you received from PEQAB Secretariat staff?

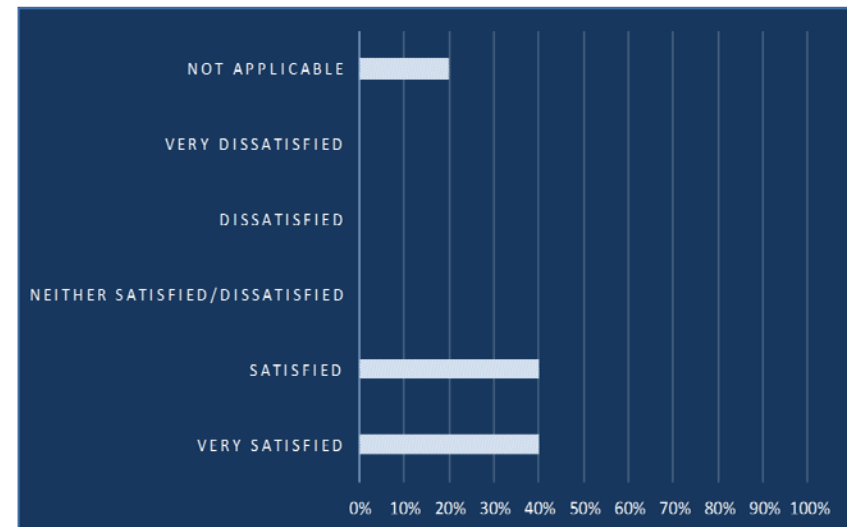

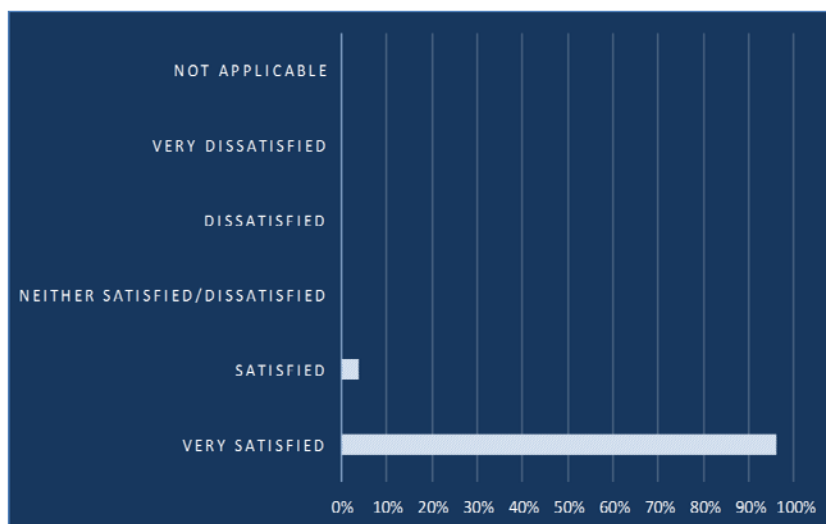

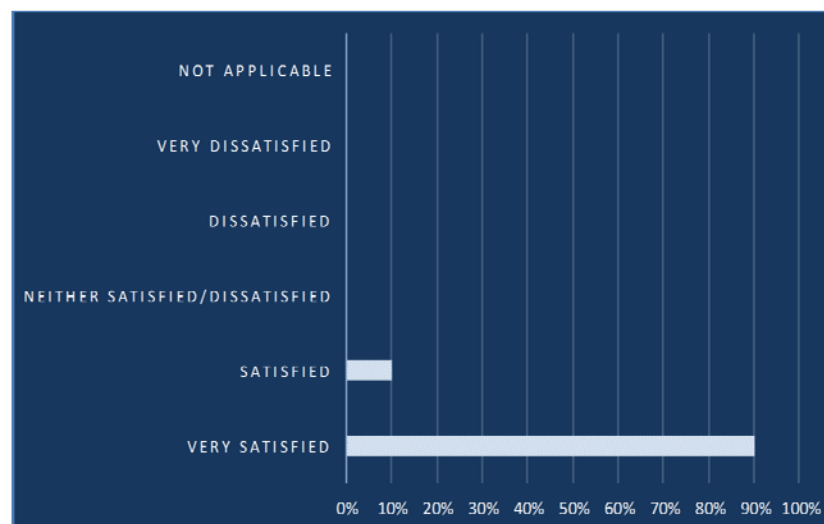

Q2: How satisfied have you been with the **timeliness** of the support you received from PEQAB Secretariat staff?

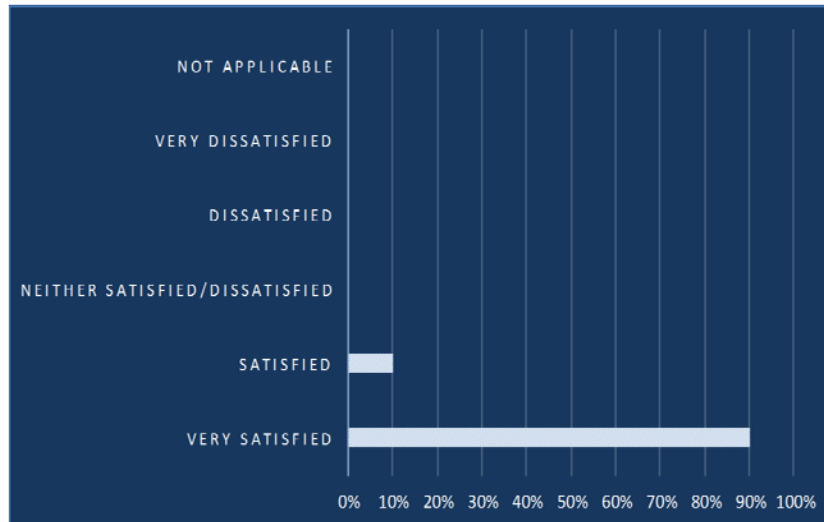

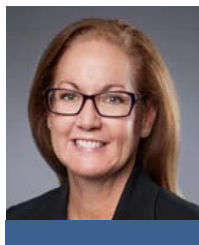
