The government of Ontario is committed to providing the information healthcare providers require in order to deliver the services needed to manage SARS. As part of these ongoing communications, the government will be issuing a SARS bulletin on a regular basis to inform healthcare professionals of new directives and other pertinent information.

This bulletin provides an update on new directives and communications and does not replace or amend these documents.

KEY INFORMATION FOR HEALTHCARE PROFESSIONALS

- Healthcare workers are advised to take the simple precaution of remaining at home should they feel ill.
- A communication pertaining to visits on Mother's Day was issued on May 2nd.
- A communication about mask testing services to obtain the best fit for specific facial features was issued on May 2nd.

DIRECTIVES

- No new directives were issued today.
- Please consult your facility administration and organization/college to obtain copies of all directives issued to date.

NEWS

- The U.S. National Institute of Allergy and Infectious Diseases (NIAID) has requested capability statements and letters of interest from investigators, specifically for antibody preparation, treatments or vaccines for SARS. KEY SARS FACTS

- All hospitals have restricted access but there are no facilities currently classified as level 2 or 3.
- All long-term care facilities have restricted access.
- Active cases have declined by 40% in the past 10 days (from 106 to 64).
- Hospitalized cases (probable & suspect) have declined by 45% in the past 10 days (from 84 to 46).
- Discharges have risen by 27% in the past 10 days (from 140 to 178).

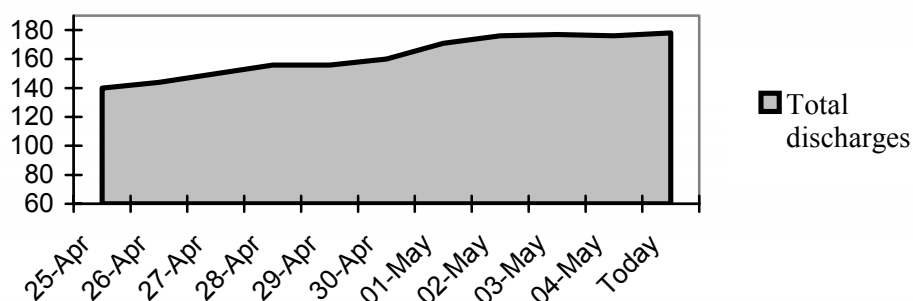
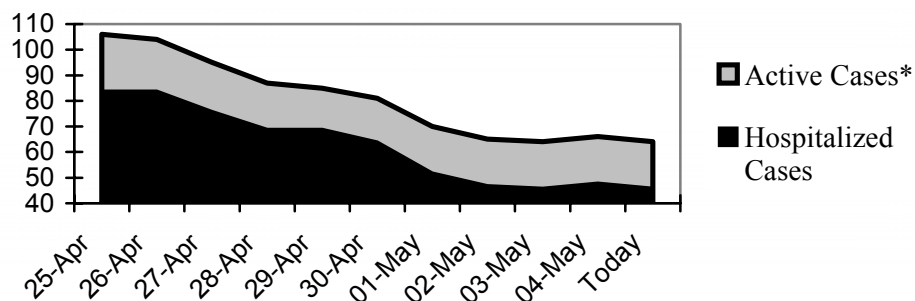
