The government of Ontario is committed to providing the information healthcare providers require in order to deliver the services needed to manage SARS. As part of these ongoing communications, the government will be issuing a SARS bulletin on a regular basis to inform healthcare professionals of new directives and other pertinent information.

This bulletin provides an update on new directives and communications and does not replace or amend these documents.

KEY INFORMATION FOR HEALTHCARE PROFESSIONALS

- Proper mask fitting is a critical component of infection control and is also an occupational health and safety requirement.

DIRECTIVES

- Questions and answers pertaining to directives issued on May 1st (O3-04R) for acute care facilities were issued yesterday.
- A letter to acute care facilities was issued yesterday.
- Please consult your facility administration and organization/college to obtain copies of all directives issued to date.

NEWS

- Health Canada has announced the composition of its National Advisory Group on SARS and Public Health. The group will be chaired by Dr David Naylor, Dean of Medicine at the University of Toronto. - The US Centers for Disease Control and Prevention is holding a webcast May 8th at 1pm EST. This broadcast will provide information to clinicians to increase awareness of Severe Acute Respiratory Syndrome (SARS) and reinforce concepts of early recognition, diagnosis, and containment. KEY SARS FACTS

- All hospitals have restricted access but there are no facilities currently classified as level 2 or 3.
- All long-term care facilities have restricted access.
- Active cases have declined by 30% in the past 10 days (from 87 to 60).
- Hospitalized cases (probable & suspect) have declined by 38% in the past 10 days (from 69 to 43).
- There are 27 probable and 16 suspect hospitalized cases.
- Discharges have risen by 16% in the past 10 days (from 156 to 181).

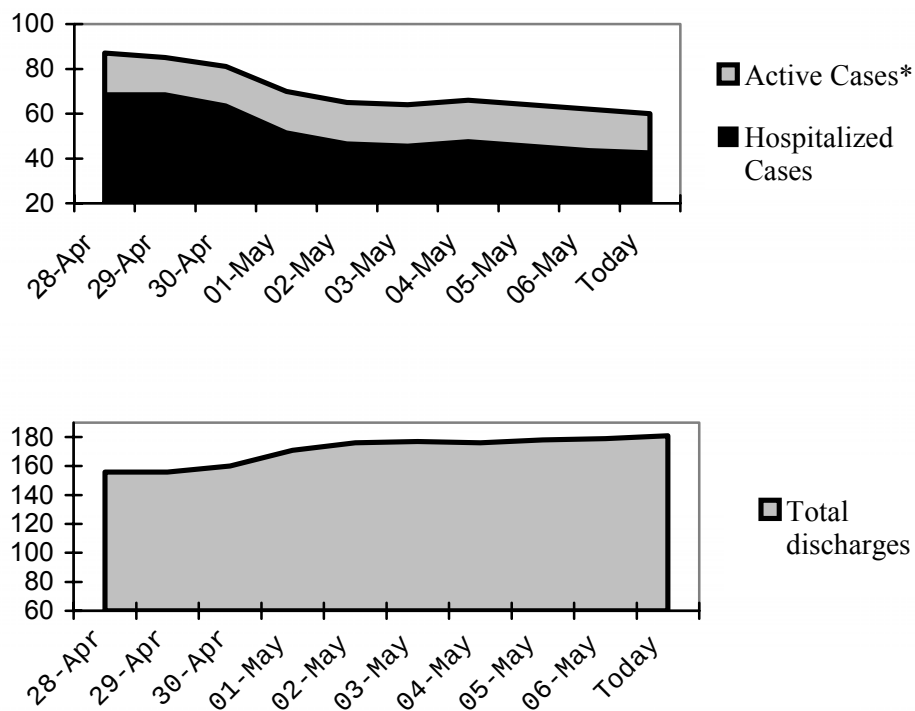
