Ontario Disability Support Program Monthly Statistical Report - April 2021

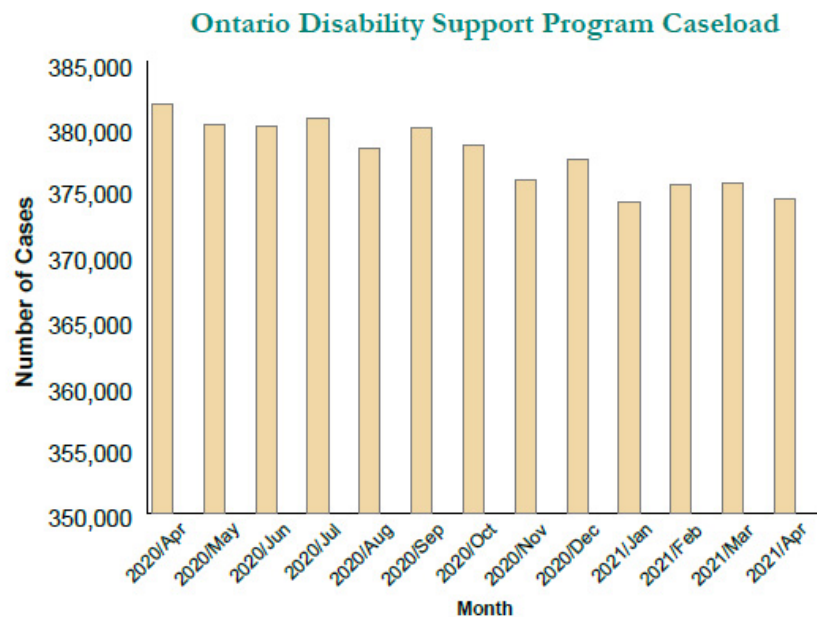
The **Ontario Disability Support Program** provides income support and health-related benefits to people with disabilities who are in need of financial assistance. The employment supports component of the program offers a range of services to help people with disabilities to look for, obtain or maintain jobs.

Assistance for Children with Severe Disabilities provides a benefit for parents caring for children with severe disabilities at home. In April 2021, there were 24,905 ACSD cases receiving this benefit on behalf of 30,025 children.

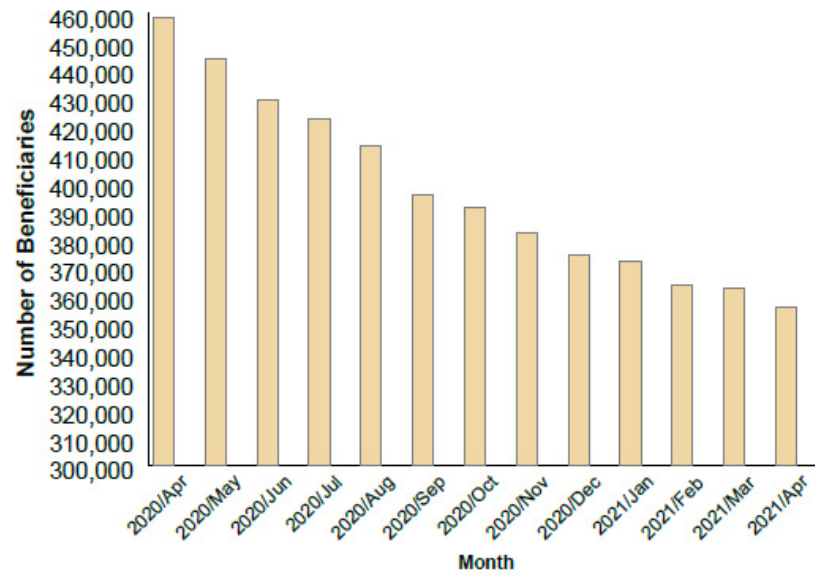
