Risk Register Due December 5, 2007

The third quarter Health Service Provider (HSP) Risk Register is due at the North East Local Health Integration Network (NE LHIN) on or before **December 7, 2007**. The submission date has been revised due to a date change of the NE LHIN Board Meeting.

You do not need to complete the Risk Register if you do not have changes to your Second Quarter Report or if you do not have any new risks to report. If applicable to your organization, risks affecting protected volumes and performance targets must be included in the Third Quarter Risk Register Template.

Based on suggestions received by HSPs, the NE LHIN has streamlined the process that will be used to complete the Risk Registers. Through our portal we created a secure site for each Health Service Provider. A user name and password has been assigned to your organization. If you have more than one program, please share the user name and password with the person responsible for completing the Risk Register. Please note that the completion of the risk register is still done by program.

Once you get into your site, you will note that the Second Quarter Risk Register has been uploaded. In order for you to have all your registers filed in one place, please upload your first quarter report.
