Risk Register Due Wednesday, June 11, 2008

The first quarter Health Service Provider (HSP) Risk Register for 2008/09 is due at the North East Local Health Integration Network (NE LHIN) **on or before Wednesday, June 11, 2008**

You do not need to complete the Risk Register if you do not have changes to your 2007/08 fourth Quarter Report or if you do not have any new risks to report.

Based on suggestions received by HSPs, the NE LHIN has streamlined the process that will be used to complete the Risk Registers. Through our portal we created a secure site for each Health Service Provider. A user name and password has been assigned to your organization. If you have more than one program, please share the user name and password with the person responsible for completing the Risk Register. Please note that the completion of the risk register is still done by program.
