TIMELINE UPDATES

- The 'L-SAA Pre Meet & Greet sessions' took place on May 29, June 1, 3, and 5.
- An online session of the 'Meet & Greet' material is scheduled for August 25, 2009 from 1:00-2:30 pm.
- The LAPS Guidelines are projected to be released to the field mid-September
- The LAPS is tentatively due to the Central East LHIN November 16, 2009. This date is subject to change based on the release of the LAPS Guidelines.

Virtual 'Meet & Greet' August 25th

The CE LHIN will be hosting an online presentation of the materials from the 'L-SAA Meet & Greet' sessions, held in the Spring. All LTCHs are invited to join as we will also be addressing an update to the materials. An email will be sent out with further details soon.

The Central East LHIN held four 'Pre-L-SAA Meet & Greet' sessions in Scarborough, Peterborough, Courtice, and Lindsay and on May 29, June 1, 3, and 5th. These sessions were an introduction to the LHIN, as well as a brief overview and timelines of the Long Term Care Home Annual Planning Submission (LAPS) and the Long Term Care Home Service Accountability Agreement (L-SAA). There were also special presentations from the Ontario Healthcare Reporting Standards (OHRS)

Project team, as well as information in regards to the B & C Bed Renewal Strategy.

The CE LHIN committed to releasing a FAQ document that captured all of the questions that were asked throughout the sessions. This document is available on the website, under Resource Documents > Accountability > LAPS/ L-SAA page.

The L-SAA Steering Committee is currently completing the sector consultations, which involves a series of table top exercises with the

various associations. The L-SAA Steering Committee is a combination of LHIN representations as well as a variety of MOHLTC branch members to overview the LAPS/L-SAA process and to act as a governing body. The LAPS guidelines are due to be released by mid September. The L-SAA will be vetted by all 14 LHIN Boards in October/ November. A two-thirds majority vote will be needed for the agreement to be accepted as a final version.

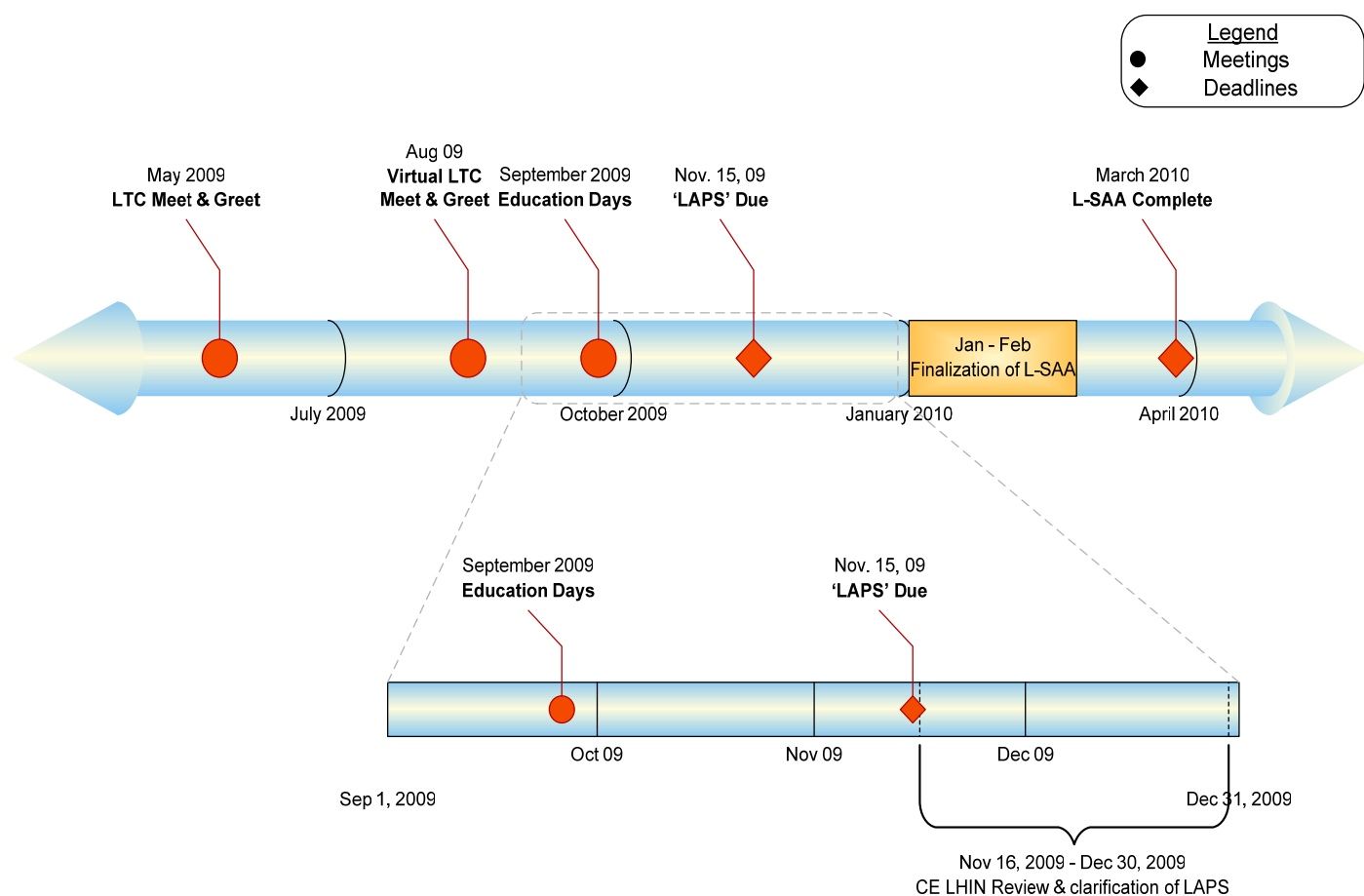
