Wage Gap Program

In January of 2011, the Pay Equity Office introduced a new program, aimed at collecting sufficient data to enable us to determine whether gender discrimination in pay practices is still prevalent in non-unionized Ontario workplaces.

We are currently contacting Ontario workplaces with more than 500 employees that have not recently been visited by a Review Officer, before proceeding to reach small and mid-sized businesses. Employers are being requested to submit current, basic wage data on positions within their organizations.
