



Ontario Respiratory Virus Bulletin | 2012-2013

SURVEILLANCE WEEK 11 (March 10, 2013 – March 16, 2013)

This issue of the Ontario Respiratory Virus Bulletin provides information on the surveillance period from March 10, 2013 to March 16, 2013 (Week 11). Unless otherwise specified, **data presented are for week 11** and data extraction and analysis for this issue of the Bulletin occurred on Wednesday, March 20, 2013. In order to enable our readers to better assess influenza and other respiratory virus activity in Ontario, we have combined various sources of information in the following table.

Assessment of Influenza Activity in Ontario

Laboratory confirmed influenza cases	Similar	There were 136 influenza cases reported ¹ in week 11 (Table 1), which was the same as the number (136) reported in week 10. In week 11, 49% of the cases reported were influenza A and 51% were influenza B. Percent positivity ² of laboratory tests for all influenza types in Ontario was 9.3% for week 11 (Table 3), which was similar to the percent positivity in week 10 (9.5%).
Institutional respiratory infection outbreaks	Higher	Seventeen new institutional respiratory infection outbreaks were reported ³ in week 11, including two influenza A outbreaks, two influenza B outbreaks, one enterovirus outbreak, two outbreaks for other organisms and ten outbreaks for which no aetiological agent was reported (Table 4, Figure 5).

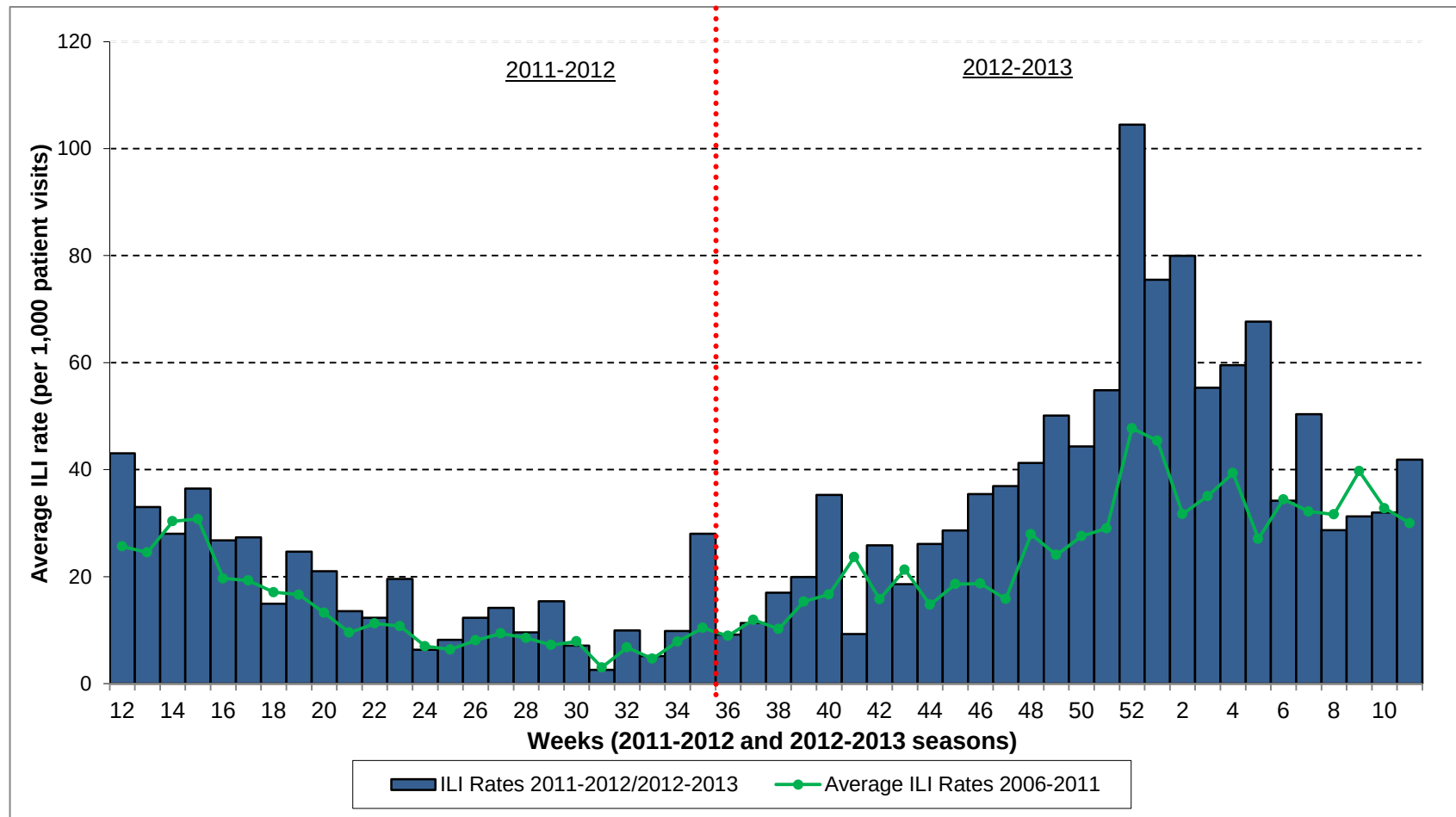
Figure 6. Influenza activity levels by health unit: Ontario, week 11

Influenza activity levels reported by health units	Lower	Toronto reported a 'widespread' level of influenza activity, seven health units reported 'localized' levels of influenza activity, and 20 health units reported 'sporadic' levels of influenza activity (Figure 6).
ILI consultation rate reported by sentinel physicians	Higher	The provincial influenza-like-illness (ILI) consultation rate ⁴ in week 11 (41.85/1,000 patient visits) was higher than the rate in week 10, which was 31.99/1,000 patient visits (Figure 7).
OVERALL ASSESSMENT	Similar	From week 10 to 11, overall the indicators show that influenza activity was similar and is now driven by both influenza A and influenza B.
Measures of severity for influenza		
Hospitalizations among lab confirmed cases of influenza	Lower	There were 58 hospitalized cases reported ¹ in week 11, which was lower than number (83) reported in week 10 (Table 2).
Deaths among lab confirmed cases of influenza	Lower	There were 2 deaths reported ¹ in week 11, which was lower than number (14) reported in week 10 (Table 2).

The number of **reported** cases needs to be interpreted with caution because there is a lag between the onset of illness, hospital admission or death and when this information is reported to public health. 2. Positivity reflects positive specimens reported to Public Health Ontario by the Centre for Immunization and Respiratory Infectious Diseases (CIRID). 3. The number of new outbreaks reported for the current week is based on the onset date of illness for the first case in an outbreak. 4. Summary of current and season-to-date respiratory virus activity

- **Seasonal influenza activity** continues to decline. The proportion of respiratory samples testing positive for influenza is now at 9.3% (with influenza A declining to 5.4% and influenza B increasing to 4.0%), compared to the seasonal peak of 33.4% in the last week of 2012.*
 - The majority of influenza cases this season (95.3%; 8,497/8,918) were influenza A (Table 1). The dominant circulating influenza A subtype is H3N2, representing 92.7% of all subtyped influenza A positive specimens.*
 - In the season to date, 1,038 confirmed institutional respiratory infection outbreaks have been reported, 562 (54.1%) of which were laboratory confirmed as influenza A and 11 (1.1%) of which were laboratory confirmed as influenza B (Table 4).
 - A total of 2,892 hospitalizations and 237 deaths have been reported among lab confirmed influenza cases in the current surveillance season to March 16 (Table 2). The majority of hospitalizations and deaths occurred in influenza A cases (96.0% and 96.6%, respectively).
- The **cause of influenza-like-illness (ILI) activity** in the 2012-2013 surveillance season is changing as the season progresses.
 - At the beginning of the season, entero/rhinovirus was the causative organism identified in most institutional respiratory infection outbreaks. Subsequently, influenza A became the most common causative organism of institutional outbreaks. However, the overall number of newly reported influenza A outbreaks has since declined (Table 4, Figure 5).
 - For the season to date, influenza A has had the highest percent positivity overall, followed by respiratory syncytial virus (Table 3).*
- Among all **circulating respiratory viruses in week 11** (Table 3):
 - Respiratory syncytial virus had the highest percent positivity (14.9%), which decreased from the previous week (18.7%).*
 - Human metapneumovirus had the second highest percent positivity (7.0%), and had a similar positivity compared to the previous week (7.1%).*

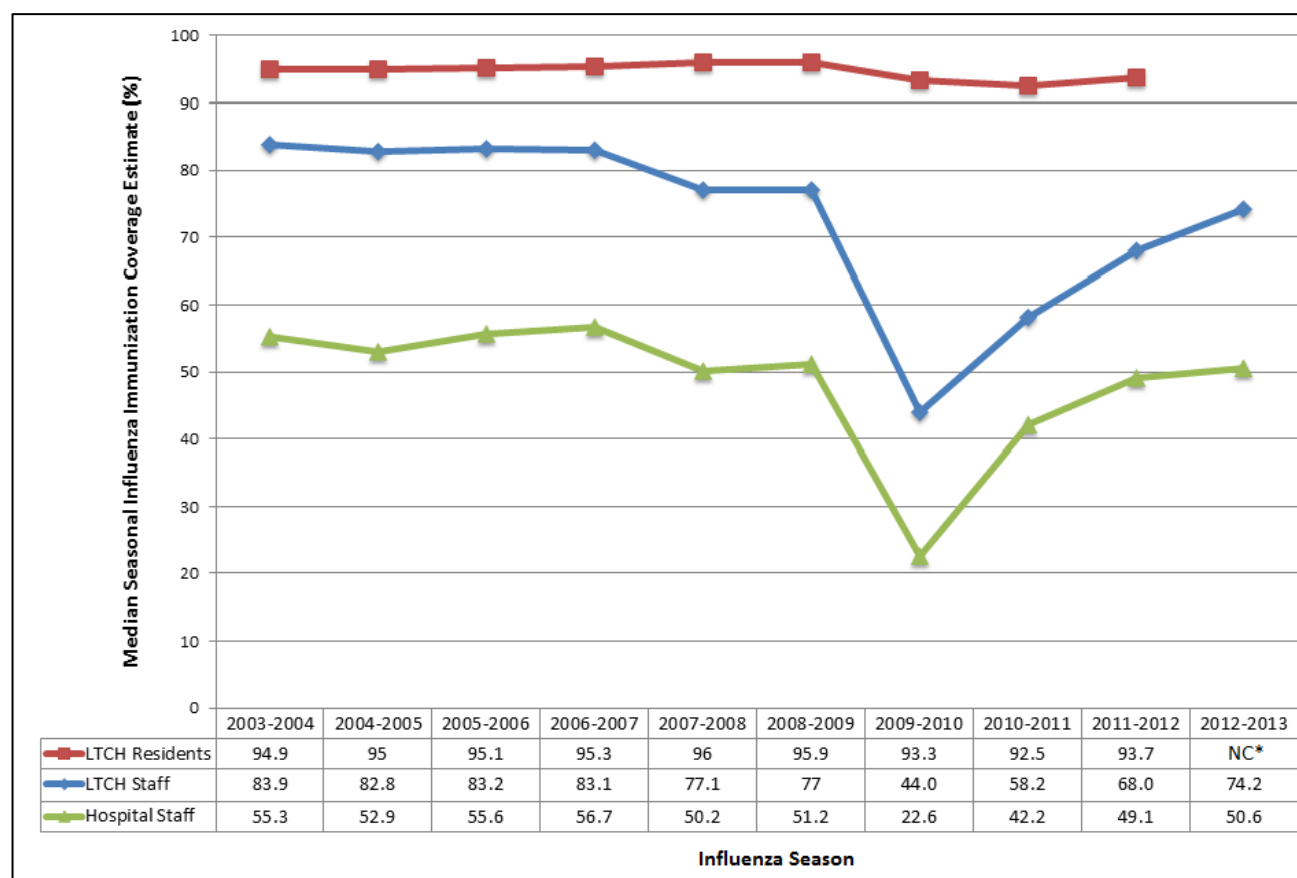

Median influenza immunization coverage rates among hospital and long-term care staff, 2012-2013 influenza season, Ontario

As per the Ontario *Influenza Prevention and Surveillance Protocol for Long-Term Care Facilities* (1999) and the *Influenza Surveillance Protocol for Ontario Hospitals* (2012), seasonal immunization coverage rates for staff of long term care homes (LTCH) and public hospitals are reportable to the local Medical Officer of Health. For the 2012-2013 season, institutions were asked to report their institutional coverage rates as of December 15, 2012. This information was then reported to the Ministry of Health and Long-Term Care by January 15, 2013. Figure A below outlines trends in reported influenza immunization coverage rates for the seasonal influenza vaccine up to the 2012-2013 surveillance season.

Figure A. Median influenza immunization coverage rates among long-term care staff and residents and hospital staff: Ontario, 2003-2004 to 2012-2013 seasons

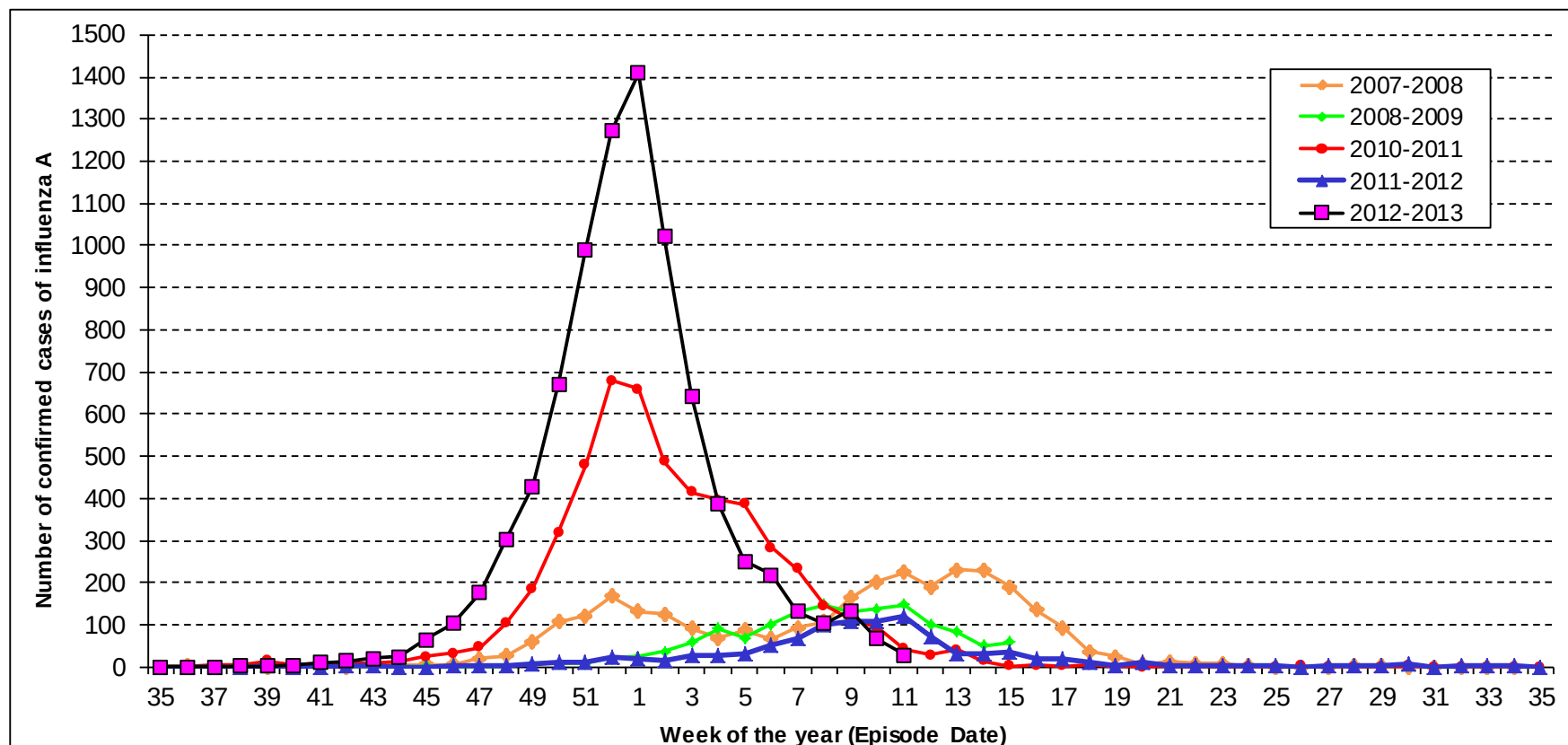

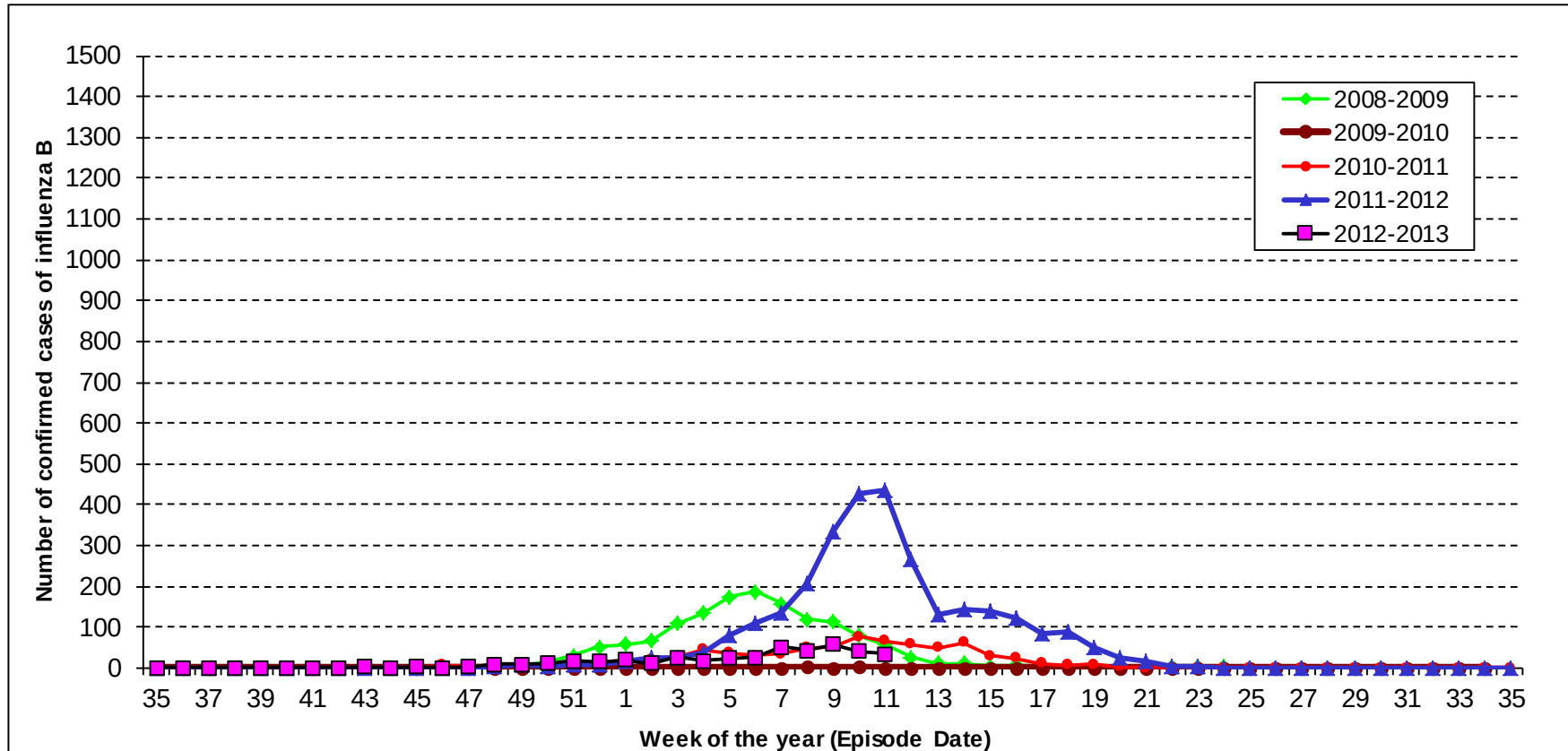

Cases after week 14 in the 2008-2009 season were excluded because seasonal influenza cases from this period may have been detected due to heightened surveillance for all influenza-like illness, therefore this period is not comparable to a regular influenza season. Additionally, all cases from the 2009-2010 influenza season were excluded from this graph due to its incomparability to a regular influenza season as a result of the influenza A(H1N1)pdm09 pandemic.

Week 53 of the 2008-2009 season has been removed for continuity in displaying trends.

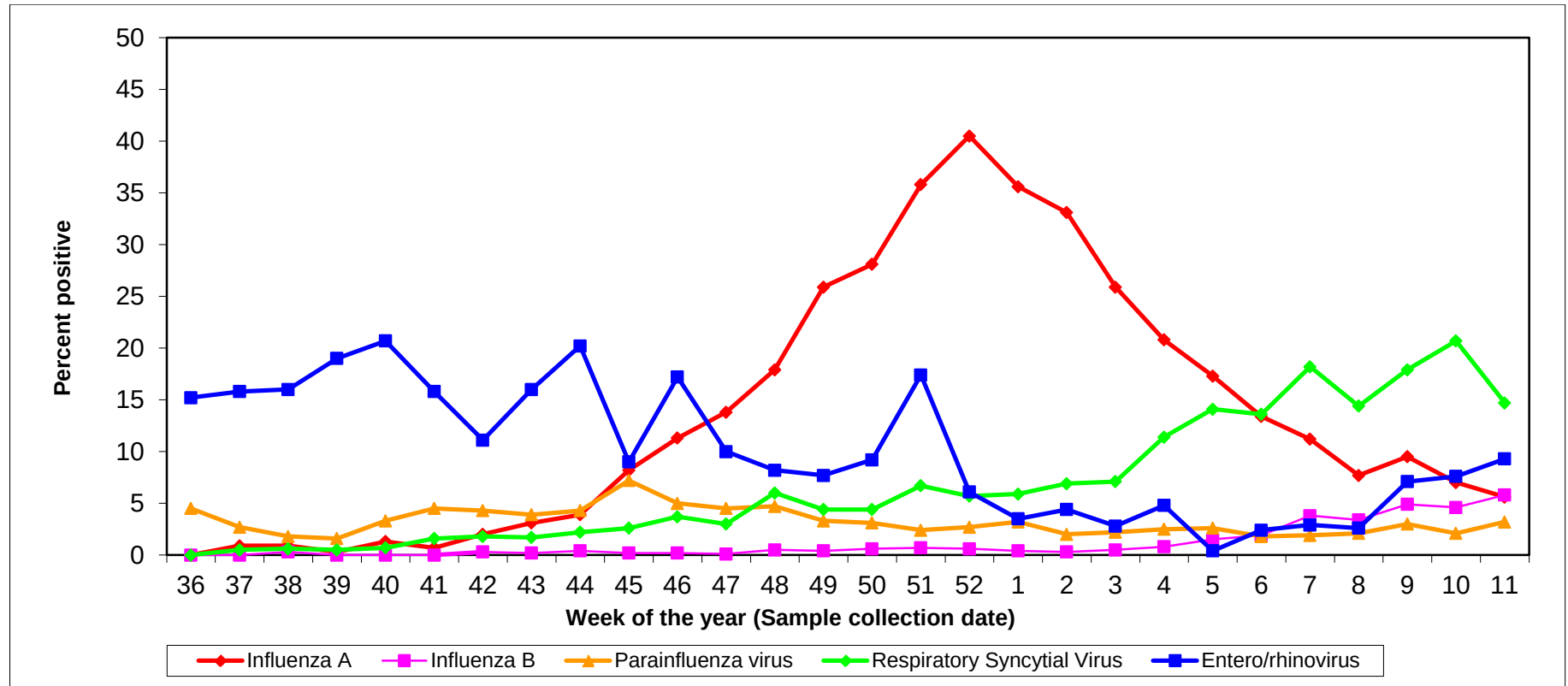

Note:

The numbers of hospitalizations and deaths provided in iPHIS need to be interpreted with caution because there are lags between the onset of illness, hospital admission or death, and when this information is reported to public health. Due to increased influenza activity over the prior few weeks, there may be additional delays in the reporting of hospitalizations and deaths beyond the usually expected reporting time lag.

Deaths in any influenza case are included; death attribution is not considered. In addition, the numbers of hospitalizations and deaths reported in iPHIS are believed to be an underestimation of the true experience in the Ontario population for many reasons, including underreporting of confirmed cases by physicians to local public health units, and ill persons not seeking medical care and therefore not getting tested.

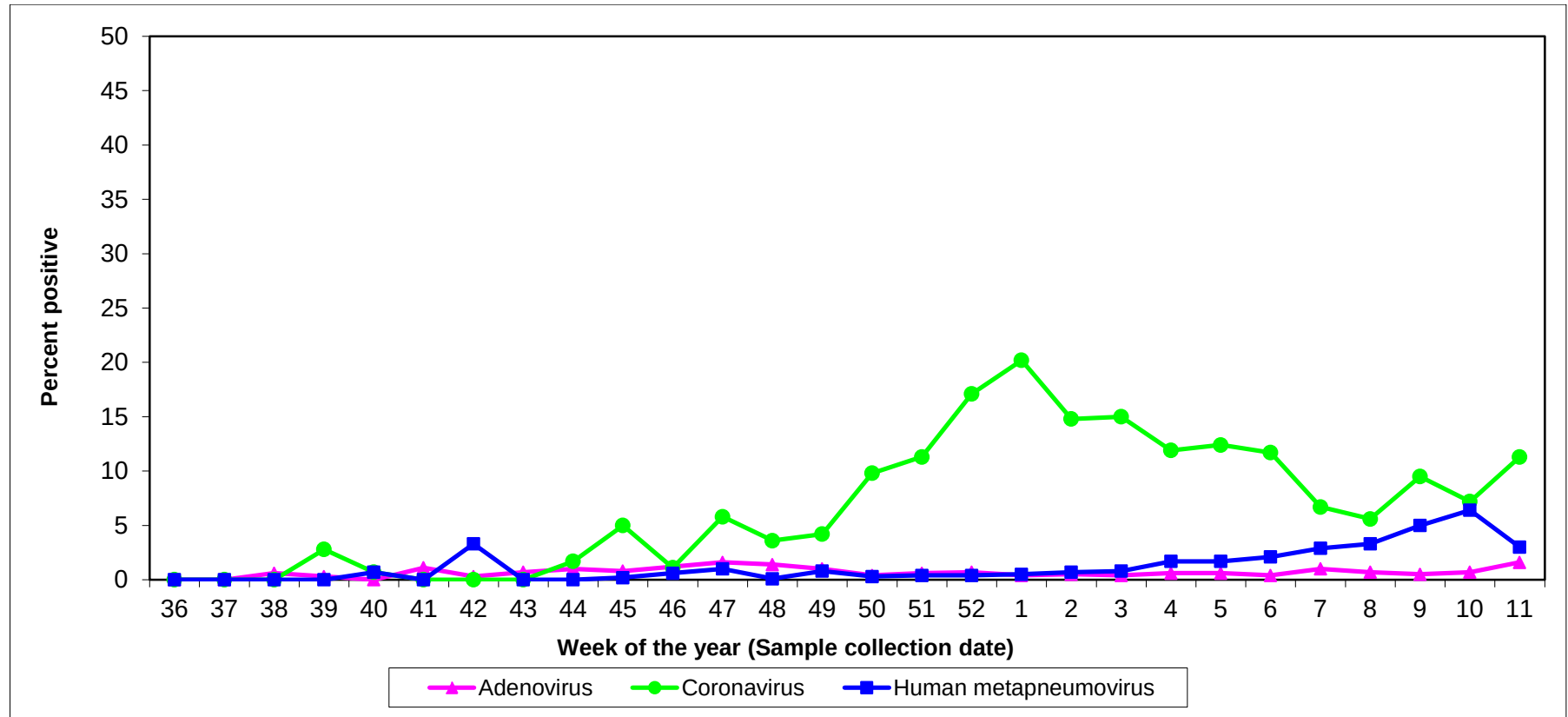

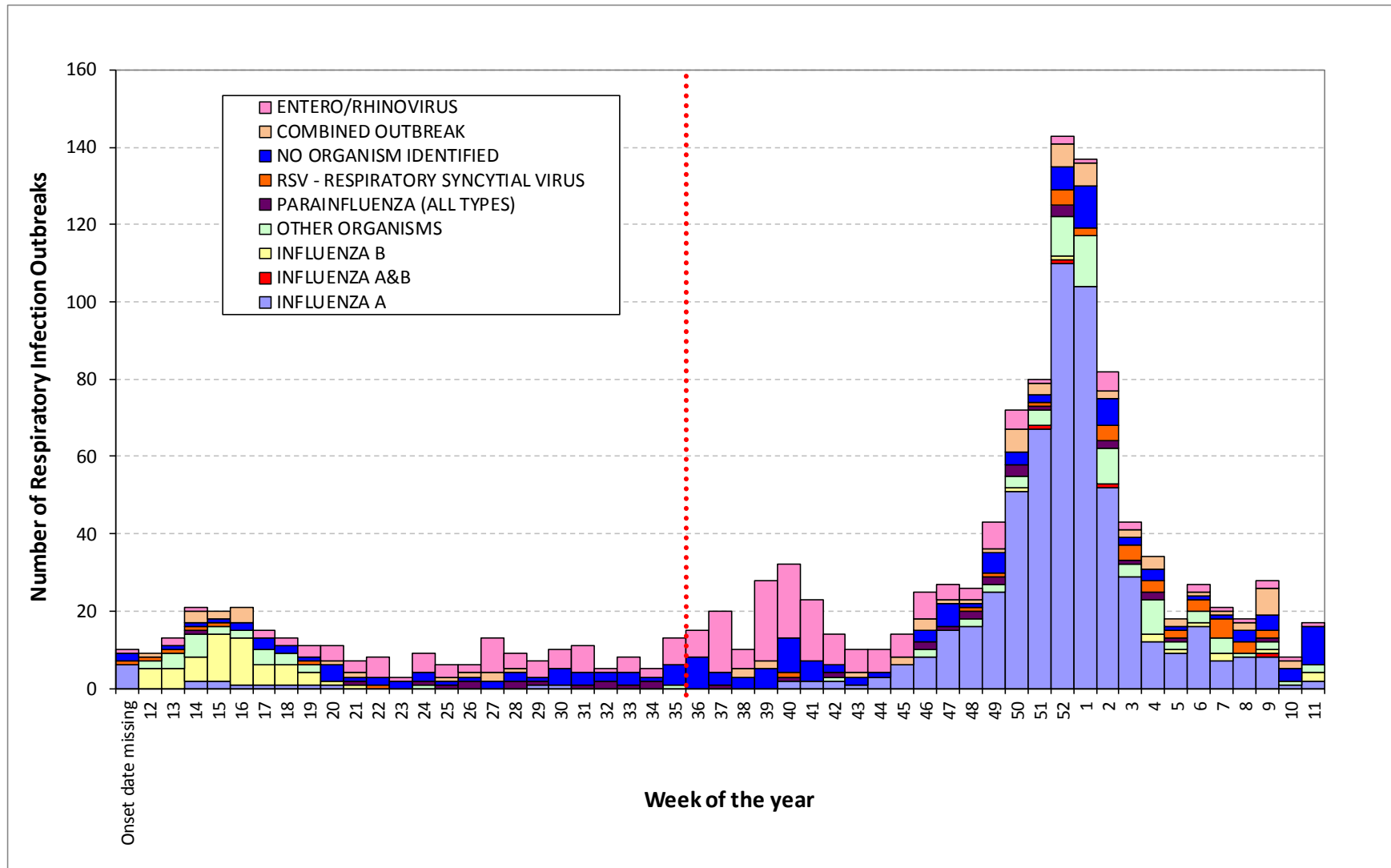

Combined outbreaks include outbreaks in which more than one non-influenza organism has been identified (e.g. RSV, parainfluenza, rhinovirus, etc.).

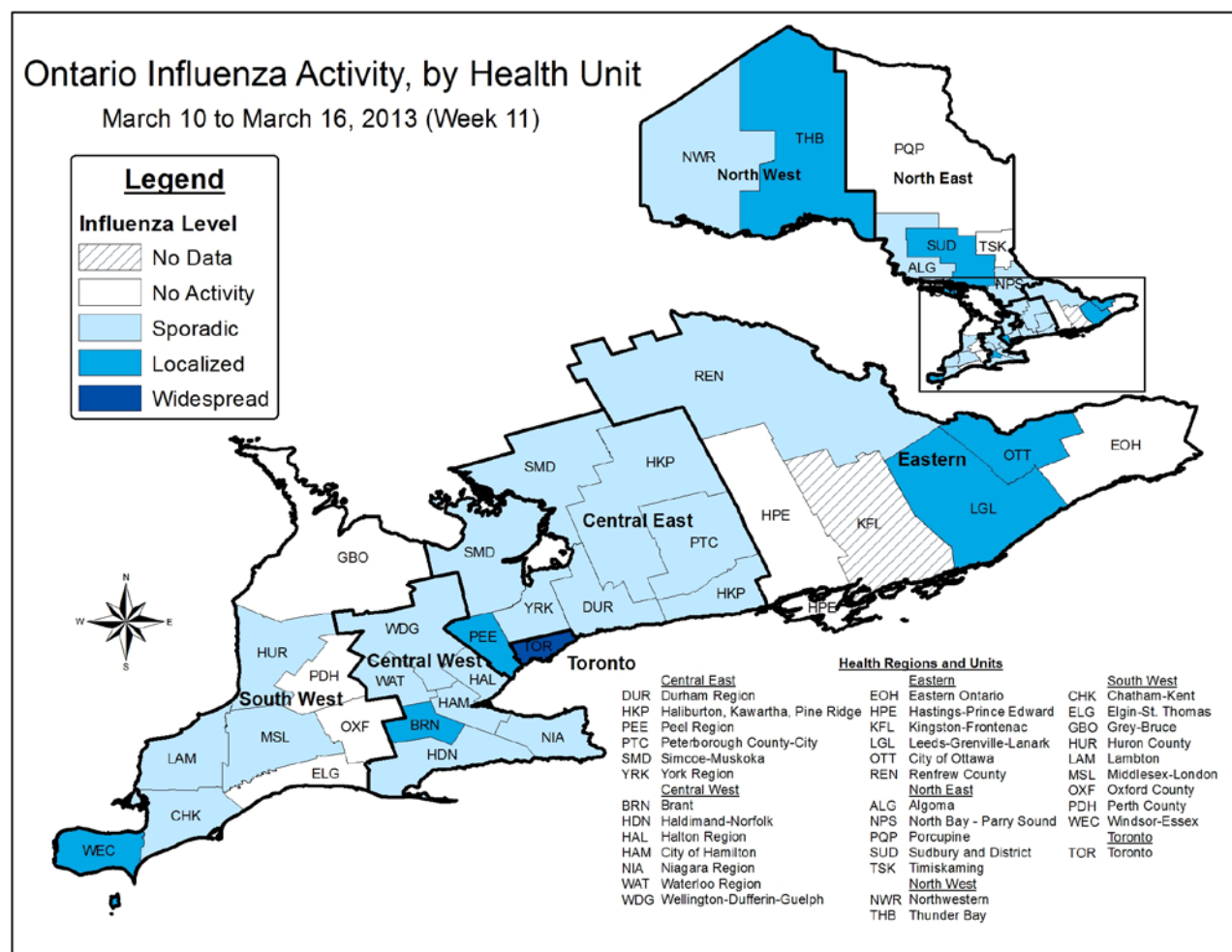
Other organisms include outbreaks involving other aetiological agents, such as human metapneumovirus, adenovirus, and coronavirus.

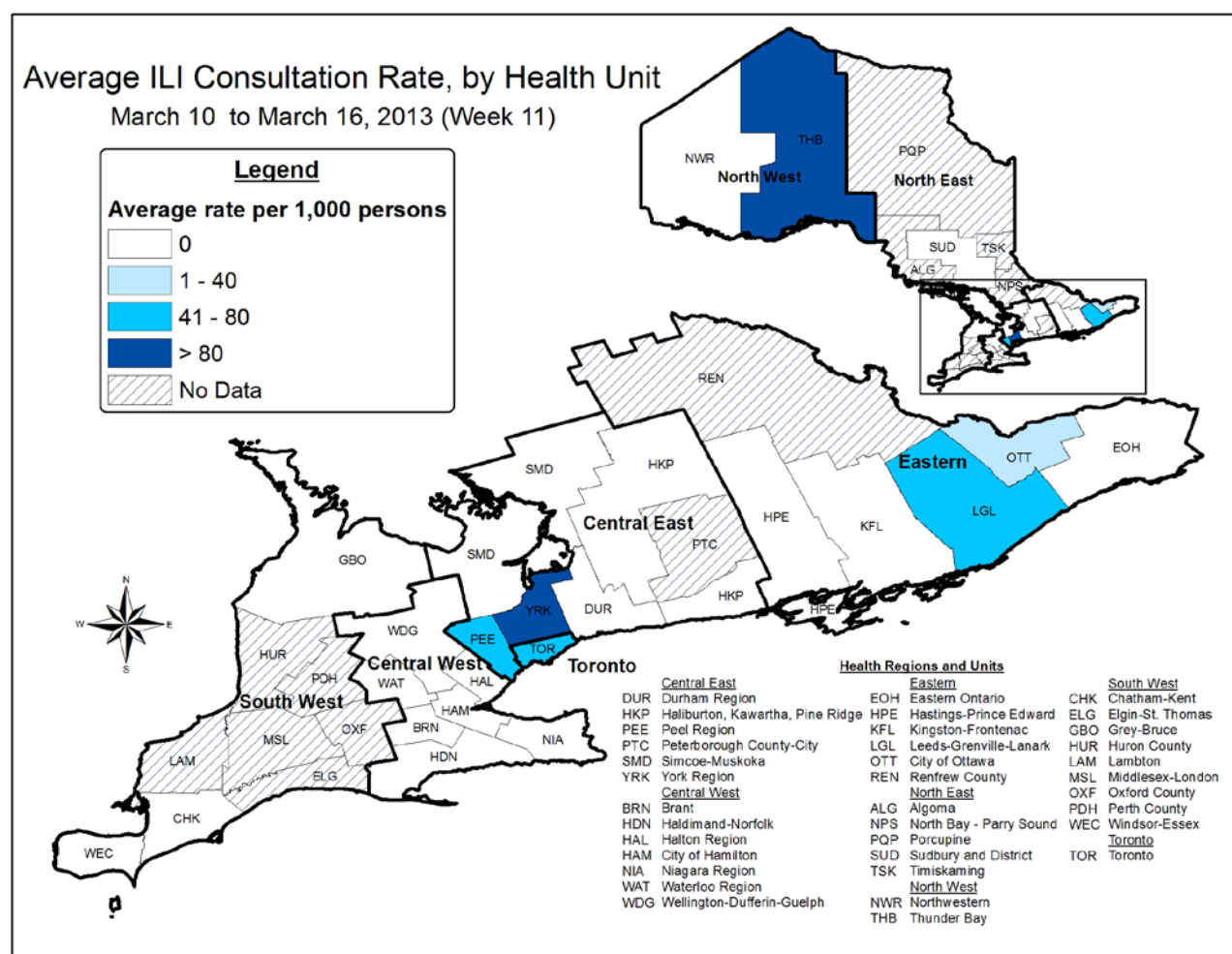

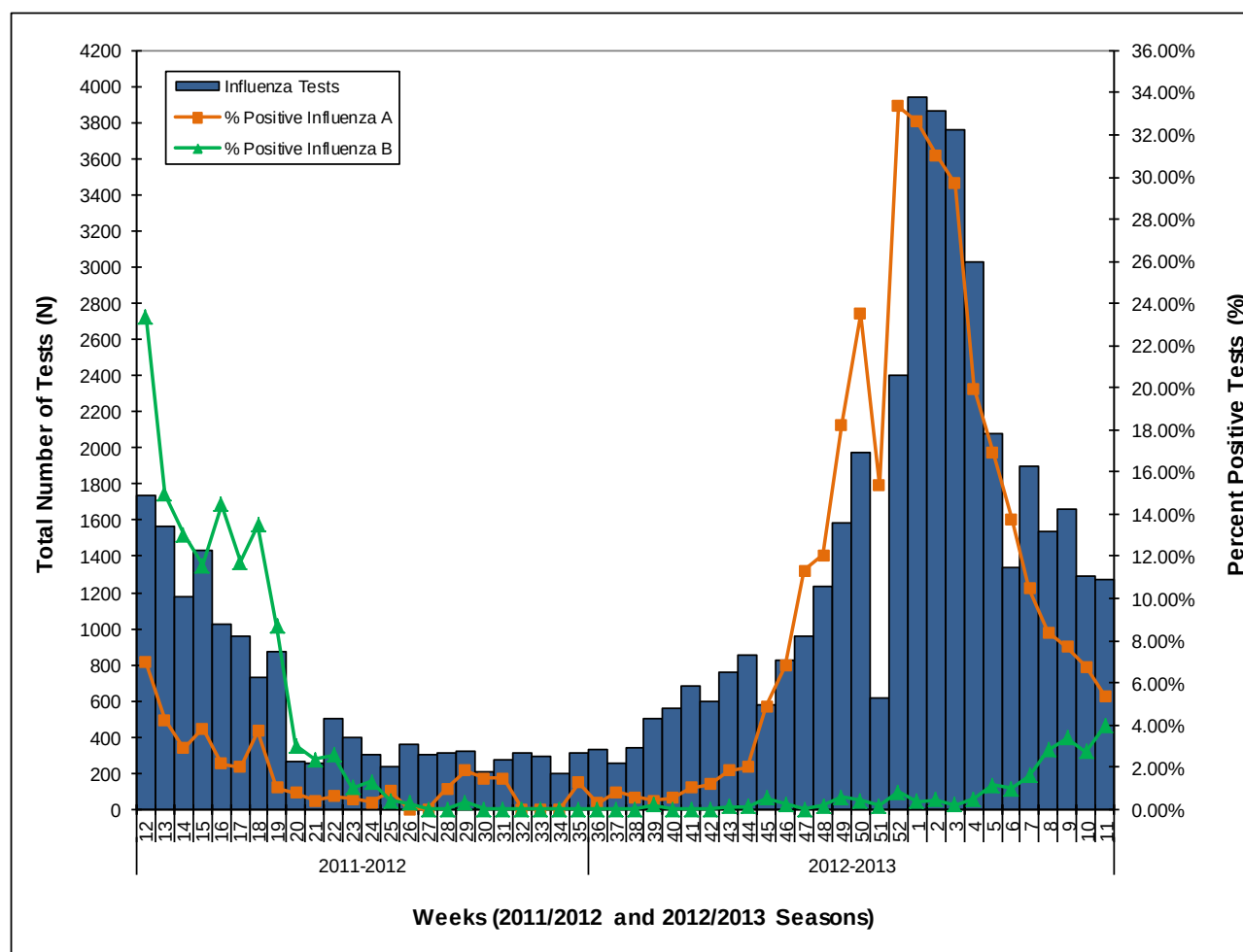
