“certificate of appointment of estate trustee” means letters probate, letters of administration or letters of administration with the will annexed, and includes a small estate certificate or amended small estate certificate (74.13, 74.13.1, 74.20, 74.20.3, 74.23, 74.23.1, 74.26, 74.31, 74.1C or 74.1F); (“certificat de nomination à titre de fiduciaire de la succession”)

(2) The definition of “judge” in subrule 1.03 (1) of the Regulation is amended by adding “but does not include an associate judge” at the end.

(b) an application for a certificate of appointment of estate trustee (Form 74.4, 74.4.1, 74.5, 74.5.1, 74.14, 74.15, 74.21, 74.24, 74.27 or 74.30), small estate certificate (Form 74.1A) or amended small estate certificate (Form 74.1E).
