#### ADOPTION OF OSC RULE 52-503

##### EXEMPTION FROM DISCLOSURE OF A SPECIFIED FINANCIAL MEASURE

On October 3, 2023, the following rule will come into force under the *Securities Act*:

- OSC Rule 52-503 *Exemption from Disclosure of a Specified Financial Measure*

OSC Rule 52-503 provides an exemption in Ontario from National Instrument 52-112 *Non-GAAP and Other Financial Measures Disclosure* for a reporting issuer that is, or that has a subsidiary or an affiliate, that is a “federal financial institution” as defined by the *Bank Act* (Canada) and subject to OFSI Guidelines.

#### AMENDMENTS TO NATIONAL INSTRUMENT 14-101 DEFINITIONS AND CONSEQUENTIAL AMENDMENTS

On September 13, 2023, the following came into force under the *Securities Act*:

- amendments to National Instrument 14-101 *Definitions* (NI 14-101); and
- consequential amendments to the following rules:
  - National Instrument 31-103 *Registration Requirements, Exemptions and Ongoing Registrant Obligations*;

- National Instrument 33-109 *Registration Information*;
- National Instrument 45-106 *Prospectus Exemptions*;
- National Instrument 62-103 *The Early Warning System and Related Take-Over Bid and Insider Reporting Issues*;
- National Instrument 81-102 *Investment Funds*;
- National Instrument 94-102 *Derivatives: Customer Clearing and Protection of Customer Collateral and Positions*;
- Ontario Securities Commission Rule 14-501 *Definitions*; and
- Ontario Securities Commission Rule 45-501 *Ontario Prospectus and Registration Exemptions* (collectively, the **Amendments**).

In connection with the Amendments, the Ontario Securities Commission also adopted changes (the **Policy Changes**) to Companion Policy 52-107CP *Acceptable Accounting Principles and Auditing Standards*. The Policy Changes came into effect on September 13, 2023.

The Amendments and Policy Changes provide for changes to the definitions of “Canadian financial institution” and “Handbook” within NI 14-101 and across all relevant national and local rules and policy, in which these terms, or similar iterations, are used.

(5) A licensee of a long-term care home is not required to comply with the requirements set out in this section until July 1, 2024, as long as the person hired as a personal support worker or to provide personal support services, in the reasonable opinion of the licensee, has the adequate skills, training and knowledge to perform the duties required of that position.

(6) A licensee shall cease to employ a person to whom subsection (5) applies if the person does not meet the applicable requirements under the Act and this Regulation on or before August 1, 2024.

(7) A licensee shall keep records of all persons to whom subsection (5) applies and provide statistical information respecting the situation to the Director monthly or upon request.

(8) The records required by subsection (7) must include at a minimum the number of persons working in the home to whom subsection (5) applies and their position.

**2. Section 388 of the Regulation is revoked.****Commencement**

**3. (1) Except as otherwise provided in this section, this Regulation comes into force on the day it is filed.**

**(2) Section 1 comes into force on the later of October 11, 2023 and the day this Regulation is filed.**

**(3) Section 2 comes into force on the later of November 11, 2023 and the day this Regulation is filed.**
