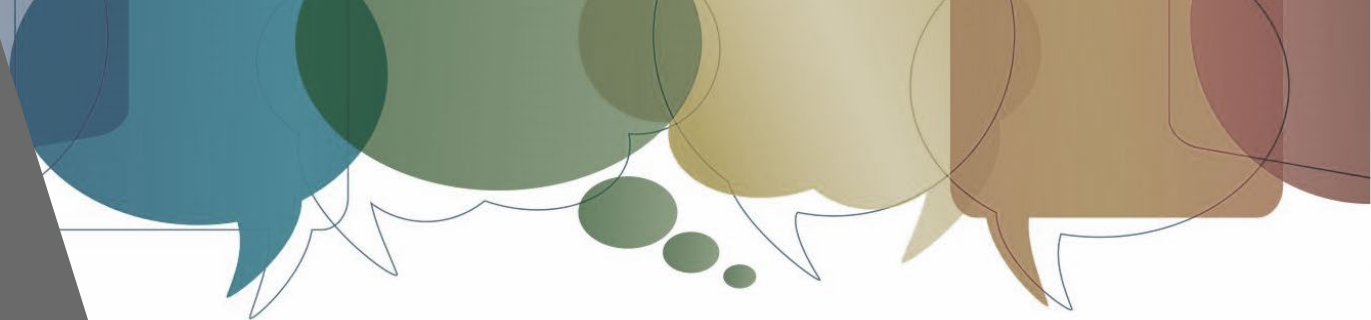

PULSE REPORT ON COVID-19 – REPORT #102

KEY FINDINGS

Key Findings

1

'Right track' scores remained steady and are at 58% this week.

3

That said, seven-in-ten (72%) Ontarians feel that the government is prepared to handle a fourth wave of infections if a COVID-19 variant spreads rapidly.

And, just over half (55%) of Ontarians continue to believe the government is 'doing what is required' to reduce the spread of the virus. The proportion of Ontarians who think the government is 'not doing as much as they should' is steady at 25% (a drop of 12-points since early September).

Rating of the government's performance for 'effectively managing vaccinations', 'keeping people safe during the COVID-19 situation' and 'delivering quality healthcare' also remained steady this week.

There appears to be an easing of concern about the pandemic, with a 9-point decline over the past two weeks to 63% Ontarians now expressing concern about a fourth wave of the pandemic. This compares to 57% in mid-July. And, this week, there was an increase to 64% of Ontarians that agree that we are over the worst of COVID-19, the highest percentage since mid-July.

However, while 85% of Ontarians over 18 years of age report they have been fully vaccinated, only about half (54%) presently agree they are confident that the end of COVID-19 is nearer now that vaccines are being administered. Connected to this, Ontarians continue to believe unvaccinated individuals are the most responsible for the increase in infections.

On the economic front, the government's performance rating for 'managing the re-opening of the economy' and 'building the provincial economy' continued to increase this week. There was also an increase measured for 'improving Ontario's finances'.

Of note, there was a 10-point improvement in the ratings of the government's performance for 'making life more affordable' this week.

In terms of the government's focus, there was a slight decline in the proportion of Ontarians who think the government's focus in the coming months should be on economic issues (down 3-points to 44%) and an increase in those who think a health and economic focus are equally important (up 3-points to 14%).

Key Findings

5 The rating of the government's performance for 'ensuring excellent public education' remained unchanged this week after declining 6-points over the past two weeks.

With increasing numbers of COVID-19 infections being reported in schools, this is a metric to watch closely.

6 Ontarians tend to be uncertain if there are any groups who are paid less than minimum wage in Ontario. About half (48%) of Ontarians believe there are not any groups who are paid less than minimum wage in the province, while almost one-in-five (17%) are not sure.

However, a majority of Ontarians hold the point of view that it is unfair to treat students under 18 (76%) and servers of alcohol (79%) differently and they should be paid the minimum wage.

And, six-in-ten (62%) Ontarians are of the view that it is important to ensure minimum wage workers are paid more. However, 29% believe the minimum wage should not be increased to \$15 as it may harm businesses that are still recovering from the impact of COVID-19.

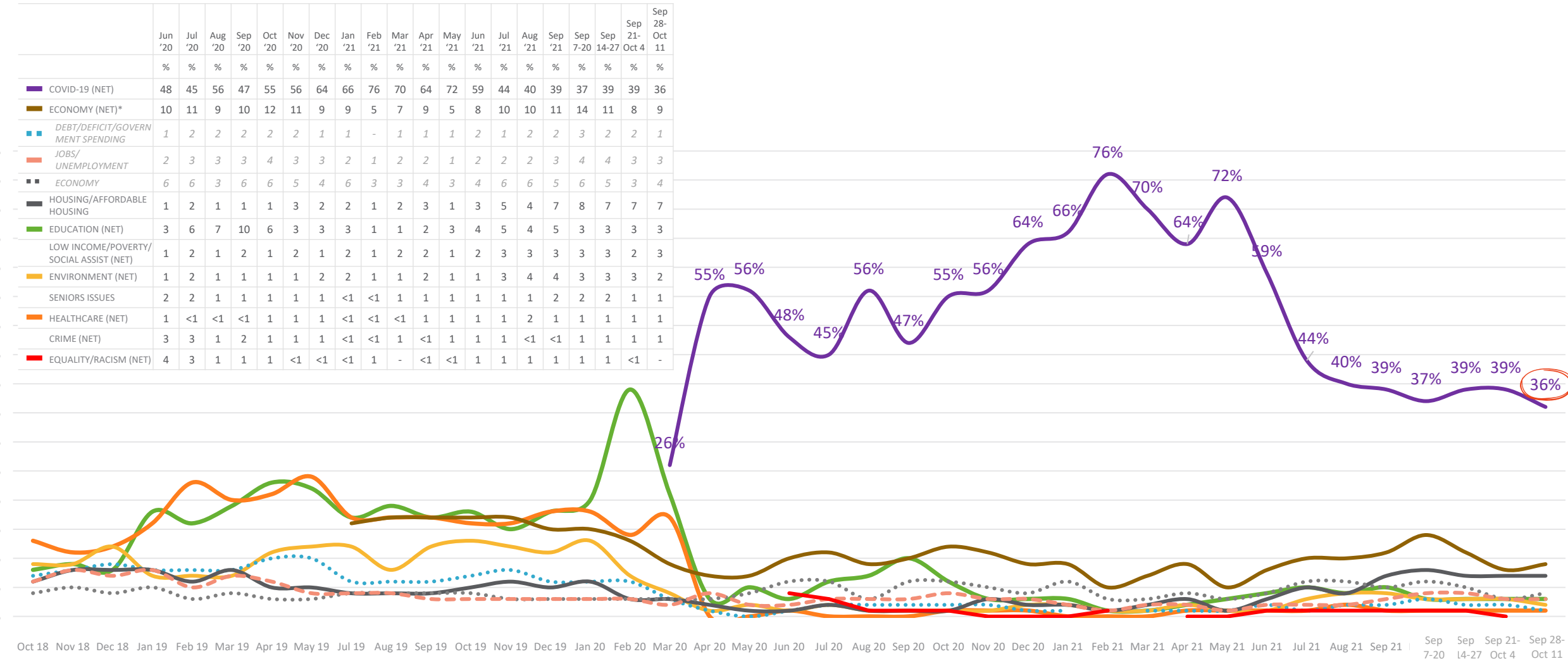
These results are not surprising given that most Ontarians are inclined to want minimum wages increased knowing that these hikes would not directly affect them.

There was a slight decline this week to 36% of Ontarians who believe that COVID-19 should remain the government’s top priority, while 9% cite the economy and 7% affordable housing.



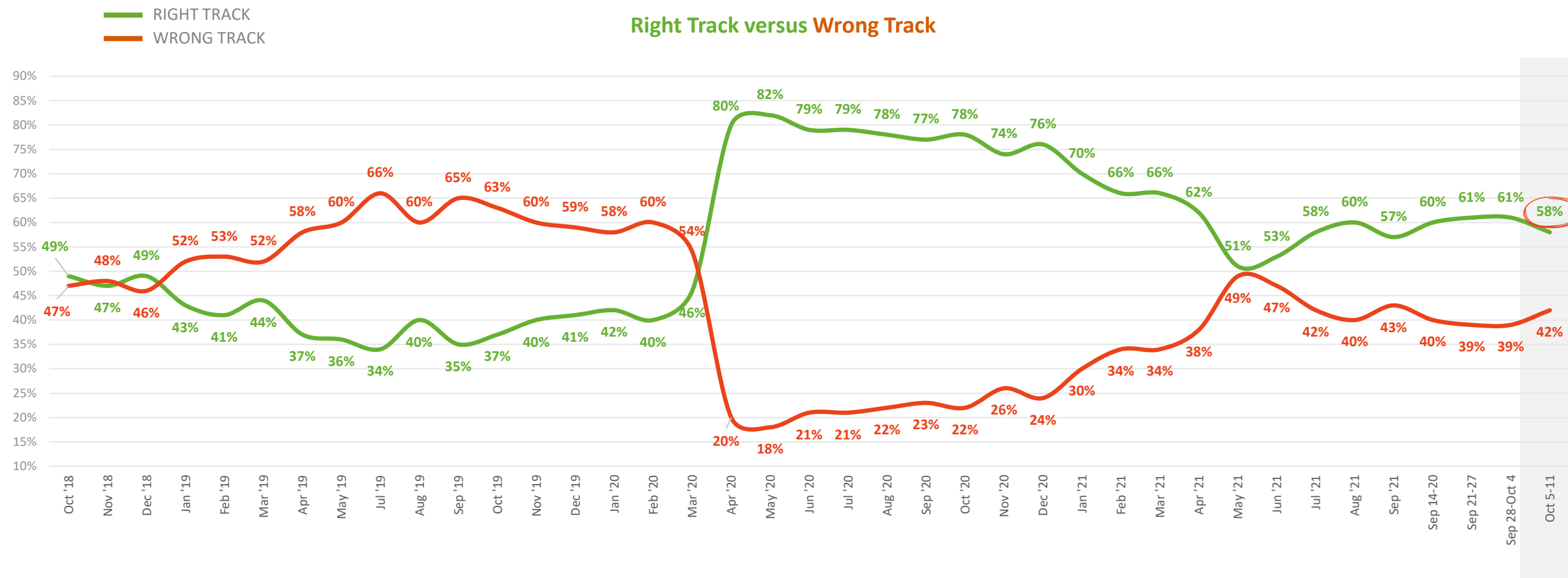

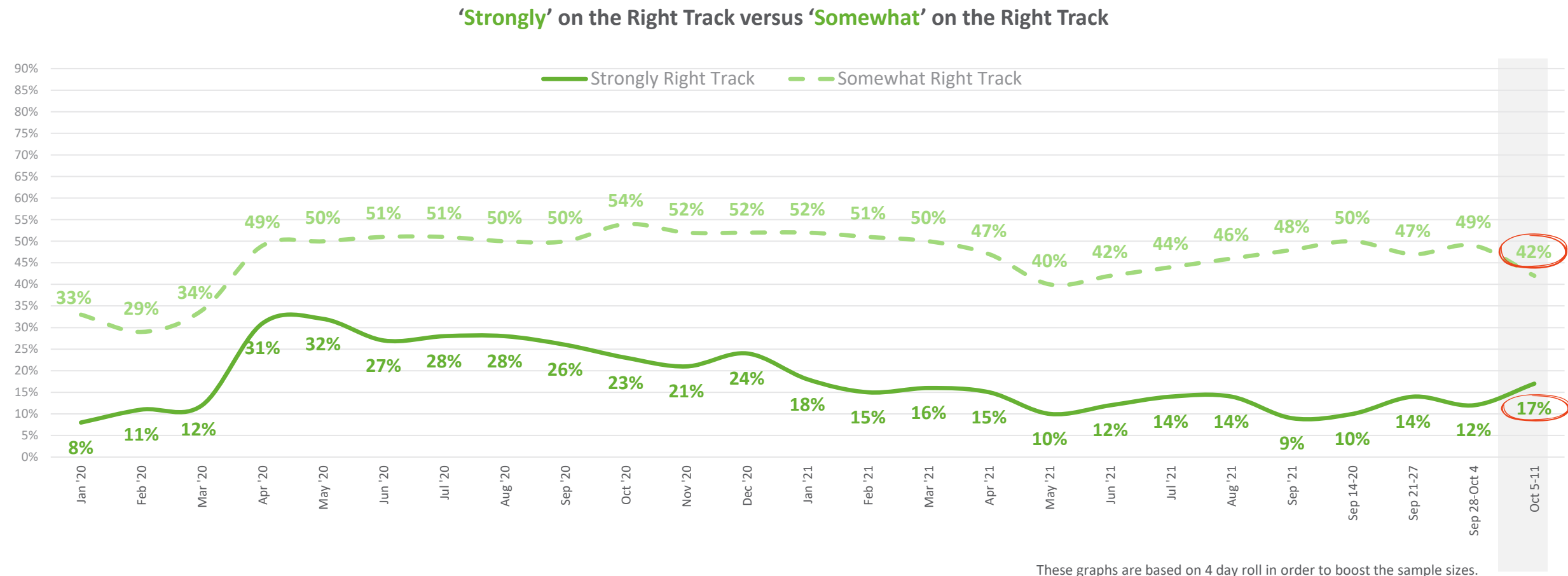

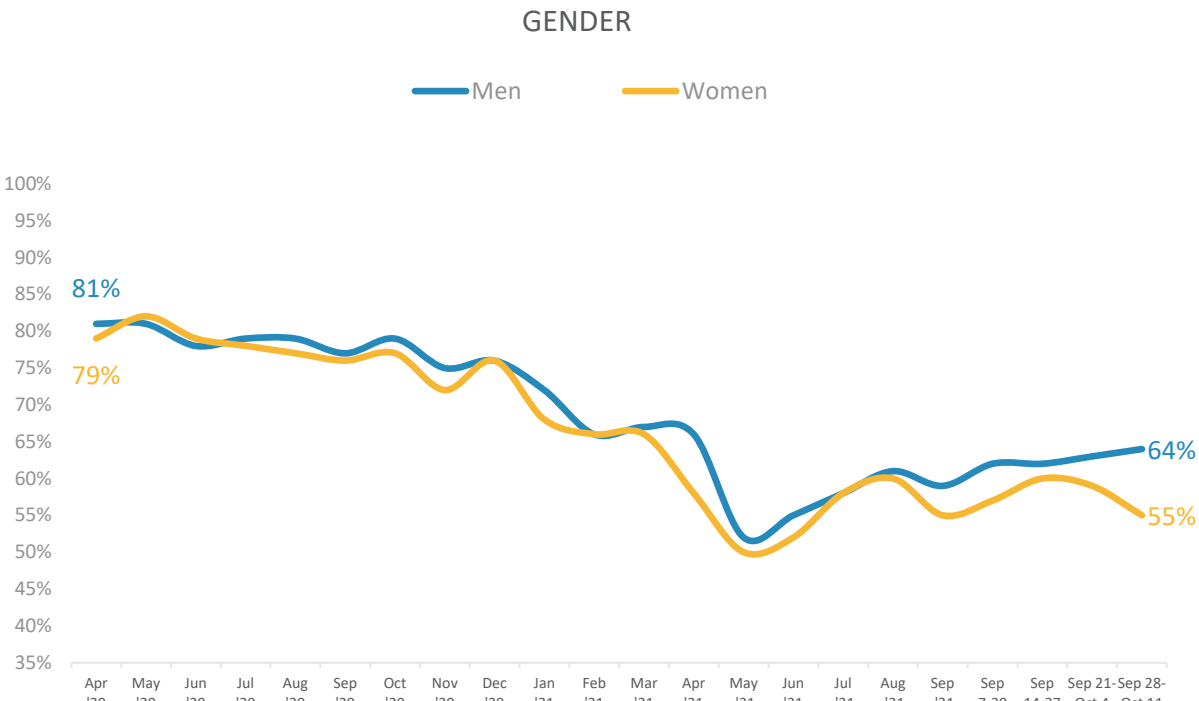
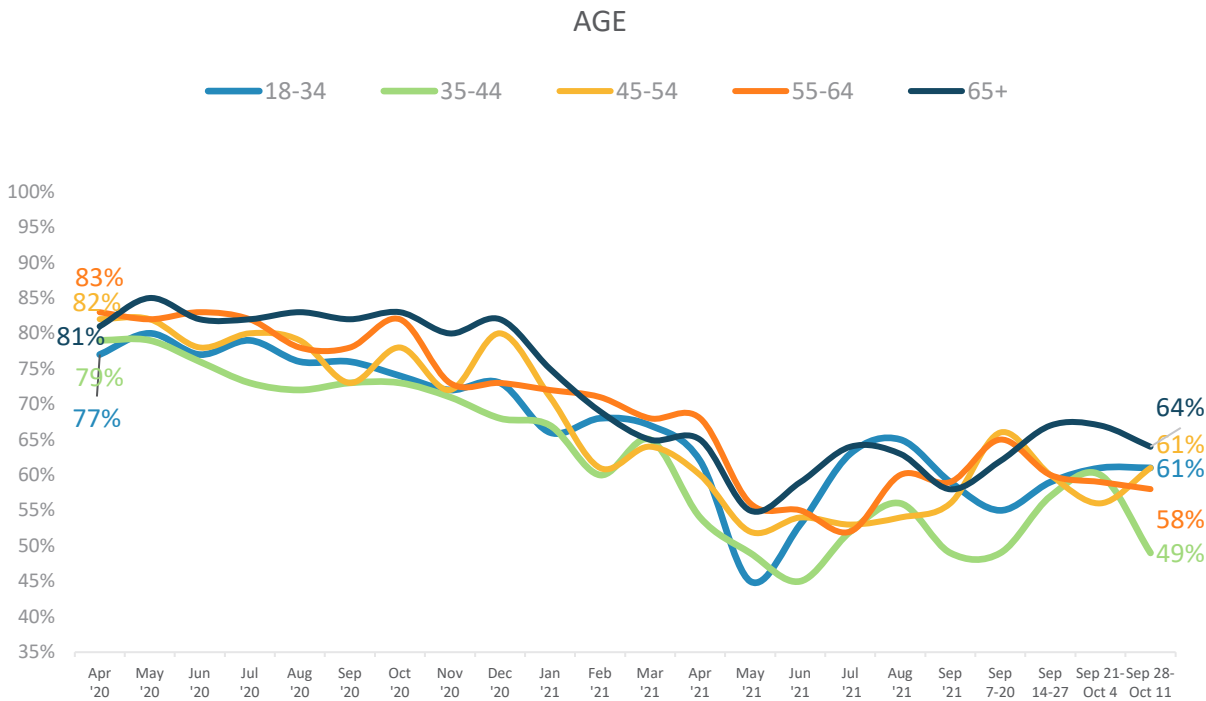
After remaining relatively steady for the past few months, there was an uptick this week for ‘strongly on the right track’ while ‘somewhat on the right track’ scores experienced a decline.

‘Right track’ scores declined this week among Ontarians aged 65+ and 35-44 (with this age group now lagging the others by 9-points or more), while there was a slight uptick among those 45-54 years of age. And, while steady among men, ‘right track’ scores declined among women resulting in a 9-point gap this week.

Right Track Scores – 12-Day Roll

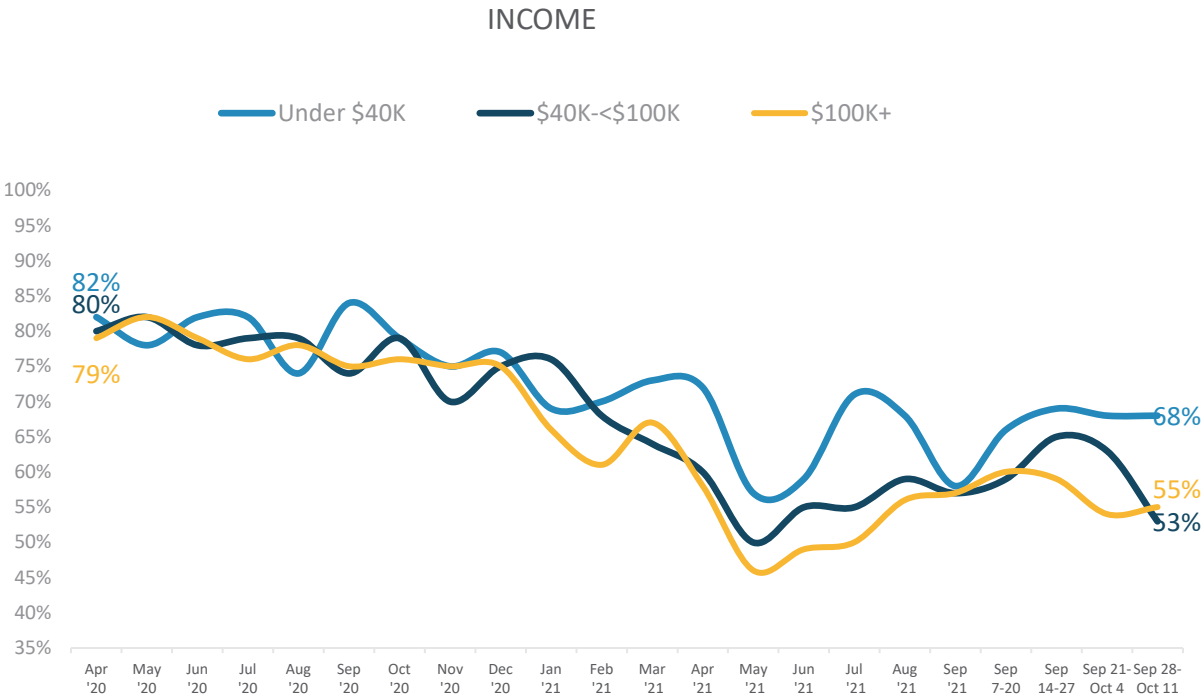
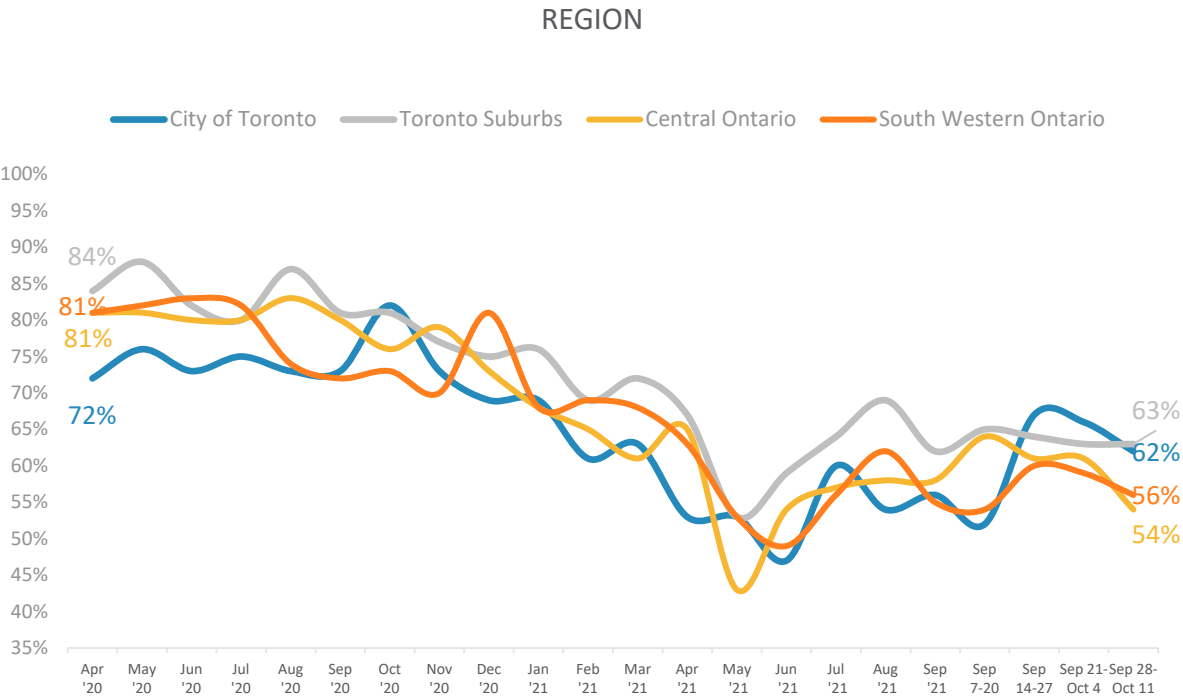

‘Right track’ scores remained steady in the Toronto suburbs, however there were declines in the other three regions this week. By income, ‘right track’ scores declined among Ontarians making \$40k-<\$100k, while results remained steady for the other income brackets.

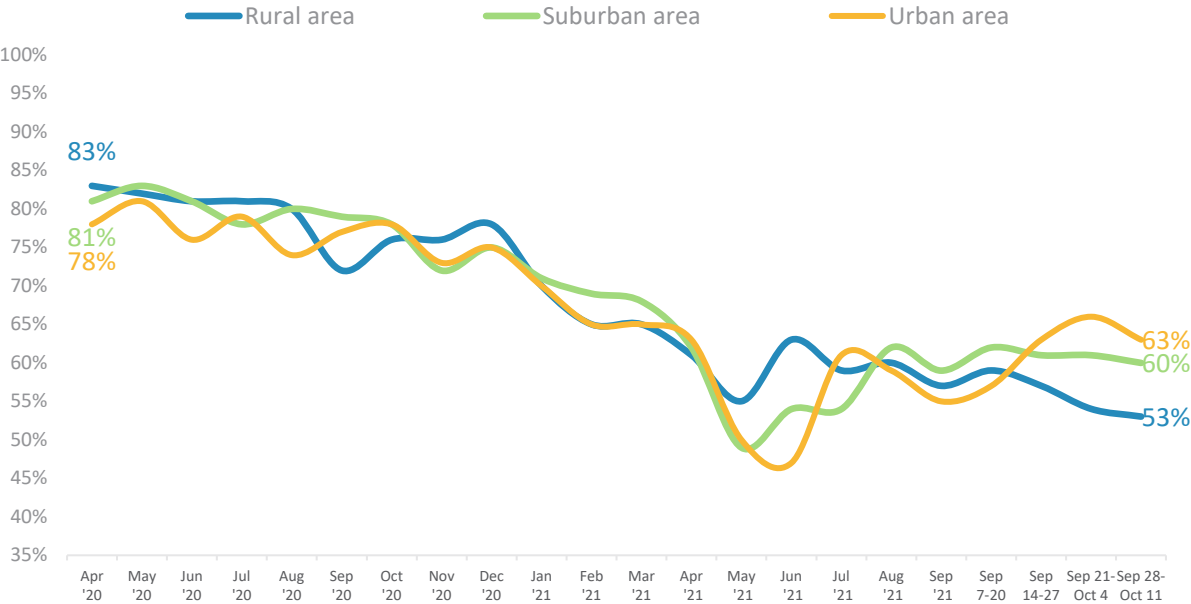

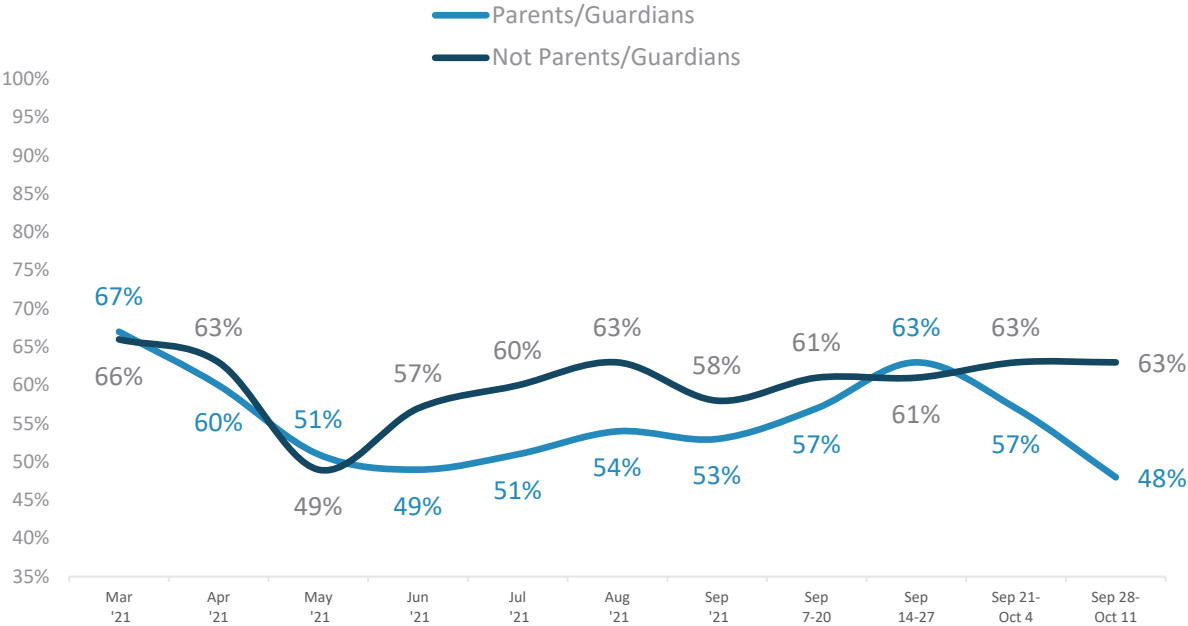
‘Right track’ scores in urban areas declined slightly this week (but remain the highest) while scores in suburban and rural areas remained steady.

PARENTS/GUARDIAN JK-G12 VS NOT PARENTS/GUARDIANS



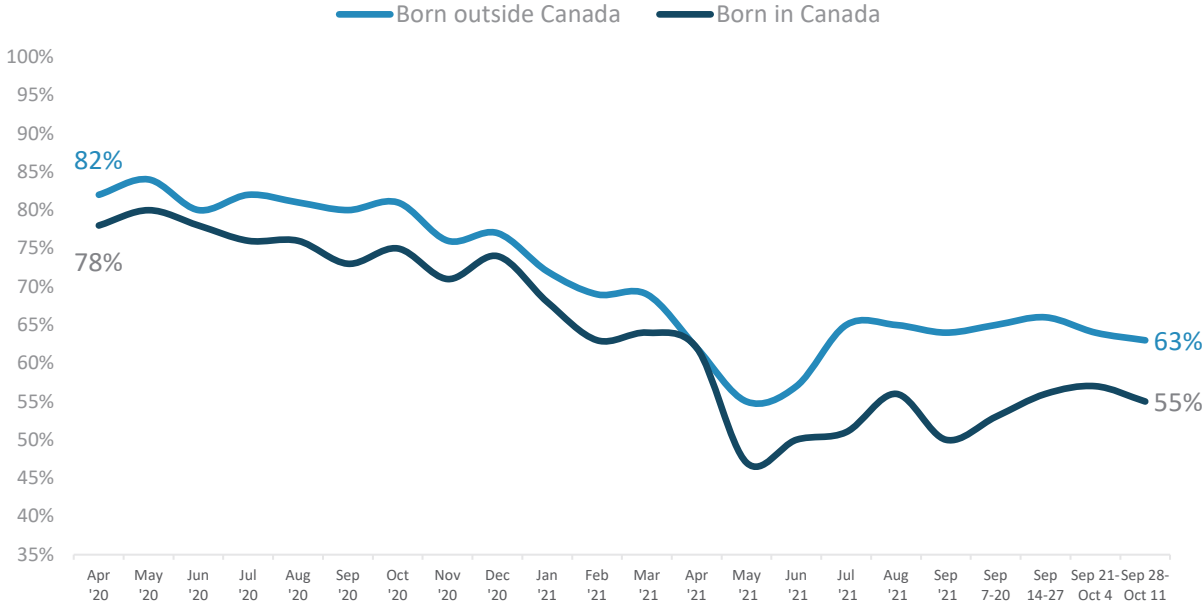

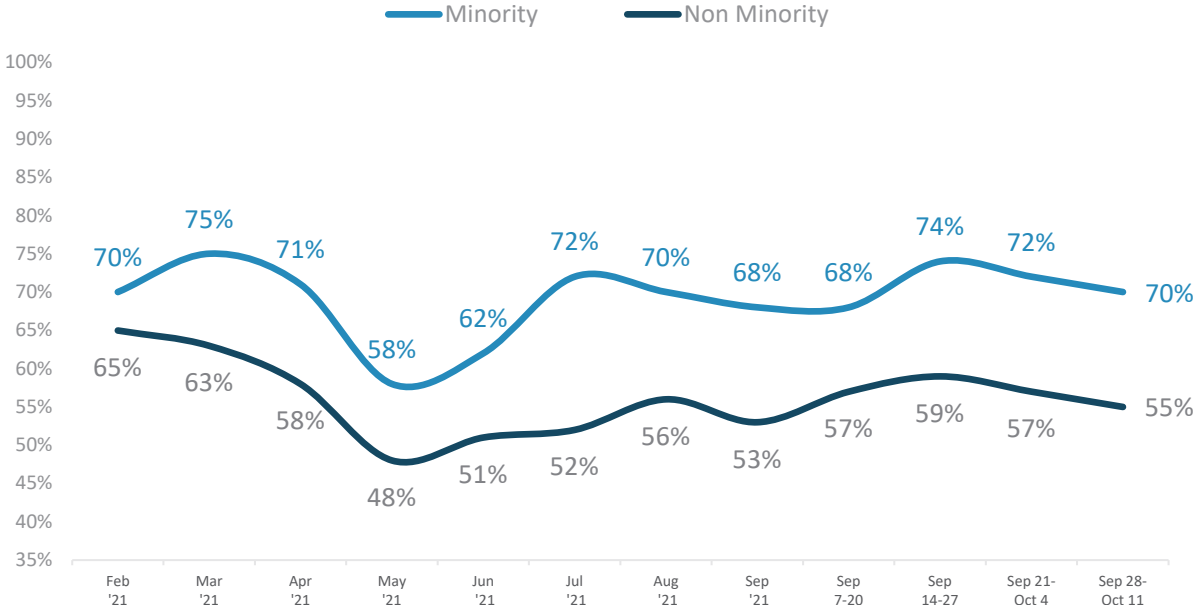

MINORITY VS NON MINORITY

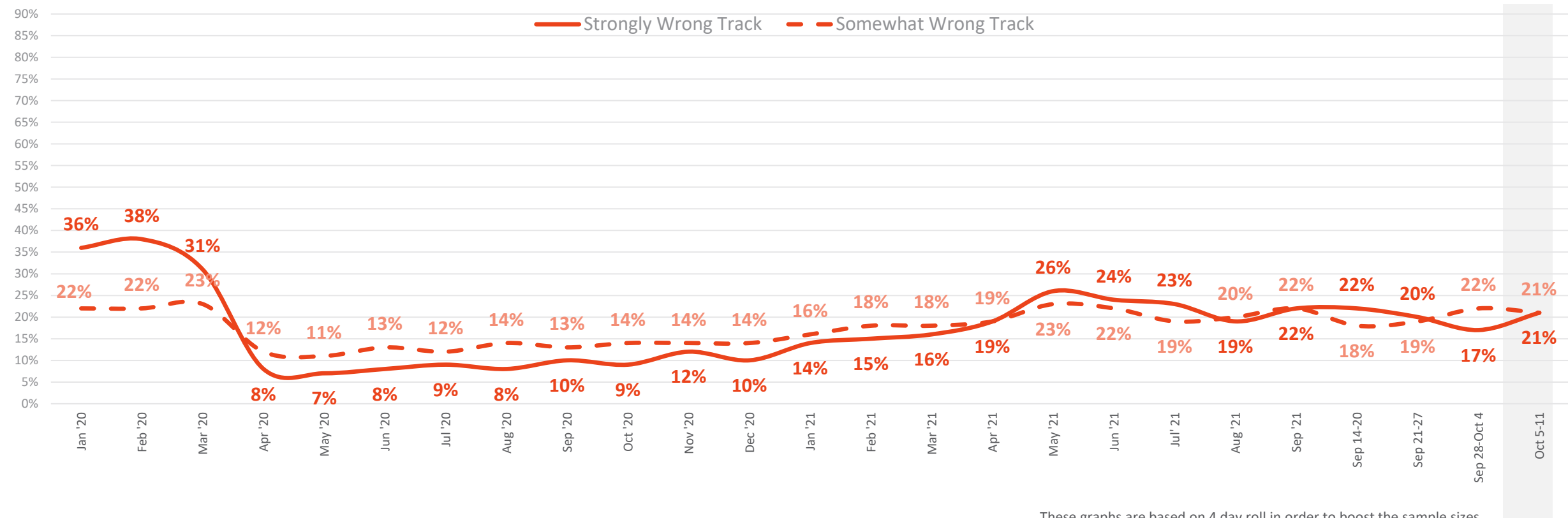

‘Strongly’ on the Wrong Track versus ‘Somewhat’ on the Wrong Track

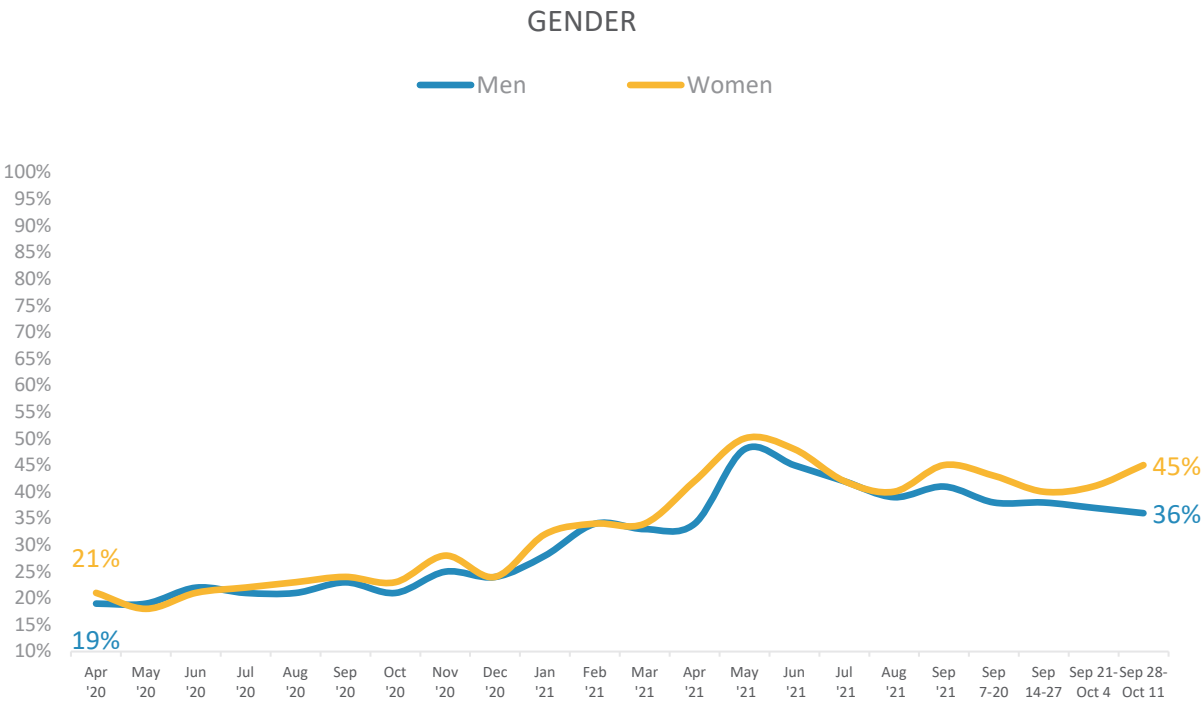
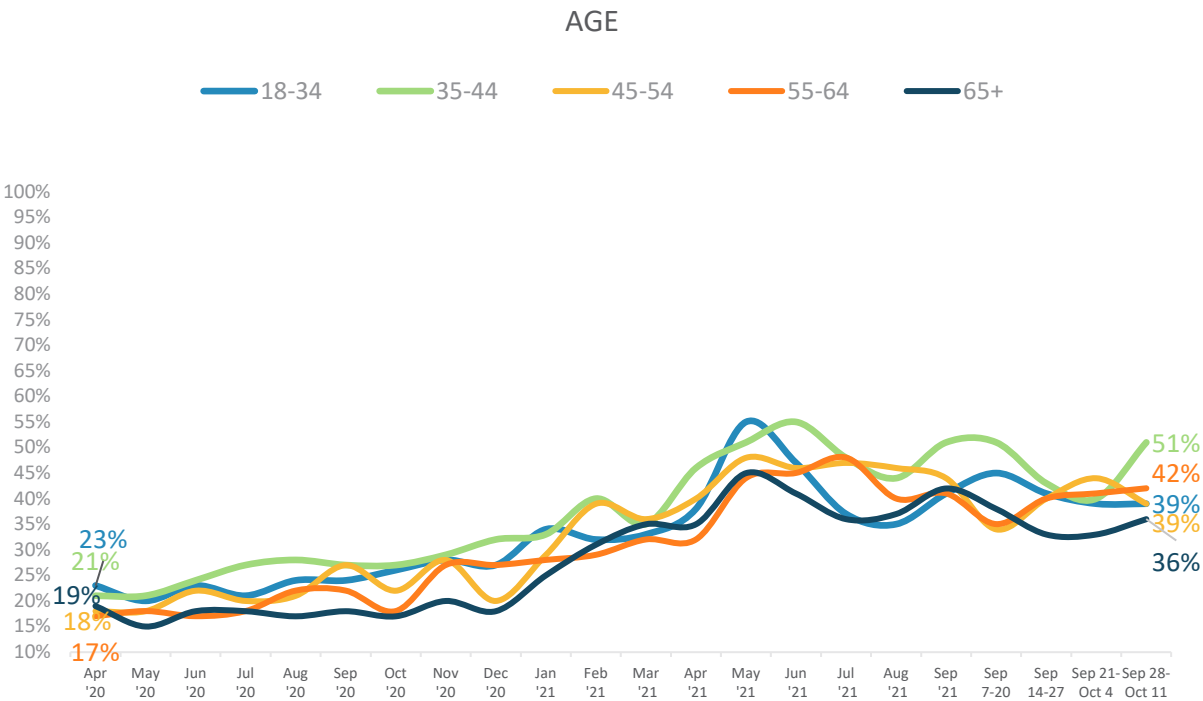

‘Wrong track’ scores increased this week among Ontarians aged 65+ and 35-44 (with this age group now 9-points or more higher than the others), while there was a slight decline among those 45-54 years of age. Women continue to have higher ‘wrong track’ scores than men with the gap increasing to 9-points this week.

Wrong Track Scores – 12-Day Roll

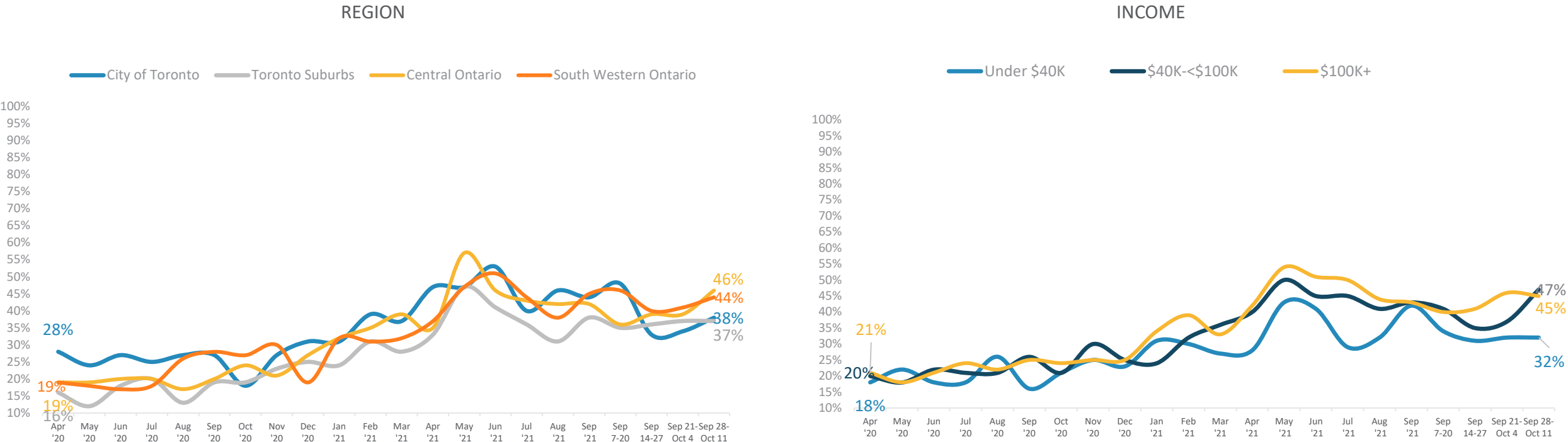

Wrong Track Scores – 12-Day Roll



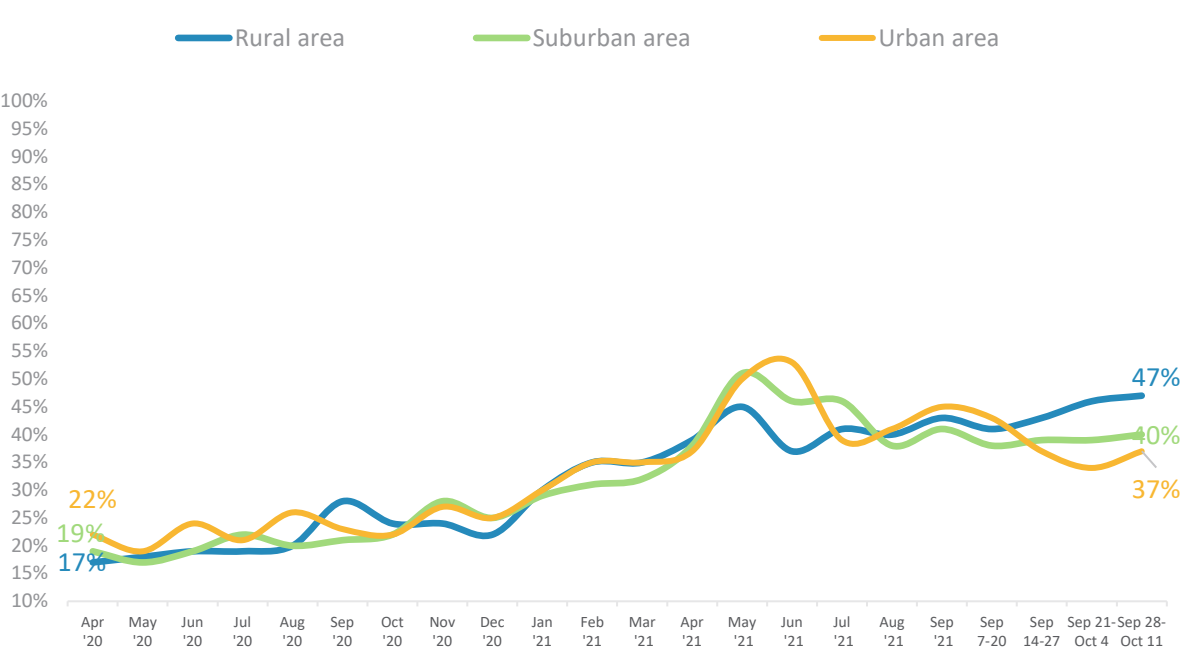

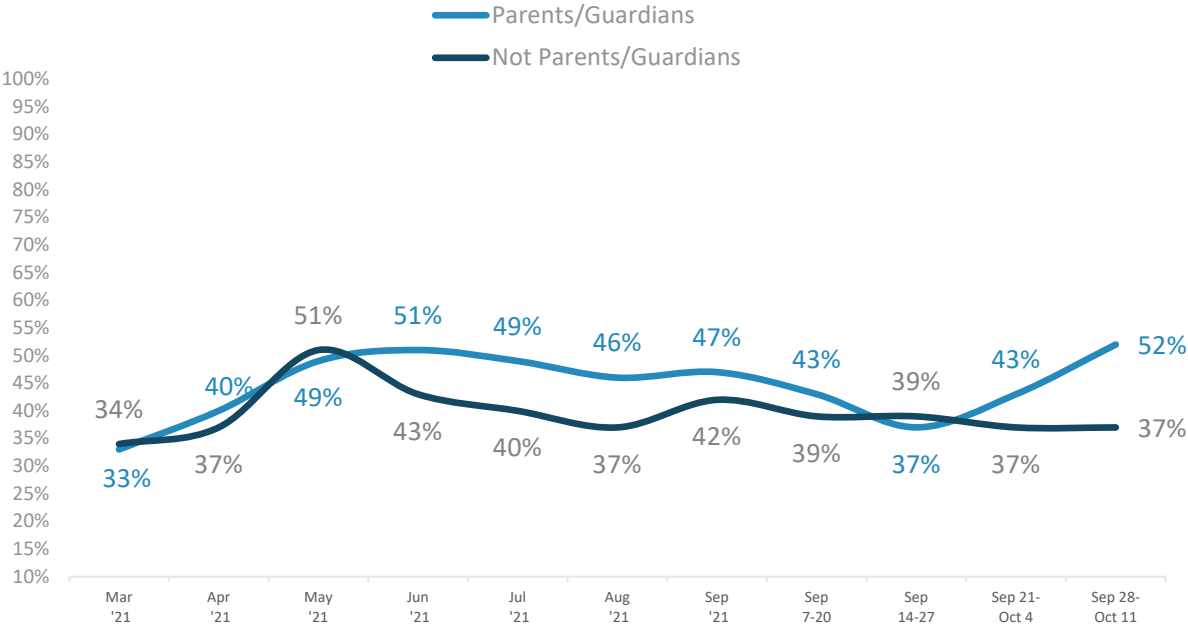

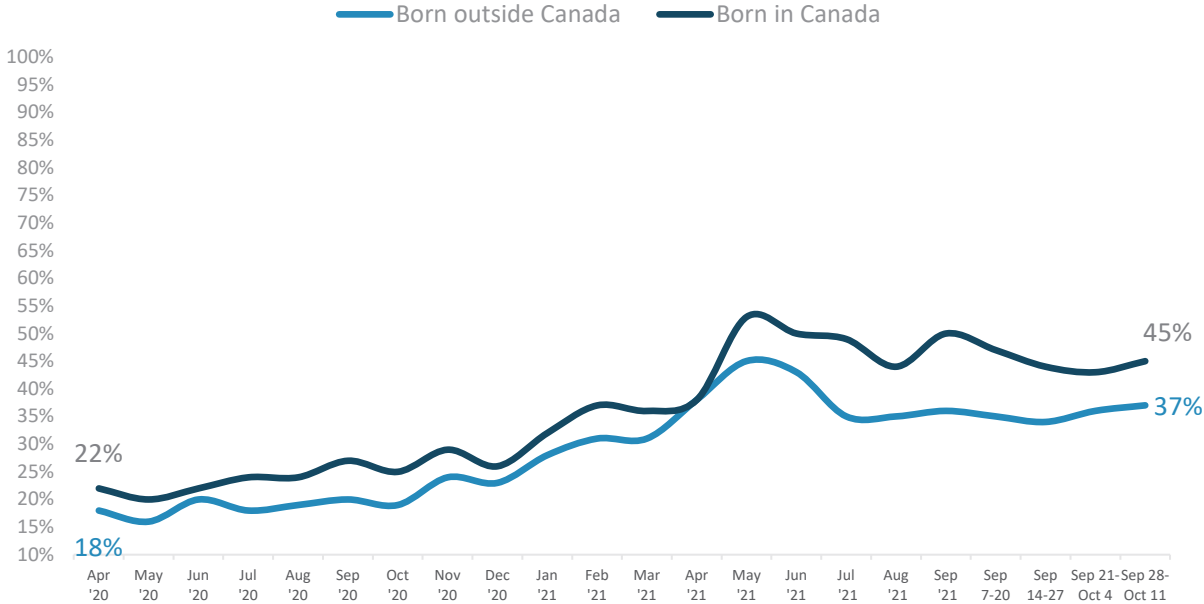

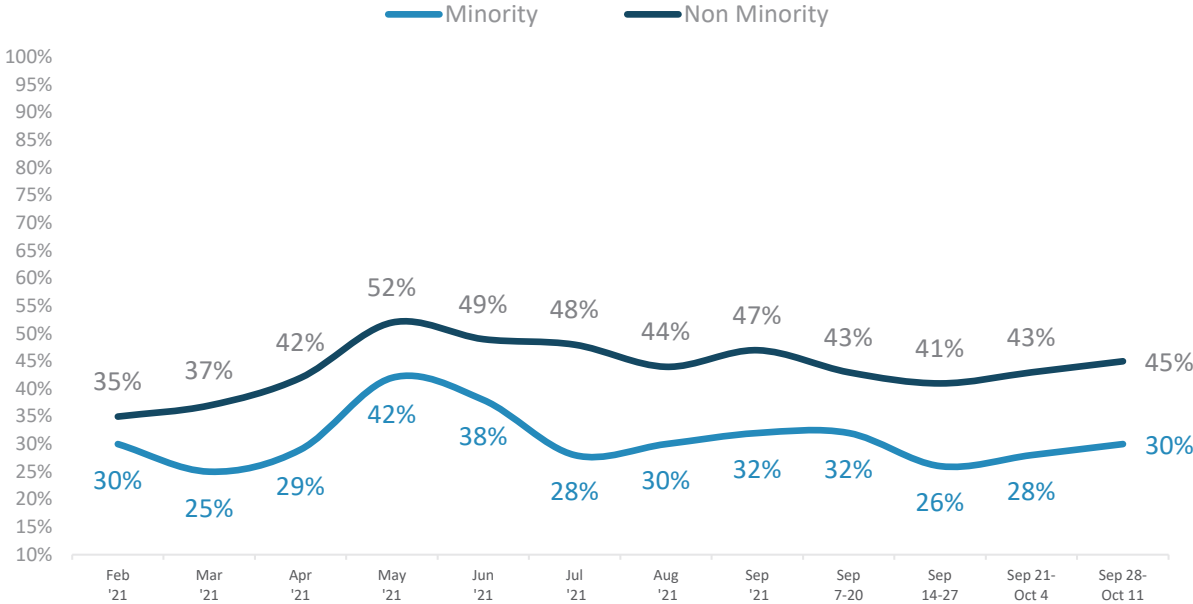

MINORITY VS NON MINORITY



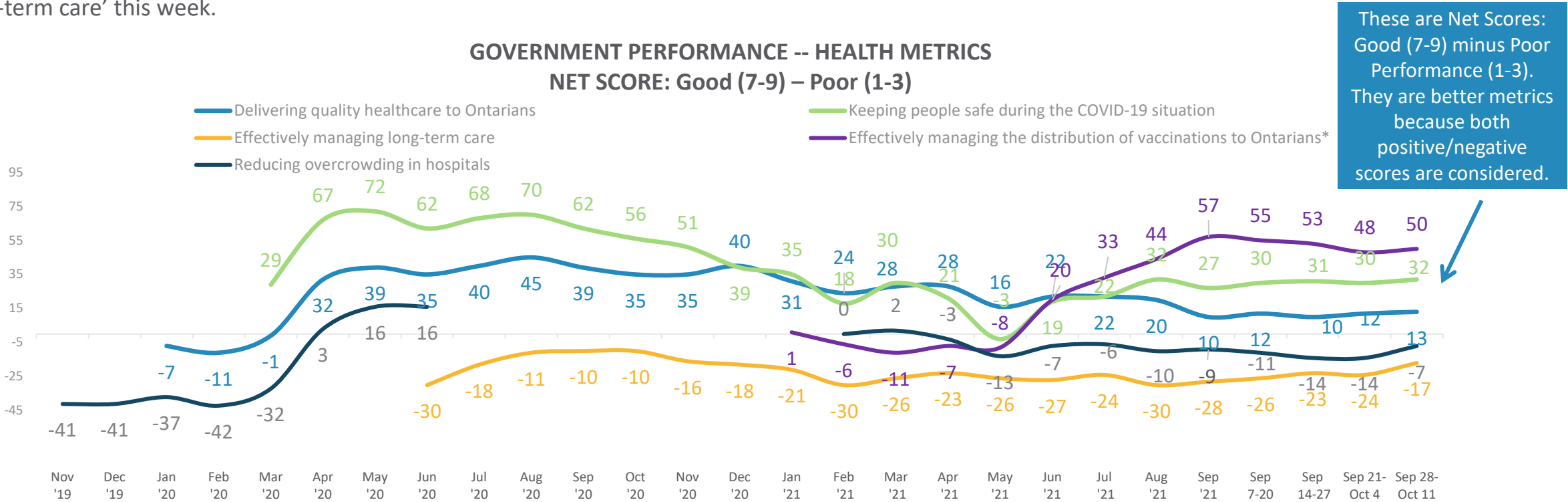

Rating of the government’s performance for ‘effectively managing vaccinations’ remained steady this week (and remains the highest rated health metric). ‘Keeping people safe during the COVID-19 situation’ and ‘delivering quality healthcare’ also remained steady.

- While remaining in negative territory, there were 7-point improvements measured for both ‘reducing overcrowding in hospitals’ and ‘effectively managing long-term care’ this week.

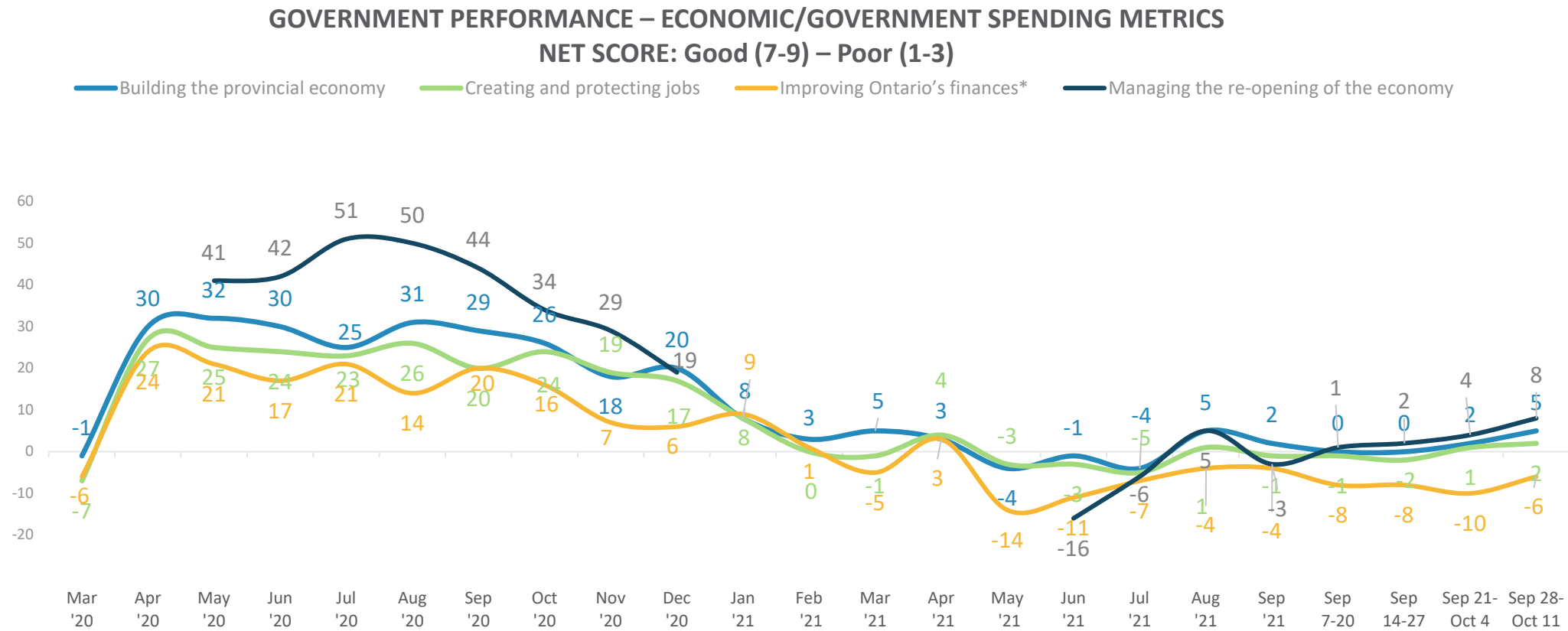

- ‘Creating and protecting jobs’ remained steady.

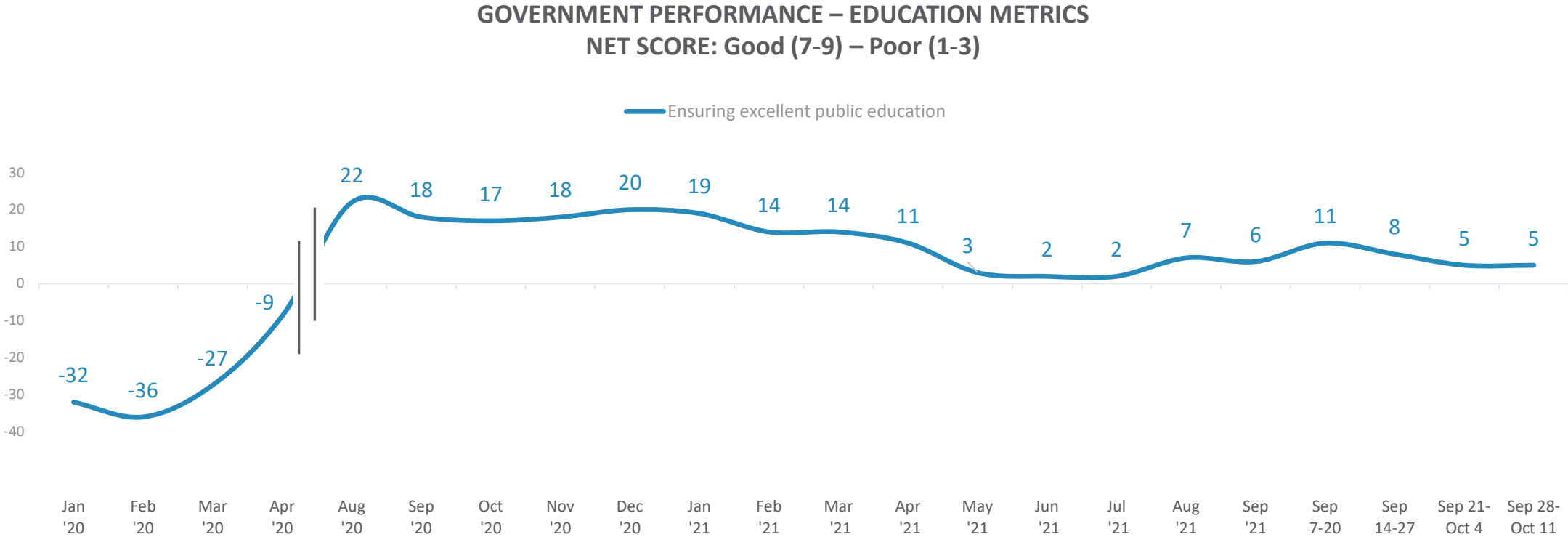

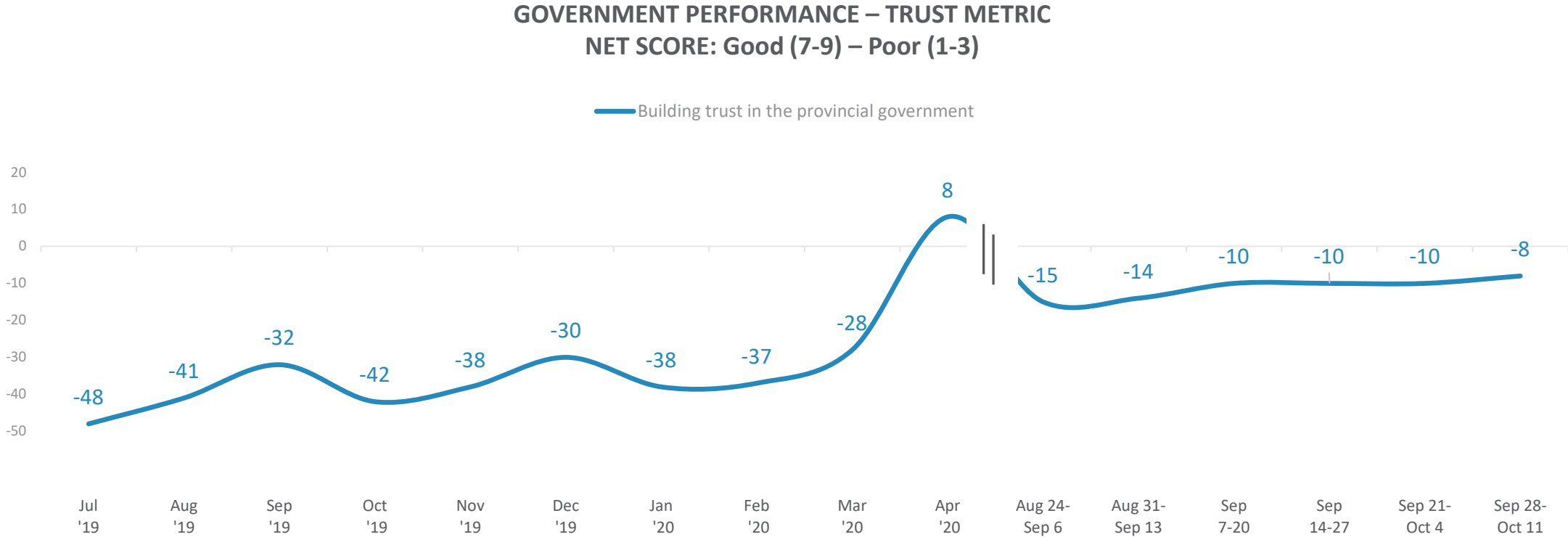

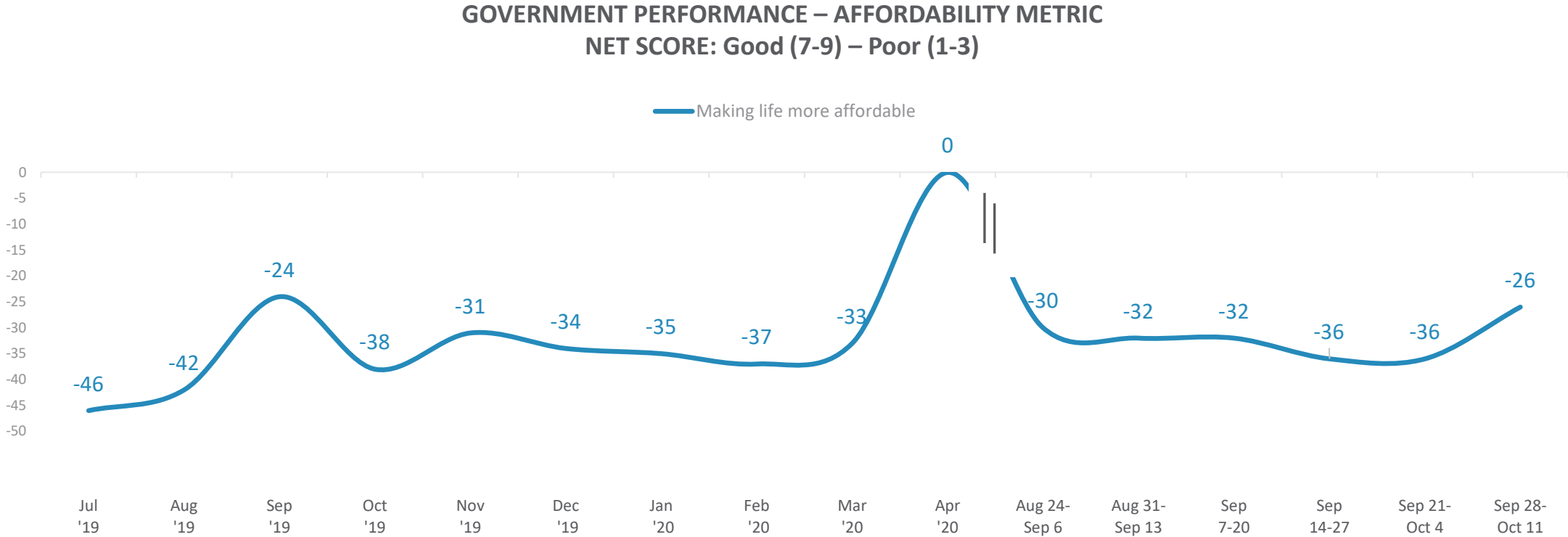

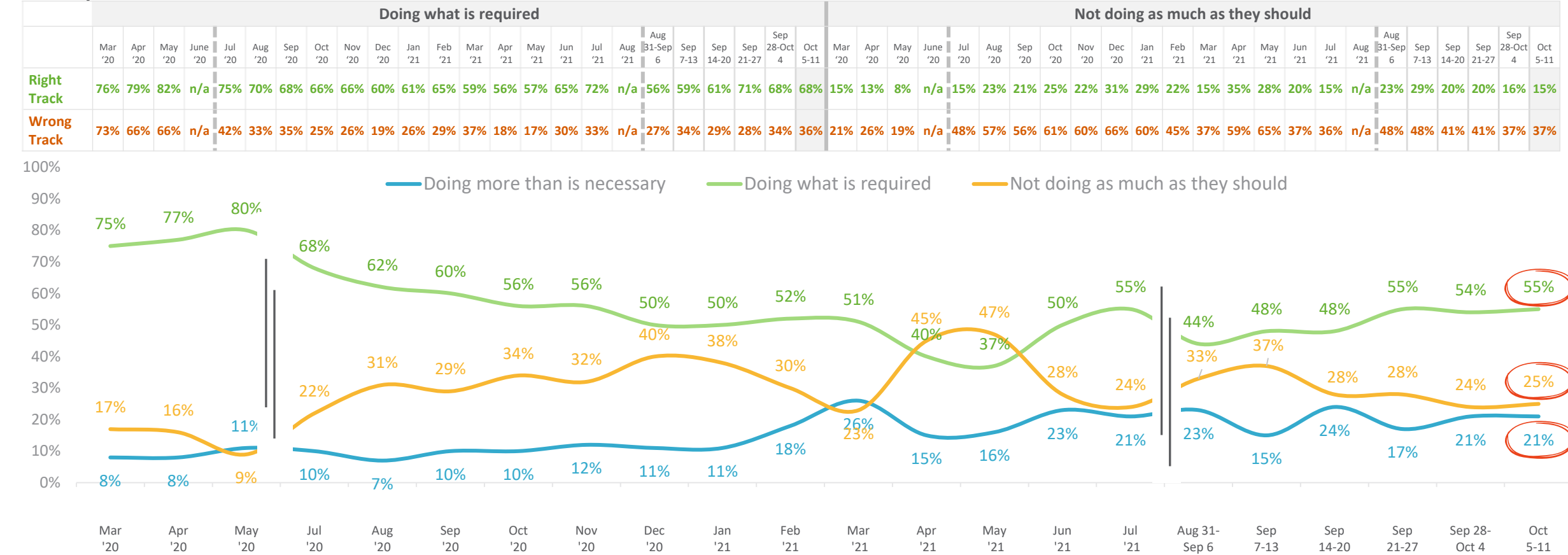

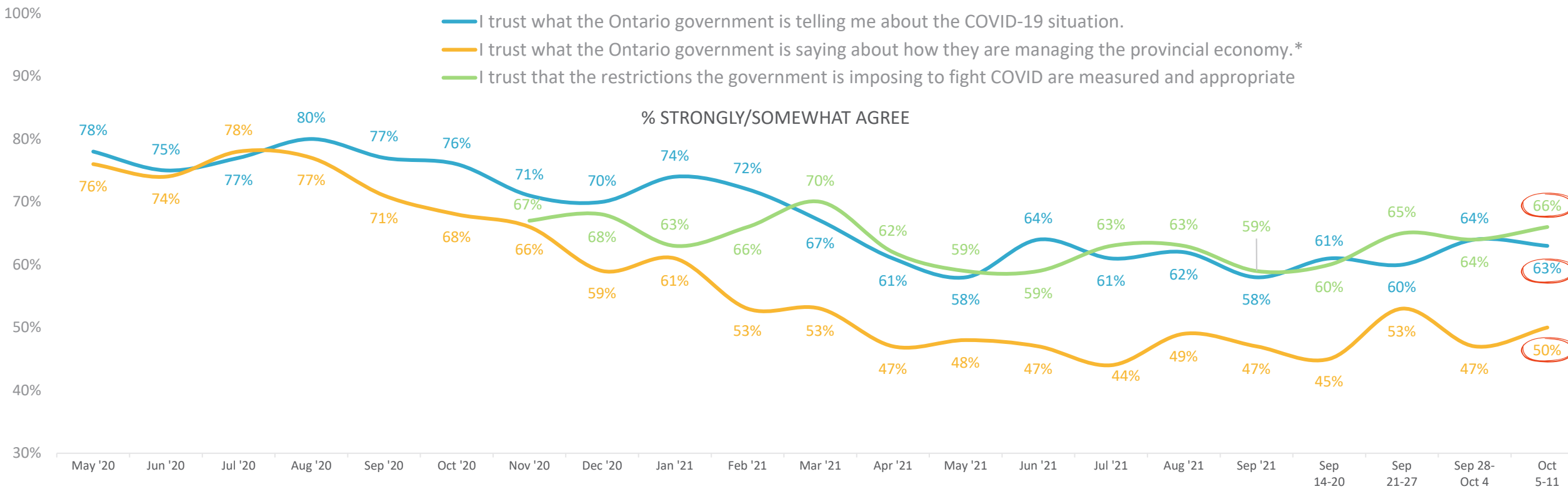

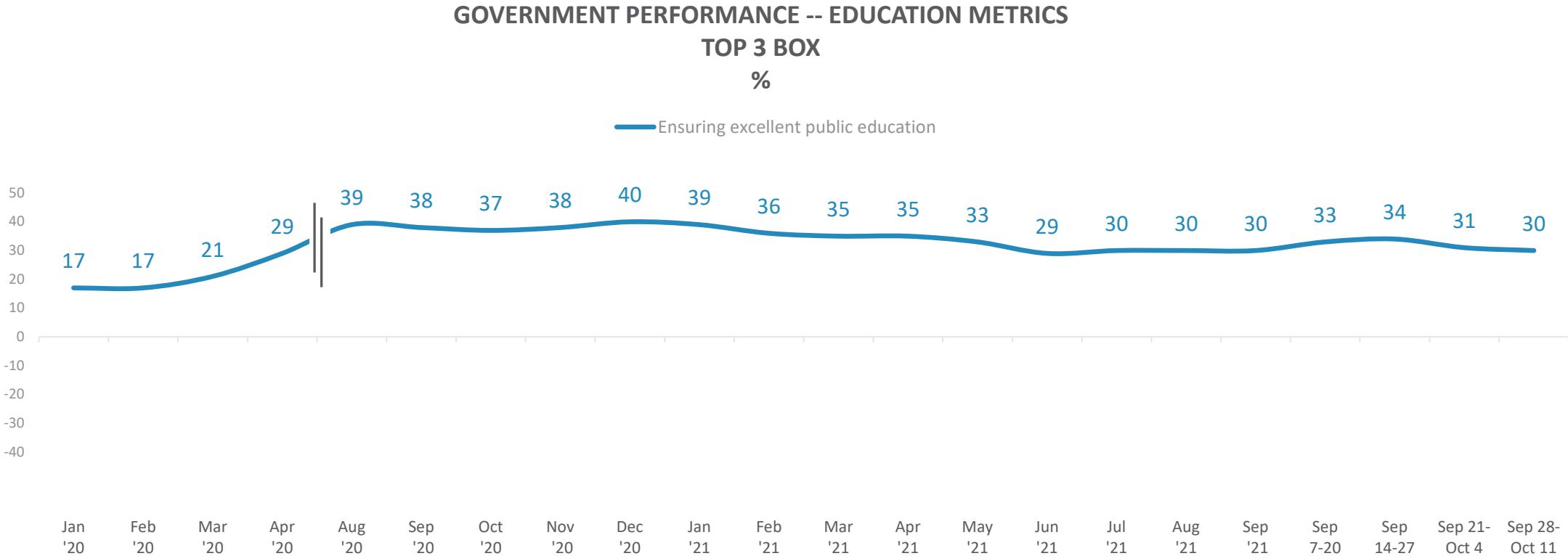

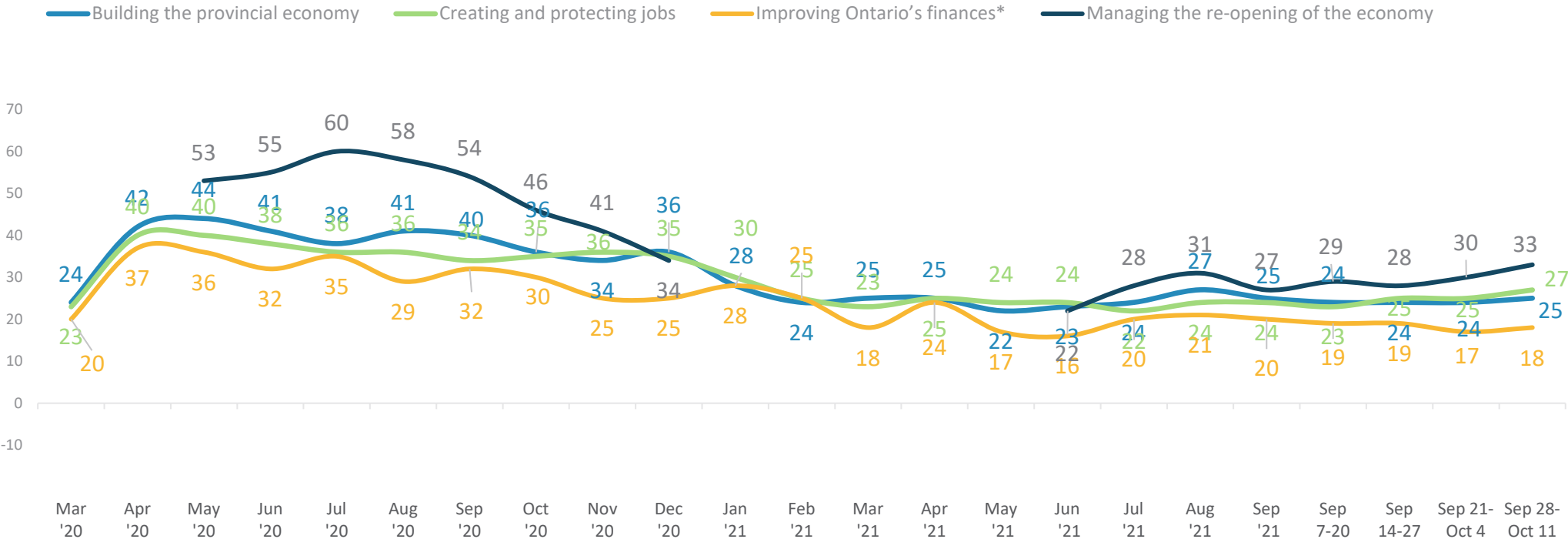

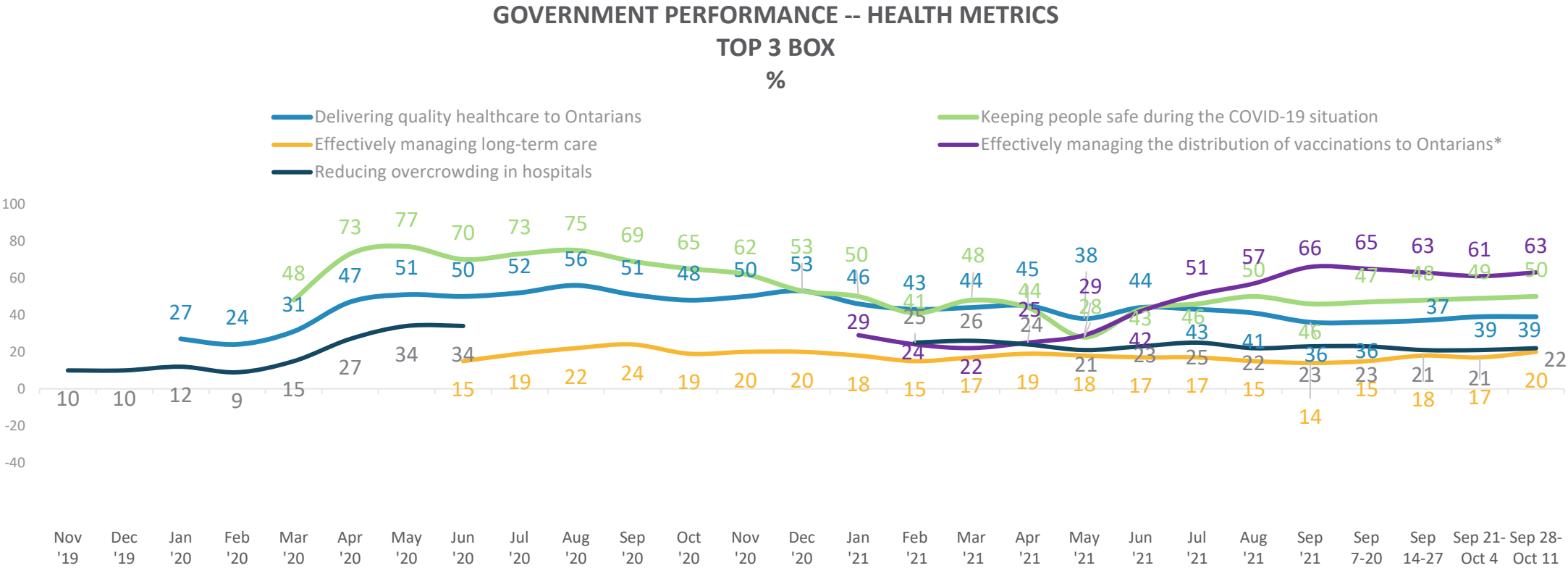

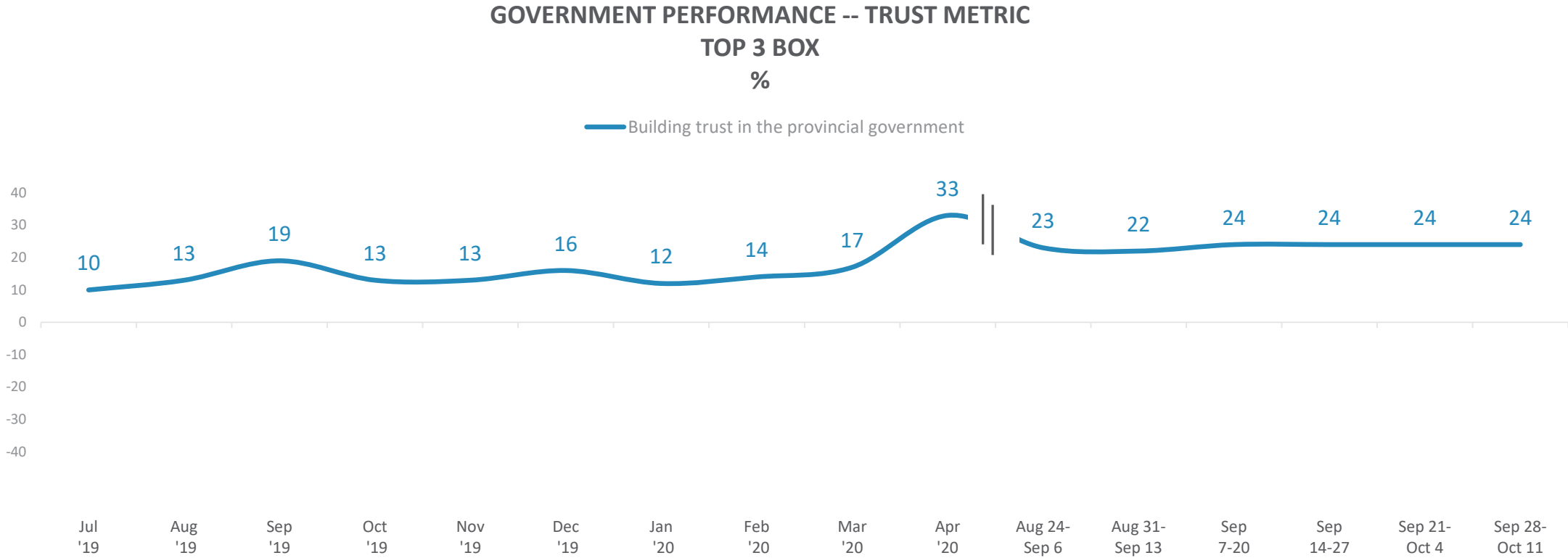

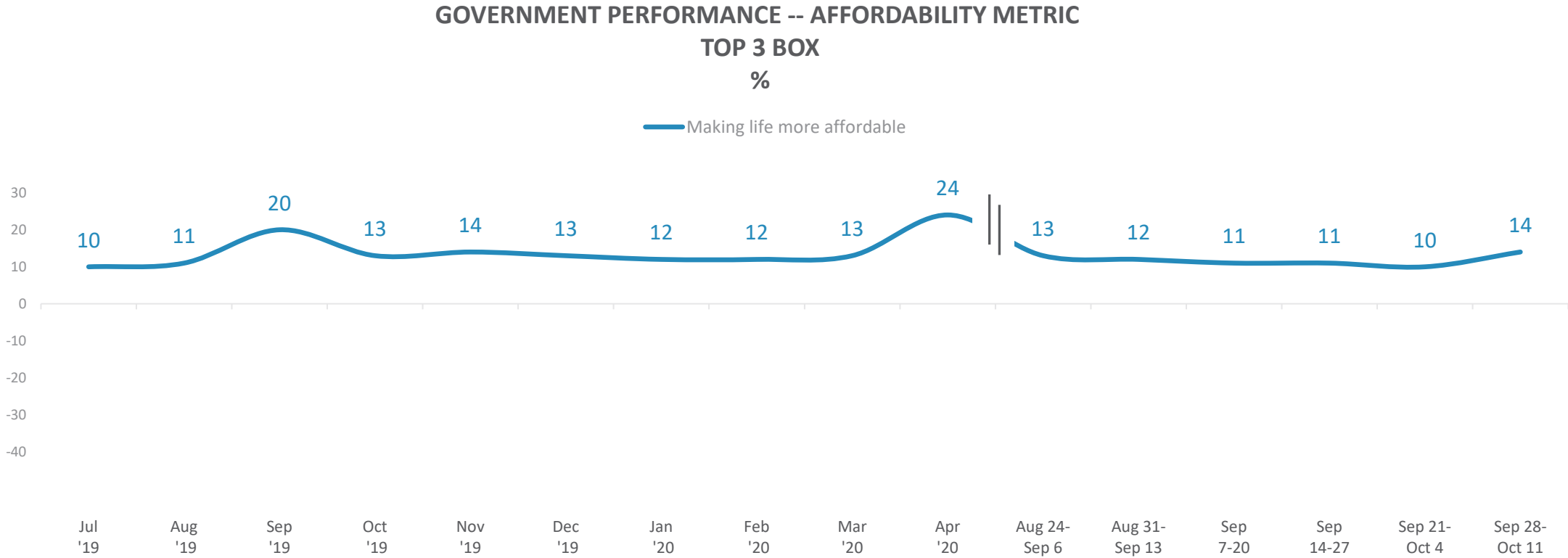
