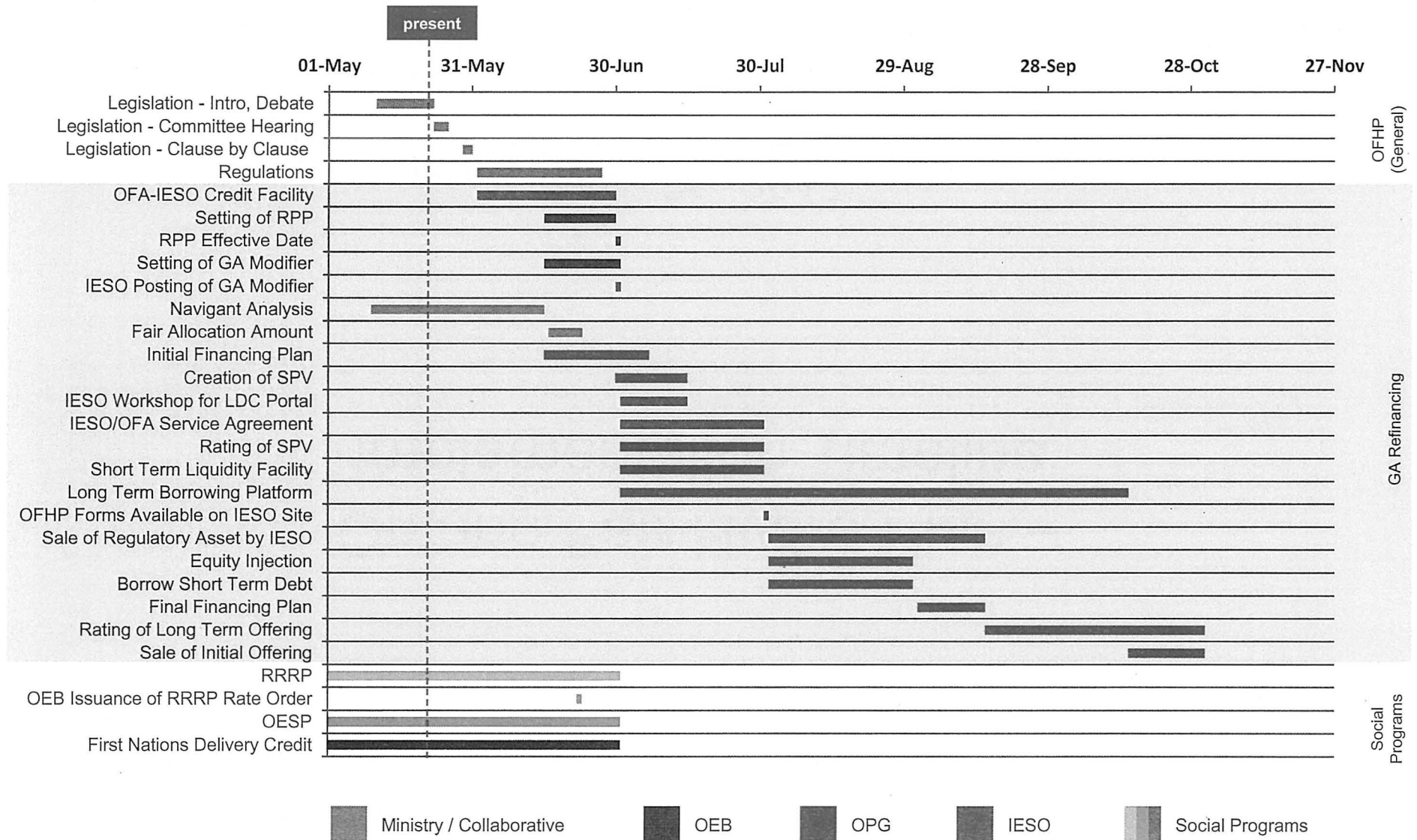

Item	Description
Finance Amount Definition	Dealers to provide final comments
Regulations Table	Table provided to Province; Province to discuss as required
Billing & Collection Process	OPG to arrange a meeting with the IESO to discuss current billing, collection and remittance process with the LDCs; waiting on IESO to confirm availability
Provincial Support Agreement	Province to call Tory's to discuss agreement and will provide markup of term sheet
Required Servicer Reporting	GS to circulate sample servicer reporting schedules
Financing Order	GS to provide list of items typically covered in financing order to ensure these are captured in legislation/regulations
