As per your request during the Secretary's briefing, here are the materials:

- ***Broad Questions Shared With the Ministry on February 9th*** .

Our outreach to the Ministry of Energy on this file began on Feb 9th . The broad questions that were posed at the time (and they continue to be relevant today) are included in the attached email.

Since then, lots of work has been done by all central agency partners and the analysis and questions have been refined. There has been continued outreach to the corporate shop at the ministry to engage them on the analysis. As of today, we are focussing our outreach on the program area directly.

- ***Issues and Questions related to Global Adjustment (GA) Smoothing:***

While the submission has a number of components, the GA smoothing is by far the most contentious/highest potential fiscal impact.
