JANUARY 2017 – Previous Insert

8% Off Electricity Bills



On January 1, 2017, your electricity costs went down 8%.

Ontario's government is reducing electricity costs by rebating an amount equal to the provincial portion of the HST on your monthly hydro bill. That's an 8% rebate for Ontario families, and on average will mean \$130 more in your pocket each year.

This is part of Ontario's plan to help people with the costs of everyday living by reducing electricity costs. Across Ontario, about five million residential consumers, farms, and small businesses will benefit from this rebate.

Energy+ Inc. will implement these savings onto your bill by July 1, 2017. Applicable savings will be retroactive to January 1, 2017.

No change to electricity prices for households and small businesses on November 1, 2016

Off-Peak	8.7 ¢ / kilowatt hour (kWh)
Mid-Peak	13.2 ¢ / kWh
On-Peak	18.0 ¢ / kWh

These are the prices that appear on the electricity line of your bill and are only for the electricity you use. They do not include other charges like delivery.

New winter (Nov 1 – Apr 30) time-of-use hours

WEEKENDS and HOLIDAYS

Households that aren't yet on time-of-use pricing will pay 10.3¢/kWh for the first 1,000 kWh of electricity they use per month and 12.1¢ for each additional kWh. Small businesses will pay 10.3¢/kWh for the first 750 kWh of electricity they use per month and 12.1¢ for each additional kWh.

If you signed an electricity contract with a company, you pay the price agreed upon in the contract, not the price set by the OEB. For more about contracts visit our website.

YOU MAY QUALIFY TO GET \$30-\$50 OFF PER MONTH ON YOUR ELECTRICITY BILL

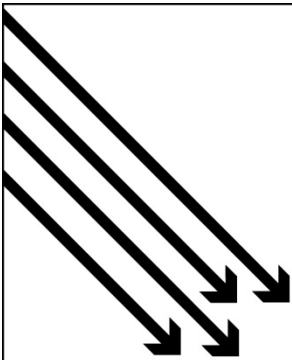

Ministry Recommended Language

Option 1: *Current public messaging including 25%*

Ontario's Fair Hydro Plan proposes new measures to lower electricity bills by 25 per cent on average for residential consumers and initiatives to reduce costs for small businesses and manufacturers. Lower-income Ontarians and those living in eligible rural communities would receive even greater reductions to their electricity bills. These measures include the eight per cent rebate introduced in January and build on previously announced initiatives to deliver broad-based rate relief on all electricity bills.

In addition any electricity rate increases over the next four years would be held to the rate of inflation.

Option 2: *wording without 25% (not all consumers will receive exactly 25% reduction on bills)*
