Attached please find the latest drafts of Energy's backgrounders for tomorrow's announcement.

- Refinancing the Global Adjustment
- Enhancing Electricity Support and Conservation Programs
- Previous Actions to Reduce Energy Costs
- Energy Sector Efficiencies

A couple outstanding questions I wanted to call your attention to:

- 1. In the 'Enhancing Electricity Support and Conservation Programs' BG, costs are broken out for each initiative for this coming fiscal year only (OESP, RRRP, Affordability Fund, FN credit). This is different from the approach we are taking in the statement/NR, where costs are presented cumulatively for all programs over a three year period. Please flag if there are any concerns with breaking out costs for individual programs in this way
 2. Per Scott's note, debt financing costs are not currently in the GA backgrounder, only total accumulated debt and GA reduction per year. Please let me know if there is a desire to add further details on costs.
