Hi Andrew/Steve. Hope all is well. Hard to believe it has been a year since we were feverishly working on the enhancements to the CPP.

I am following up on the discussion that Ed had with you about your participation in a video that we are producing at Aon on the impact of the CPP changes. In addition to the many things he does, I guess you could say Ed is also acting as my talent agent.

By way of background, our global CEO, Greg Case, has been very focused on the level of impact we can have as a firm not only for our clients and our shareholders but on the big societal challenges we face. The societal aspect is not just about how we as an organization give back to the communities we work in around the world but how what we do as a firm helps to address some of these big challenges.
