From my review of the lists, I would note the following:

- **Sept 25 LRC:** Item #28 is the agreement to transfer control of the settlement lands from the P i c Moberg First Nation to the Govt of Canada
- **Sept 25 TB/MBC:** Item #1 provides for the guarantee of undertakings of a financing entity supporting Ontario 's Fair Hydro Plan Implementation.
- **Sept 27 Main Appts:** the following are on hold from LG signature, pending Standing Committee review - #1, 19-21, 36, 43, 47, 50-52, 54-57, 68
- **Sept 27 Supp Appts:** #69-78 appoint provincial judges; #79 extends the appointment of the Archivist of Ontario
- **Sept 27 Prmr's Appts/Supps:** #1 appoint an interim Financial Accountability Officer; #4-10 extend the appointments of various current DMs.
