ENE said they were fine with the existing language, so no other changes. The revised paragraph would look like this:

As you know, as part of its preparations for the development of the implementation of the Government's Fair Hydro Act, Navigant Consulting was engaged to conduct analysis and prepare a report. The report was commissioned in June 2017 and completed at the end of September 2017. Although the report was not commissioned as a result of your audit or to respond to any questions raised by your office as part of your audit process, we believe it does contain information relevant to your audit. As per your letter which noted that we should share

any other information that may be relevant, we felt it would be appropriate to share a confidential copy of the report with your office ~~in advance of it being made public.~~

If we can direct the AG to something online (e.g., standards), a hyperlink would be fine. If no material can be provided, please ensure the box is changed to 'N'.
- Please have staff review the documents one last time and ask that they note any required changes in the clean versions.
- The key focus at this point should be the government response. At this stage, changes to the consolidated comments should be kept to a minimum.
- **Please reply-all with any edits by 11:00AM.**
- I will coordinate having the joint-DM memo signed. We'll have to work together to get it in front of each of them (separately is fine) before 12:30.
- I will aim to distribute a final package by 1:00. The target for getting it to the AG is 2:00.
