Hi Steven,

Brief update on this file and a heads up that ECO will send through an update on the more procedural elements for CAB tomorrow. You should see that shortly.

Energy has not sent over the process summary and we continue to follow up with them. They expect to send it later this evening. We have reviewed our materials and are certain the risk was not flagged when the first set of bill presentment regs went forward to Cabinet on June 14.

Leg Counsel has now been in touch to advise they will prepare a memo for Cabinet noting the regulations should be considered unsealed (i.e., they would not have sealed them had they known of this risk at the time they were sealed). We have advised PO of this development and they are looping in with both MOs to confirm how the Ministers plan to approach the discussion.

I know you are over at TB for some time – happy to speak with you afterwards at your convenience. Attached is the latest CBN for your reference.
