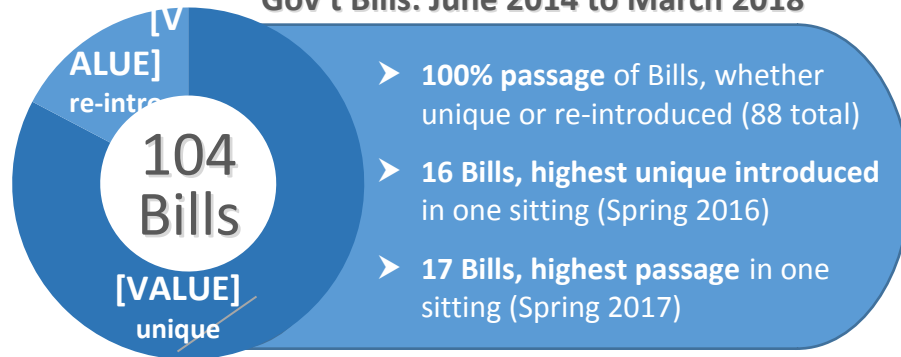


Legislative Achievements 2014 to 2018: Transforming and Delivering

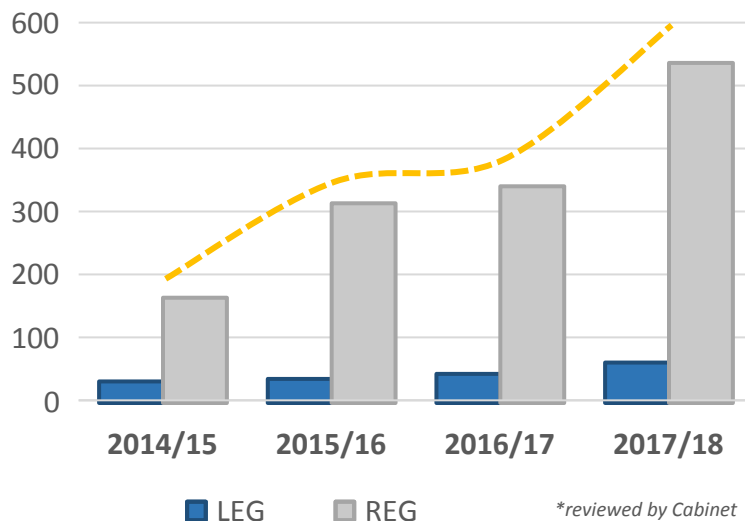
Around 75% of legislative items - many transformational - were in the areas of Fair Society, Health Transformation, and Government / Communities / Environment.

Gov't Bills: June 2014 to March 2018



- 100% passage of Bills, whether unique or re-introduced (88 total)
- 16 Bills, highest unique introduced in one sitting (Spring 2016)
- 17 Bills, highest passage in one sitting (Spring 2017)

SPEAKING POINTS:

- From 2014, the government had a large and transformational legislative agenda.
- Out of hundreds of new policy submissions, the government used the legislative or regulatory lever where it makes the most impact – ensuring fairness in society, transforming the health care system, modernizing government and communities, and protecting the environment.
- Overall, the government introduced or re-introduced 104 Bills, with an additional 4 currently in the House.
- Many of the Bills were transformational in nature, such as modernizing child care, creating a new waste framework, transforming child and youth services, and expanding the Local Health Integration Networks.
- Of course, many Bills also ventured into new areas to deliver on key government commitments, such as creating a carbon market using a cap and trade program, reducing costs of hydro, and creating a made in Ontario approach to legalization of Cannabis.
- To deliver on such a transformational legislative agenda, the government showed a clear pivot to implementation between Spring 2016 and Spring 2017 -- this period accounted for the highest volume of bills introduced and passed, as well as starting the work of implementing and delivering using regulatory levers, where necessary and appropriate.

 - Session 1 – TOTAL INTRODUCED: 57 (10 re-intro); TOTAL PASSED: 48
 - Session 2 – TOTAL INTRODUCED: 43 (5 re-intro); TOTAL PASSED: 40
 - Session 3 – TOTAL INTRODUCED: 4 so far, with 4 more possible (3 re-intro); TOTAL PASSED: none yet, expect 5-6
- Cabinet approvals by fiscal year:
 - 2014/15: LEG - 30; REG - 163
 - 2015/16: LEG - 34; REG - 313
 - 2016/17: LEG - 42; REG - 340
 - 2017/18: LEG - 60; REG - 536
 - 2018/19 (*April projection*): LEG - 2; REG – 80
- Legislation by focus area:
 - 5% -- People and Skills
 - 7% -- Infrastructure, Transit and Transportation
 - 4% -- Business Climate
 - 35% -- Fair Society
 - 12% -- Health Transformation
 - 6% -- Other 1 (pensions, assets, RoF, intergovernmental)
 - 31% -- Other 2 (environment, lands, government, communities)
