Taking Stock: Policy Decisions & Delivery



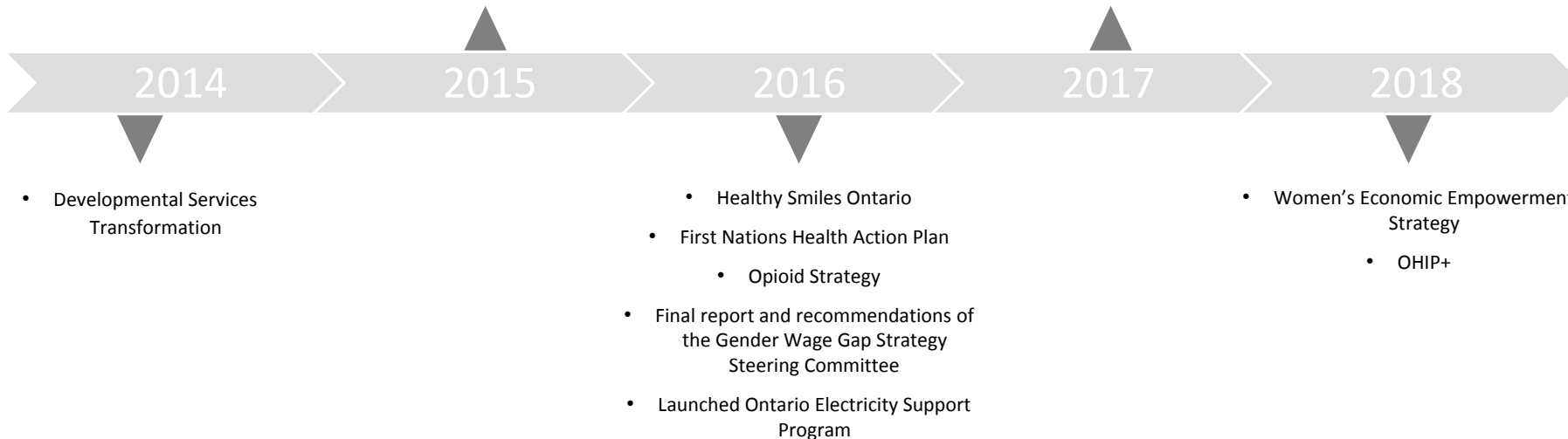
The Government made significant policy decisions throughout the 2014 to 2018 period. As policy direction was provided, the focus on implementation and delivery increased.

Communications and fiscal alignment remained a consistent focus from policy development through to delivery phases.

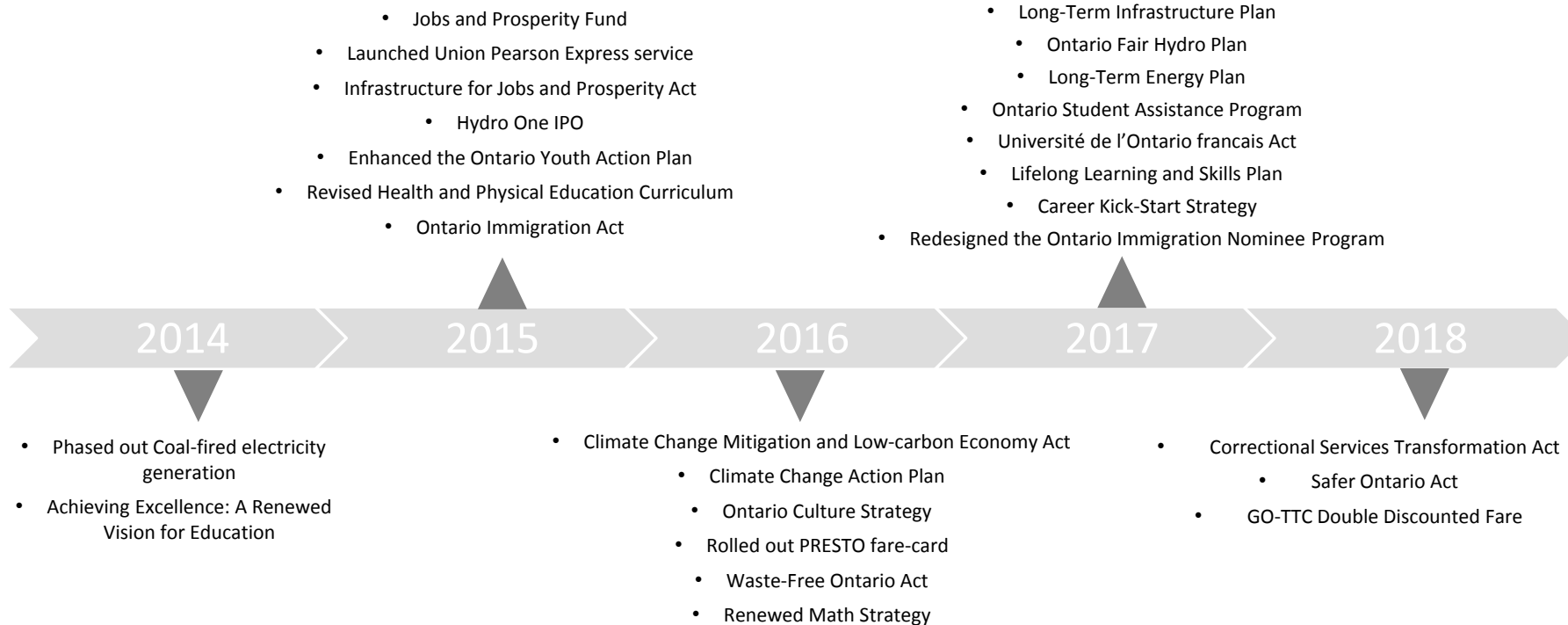

OUTCOMES

- Created 19,000 new **child care** spaces
- Improved services for **survivors of domestic violence**, including funding for Sexual Assaults and Domestic Violence Treatment Centres, access to safe beds in shelter and transitional housing supports
- Removed long-standing barriers that have kept **women** from benefitting equally from Ontario's economy
- Decreased the number of children **living in poverty** by 24% and children living in deep poverty by 37%
- Contributed to a 46% **decline in the youth crime** rate
- Addressed integration needs of **refugees, refugees claimants** and other vulnerable **newcomers**
- Improved outcomes for more than 10,000 **Black children and youth** in Ontario by eliminating systemic, race-based disparities
- Provided over 500,000 **seniors** found opportunities to volunteer, stay active and continue life-long learning
- Provided access to **high-quality primary care**, culturally-appropriate supports for indigenous individuals and communities, psychotherapy services, and life-saving harm reduction supports
- Transformed the **developmental services** sector to better support approximately 47,000 individuals
- Over 550 people have joined the **Community Hubs** Resource network, resulting in stronger planning and sharing of best practices
- Provided over 500,000 **seniors** found opportunities to volunteer, stay active and continue life-long learning
- Promoted inclusive and equitable treatment by providing **gender neutral** health cards, driver's license and birth certificates

Growing the Economy and Creating Good Jobs



OUTCOMES

BUSINESS

- **Saved businesses** over \$152M through measures to cut **red tape** and reduced small business Corporate Income Tax rate by 22%
- 36,000 private-sector jobs created and over \$7.1B in total investments attracted through **Jobs and Prosperity Fund**
- Played a key role in **negotiating** the new Canadian Free Trade Agreement.
- Global Trade Strategy (2016-17) - \$702M in **export sales** opportunities, took 790 companies to market, led 75 **trade missions**, and hosted 124 incoming **delegations**.
- **Tourism** Receipts = \$32.3B for 2016-17

CLIMATE CHANGE

- Invested **cap and trade** proceeds into numerous greenhouse gas reducing initiatives

TRANSIT AND INFRASTRUCTURE

- \$31.5B dedicated to support **public transit, transportation and priority infrastructure**
- Ontario Community Infrastructure funding has been provided to 426 municipalities.

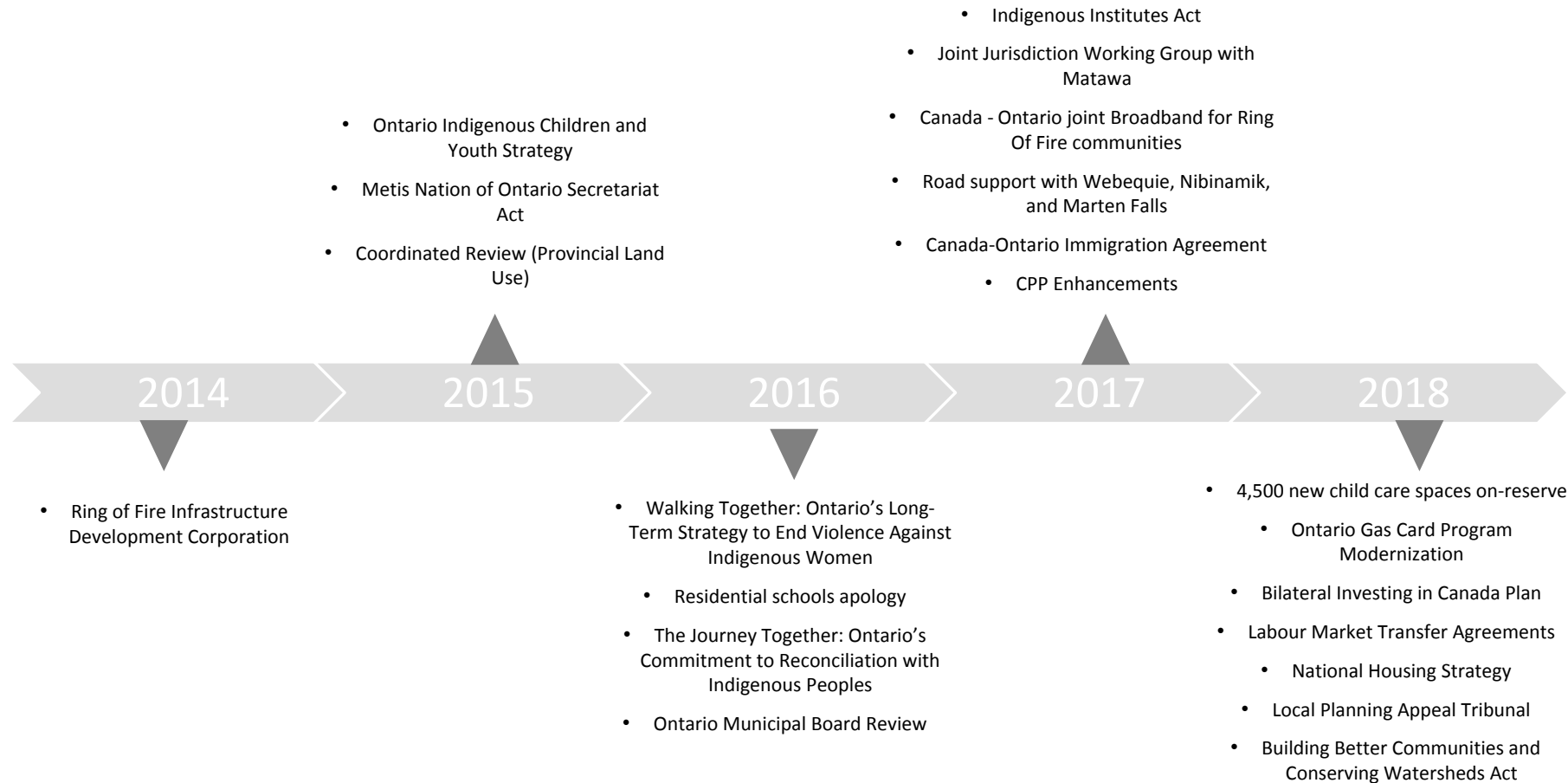
EDUCATION & EMPLOYMENT

- Through the new **OSAP**, over 225,000 students are receiving free tuition and 175,000 are receiving grants and loans
- More **adult learners** will have access to free reading, writing, math and digital skills
- Ontario's efforts for a **renewed vision for education** has allowed the province to remain an international leader
- The general **minimum wage increased** to \$14 per hour

ASSETS

- More than 350 grocery stores across Ontario can now **sell beer and cider** – including up to 70 that can sell wine
- Exceeded \$9 Billion target through broadening **Hydro One** ownership. Province retains ownership to 47.4% of Hydro One
- **Ontario's Fair Hydro Plan** reduced electricity bills for residential consumers by an average of 25%

Fairness and Opportunity through Partnerships



OUTCOMES

FEDERAL

- Expanded scope of **labour market** supports that allow Ontario to provide a broader range of employment and training
- Reached an historic agreement with the federal government on a **National Housing Strategy** –Ensured that Canadians have access to housing that meets their needs and that they can afford
- Collaboration with FPT partners to finalize the technical details of **CPP Enhancement**

INDIGENOUS

- Expanded the capacity of **Indigenous Institutes** to support more than 1,000 learners annually
- Co-developed the **Urban Indigenous Action Plan** with indigenous partners
- Helped communities and tribal councils prepare for **Ring of Fire** development

MUNICIPAL

- Supported clearer and more timely decision-making through the **Building Better Communities Act** and Local Planning Appeal Tribunal
