Please find attached the first draft agenda for the LRC meeting scheduled for April 10, 2017. This is representative of the items we currently have in MOSAIC.

As always, I would point out that these preliminary agendas are still quite fluid, so please do not indicate discussion/non-discussion items to your ministries at this point. Ministries should be preparing all their materials with an anticipation of their items being discussed.

Few quick notes:

- **Busy agenda/discussion items:** Please help me plan ahead as this is expected to be a busy meeting with lots of elements – currently 33 items under 19 tabs. In the first draft agenda, I've noted a fair amount of potential Schedule A (discussion) items; however, I do not expect this to be the case once we see more information about proposals.
- **Drafts (past due):** ADM drafts were due to CO on March 14th. Unless you've already done so, please forward them to me and the LRC team. Unless previously discussed/identified, items that do not have drafts should be removed/rescheduled in MOSAIC to support version 2 of the agenda.
- **Finals :** Minister signed materials are due by March 30th. As you know, this does not mean

ministries need to wait until the deadline, as we at ECO are very happy to receive finals any time before then. If there are any issues meeting timelines, it will be very important to get in touch with me as this is expected to be a complex meeting.

- ***NEW* Titles & Descriptions:** You will notice that the LRC team has started to use titles and descriptions in the draft agendas. This will align with the way items are viewed in BinderBrowser, and also supports consistency of naming in the Planning Calendar, LRC briefing notes, and Cabinet agendas. As always, your feedback is welcome during the draft stage for both the titles and descriptions.
